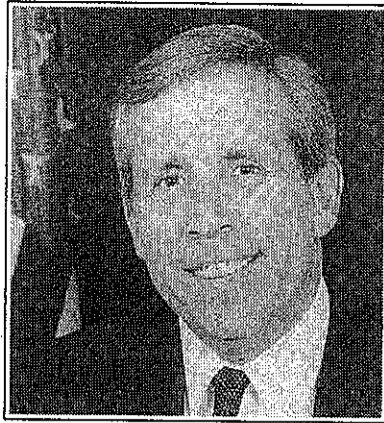

Congressman Wolf's Voting Record

2nd SESSION, 102nd CONGRESS • JANUARY 28 - OCTOBER 9, 1992

Dear Friends:

This report includes the votes I cast for the 2nd Session of the 102nd Congress, continuing my practice of making my complete voting record available to the people of the 10th District of Virginia. While very few members of Congress publish comprehensive voting records, I have provided my voting record to the 10th District citizens each year since I began serving in the House of Representatives in 1981 because I believe it is important for you to know how I have voted on all matters coming before Congress.

There were 488 roll call votes during the 2nd Session of the 102nd Congress which convened on January 28 and officially adjourned on October 9, 1992. Of those 488 roll calls, I missed only six votes, for a voting attendance record of 99 percent. The 488 roll calls included 47 procedural votes such as approving the Speaker's journal, quorum calls and motions to adjourn. Those procedural votes are not included in this report. To assist you in understanding the terminology used in the legislative process, a glossary of terms used in this report to describe the votes may be found on page 2.

This report is arranged by general subject areas as follows: each vote begins with the roll call number in parentheses, fol-

lowed by the number of the bill or resolution being considered and a short description of the question on which the vote was taken, including amendments, motions and passage. Next my own vote on the measure is listed by a "yes" or "no." The vote of the entire House is next indicated by either "passed" or "failed" with the vote total, followed by the date on which the vote occurred. Votes taken under suspension of the rules are so indicated and an explanation of that procedure may be found in the glossary.

I hope you find this voting record information helpful. As the 103rd Congress begins its work, I encourage you to share your comments on this report and to let me know your views on the important and challenging issues facing our district and the nation and other matters of interest to you.

AGRICULTURAL & RURAL AFFAIRS

(243) H.R. 5487, agriculture appropriations for FY 1993. Amendment to cut \$57.7 million for special research grants by the Cooperative State Research Service which administers funds to state agricultural experiment stations to conduct agricultural research. No. Failed 126-295. 6/30/92.

(244) H.R. 5487. Amendment to cut \$46.4 million from watershed and flood prevention operations and provide funding for the Wetlands Reserve Program. No. Failed 109-308. 6/30/92.

(245) H.R. 5487. Amendment to add \$23.25 million for the Water Quality Incentive Program. No. Failed 18-396. 6/30/92.

(246) H.R. 5487. Amendment to reduce the \$343.1 million in funding for Title I of PL 480, the Food for Peace program, by \$25 million. Yes. Passed 410-4. 6/30/92.

(247) H.R. 5487. Amendment to reduce the amount the president can forgive for debt restructuring under the Enterprise for the Americas initiative from \$69.5 million to \$34.5 million. No. Failed 78-333. 6/30/92.

(248) H.R. 5487. Amendment to cut overhead spending for all agencies in the bill except the Food and Drug Administration by 10 percent. No. Passed 214-191. 6/30/92.

(249) H.R. 5487. Amendment, on demand for a separate vote in the House, to prohibit funds for the Market Promotion Program from going to promote tobacco sales abroad. [Note: in FY 1992, \$3.5

(250) H.R. 5487. On passage of the bill to provide \$59 billion in FY 1993 for the Department of Agriculture, rural development and related agencies. No. Passed 312-99. 6/30/92.

(368) H.R. 5237, Rural Electrification Administration (REA) Improvement Act to increase the flexibility of rural electric cooperatives to sell or prepay certain loans and improve electric and telephone service in rural areas. Yes. Passed 359-60, under suspension of rules. 8/5/92.

(379) H.R. 5487, to adopt the conference report to provide \$60.5 billion in FY 1993 for the Department of Agriculture, rural development and related agencies. No. Passed 299-100. 8/11/92.

(206) H.R. 5132, to approve the conference report providing \$1 billion in emergency disaster aid to Los Angeles and Chicago and other urban areas, including \$500 million for a summer youth jobs program, \$169.7 million to the Small Business Administration to subsidize about \$500 million in loans for businesses in Los Angeles, and \$300 million for Federal Emergency Management Agency disaster payments, mostly to businesses damaged by flooding in Chicago. (24) **H.Res. 374**, to adopt the rule to consider H.R. 4210, bill to provide economic growth and tax relief. **No.** Passed 244-178. 2/26/92.

(25) **H.R. 4210**, bill to provide economic growth incentives and tax relief. Amendment as a substitute providing individual income tax and business-related income tax changes as proposed by the President and modified and introduced by Rep. Gephardt, majority leader. **No.** Failed 1-427. 2/26/92.

(28) **H.R. 4210**, to provide economic growth incentives and tax relief. Amendment as a substitute to implement a seven-point plan that includes a cut in the capital gains tax rate, a \$5,000 two-year tax credit and penalty-free withdrawals from Individual Retirement Accounts for first-time homebuyers, passive loss deductions for real estate developers, an increase in the rate of depreciation for business equipment and new rules encouraging real estate investment by pension funds. **Yes.** Failed 166-264. 2/27/92.

On passage of the bill to give workers a temporary tax credit worth up to \$400 for couples and \$200 for individuals a year to be paid with a 10 percent surtax on millionaires and a new top income tax rate of 35 percent on individuals with taxable income higher than \$85,000 and couples about \$145,000; indexing of capital gains, passive loss deductions for real estate developers, permanent extension of certain tax breaks, and penalty-free withdrawals from Individual Retirement Accounts for first homes and medical and educational expenses. **No.** Passed 221-209. 2/27/92.

Amendment (Dannemeyer) as a substitute to provide \$1.5 trillion in budget authority and \$1.4 trillion in outlays for FY 1993 with a deficit level of \$334.3 billion; hold domestic discretionary spending for FY 1993 at FY 1992 levels; cut Medicare and Medicaid entitlement programs by \$138.4 billion over five years; cut international affairs programs by 25 percent; and reduce the interest cost on the national debt by issuing low-interest securities. **No.** Failed 60-344. 3/4/92.

Amendment (Gradison) as a substitute incorporating the President's FY 1993 budget including a short-term economic stimulus package, a defense cut of \$7.9 billion in FY 1993; a \$32.2 billion cut in entitlement spending over five years, and a \$3.6 billion reduction in revenues in FY 1993, with a deficit level of \$392.6 billion. **No.** Failed 42-370. 3/4/92.

(40) **H.Con.Res. 287**. Amendment (Towns & Dellums) as a substitute to reduce by half annual military spending within four years, shifting the savings to domestic programs and provide a tax cut for middle-income taxpayers by increasing taxes on the wealthy and corporations. **No.** Failed 77-342. 3/5/92.

(41) **H.Con.Res. 287**. On adoption of sections one, two, and four of the budget resolution (Plan "A") to set budget levels for FY 1993; allow for the possibility that a separate bill would be enacted to modify the 1990 Budget Enforcement Act to remove the prohibition on shifting money from defense to domestic programs; double the president's recommended defense cuts, splitting the proceeds between deficit reduction and domestic spending in a ratio of 25 to 75; and set budget authority at \$1.525 trillion; outlays, \$1.505 trillion; revenues, \$1.173 trillion; deficit, \$331 billion. **No.** Passed 215-201. 3/5/92.

(42) **H.Con.Res. 287**. On adoption of section three of the budget resolution (Plan "B") to set budget levels for FY 1993; provide for the possibility that a separate bill will not be enacted to remove the prohibition in budget law on shifting money

from defense to domestic programs; double the president's recommended defense cuts with the savings going to deficit reduction; and set budget authority, \$1.513 trillion; outlays, \$1.498 trillion; revenues, \$1.173 trillion; deficit \$325 billion. **No.** Passed 224-191. 3/5/92.

(49) **H.R. 4210**, 1992 tax bill. Motion to table the motion to instruct House conferees on the 1992 tax bill to insist that the House provisions to create a new top income tax rate of 35 percent and the Senate provisions to create a new top income rate of 36 percent be dropped from the bill. **No.** Failed 0-409. 3/18/92.

(50) **H.R. 4210**. Substitute to the motion to instruct House conferees on the tax bill to change the instructions to ones that would instruct the House conferees to insist on provisions that would provide significant middle-class tax relief, rather than instructions to not agree to the House provisions to

create a new top income tax rate of 35 percent and the Senate provisions to create a new top income rate of 36 percent. **No.** Passed 206-200. 3/18/92.

(53) **H.Res. 402**, rule to consider the conference report to H.R. 4210, 1992 tax bill for middle-income tax relief and economic growth incentives. **No.** Passed 244-151. 3/20/92.

(54) **H.R. 4210**, to approve the conference report on the bill to amend the Internal Revenue Code of 1986 to provide incentives for increased economic growth through a permanent increase in the top income tax rate from 31 to 36 percent, a Social Security-based tax credit of up to \$150 for singles and \$300 for married couples filing jointly in 1992 and 1993, and beginning in 1994, a permanent \$300 per child tax credit to be phased out as income rises above \$47,500, and other provisions. **No.** Passed 211-189. 3/20/92.

(55) **H.R. 4210**, to approve, over the veto of the

president, the bill to amend the Internal Revenue Code of 1986 to provide incentives for increased economic growth through a permanent increase in the top income tax rate from 31 to 36 percent, a Social Security-based tax credit of up to \$150 for singles and \$300 for married couples filing jointly in 1992 and 1993, and beginning in 1994, a permanent \$300 per child tax credit to be phased out as income rises above \$47,500, and other provisions. **No.** Failed 211-215. 3/25/92.

(64) **H.Res. 410**, rule to provide for further consideration of H.R. 3732, Budget Process Reform Act of 1991. Motion to order the previous question on the rule. **No.** Passed 242-177. 3/31/92.

(65) **H.R. 3732**, Budget Process Reform Act of 1991. Motion to recommit the bill to a House Select Committee on Reform to be composed of 10 House members appointed by the Speaker, five from the majority and five from the minority, with instructions to report the bill back with appropriate amendments to fully effect reform of the budget process with changes to further reduce government spending and the deficit. **Yes.** Failed 162-262. 3/31/92.

(66) **H.R. 3732**. On passage of the bill to amend the Budget Enforcement Act to break down the so-called "firewalls" that prevent shifting funds between the defense, international, and domestic discretionary spending categories to facilitate using defense savings, which would otherwise be used for deficit reduction, for expanded domestic spending. **No.** Failed 187-238. 3/31/92.

(107) **H.Con.Res. 287**, FY 1993 budget resolution. Motion to instruct the House conferees to include Senate provisions relating to the adoption of a joint resolution proposing an amendment to the Constitution for a federal balanced budget. **Yes.** Passed 322-66. 5/6/92.

(109) **H.Res. 447**, rule to consider H.R. 4990, to rescind certain FY 1992 budget authority. Motion to table (kill) the appeal of the ruling of the chair rejecting a point of order against the rule. **No.** Passed 253-161. 5/7/92.

(110) **H.Res. 447**. Motion to order the previous question on the rule. **No.** Passed 257-160. 5/7/92.

(111) **H.Res. 447**, to adopt the rule to consider H.R. 4990, to rescind certain FY 1992 budget authority. **No.** Passed 240-178. 5/7/92.

(112) **H.R. 4990**, to rescind certain FY 1992 budget authority. Amendment to substitute \$5.66 billion of the president's rescissions for the rescissions recommended by the House Appropriations Committee. [The president would rescind funding for both a second and third Seawolf nuclear submarine, a total of nearly \$3 billion, while the committee's bill would rescind funding only for a third submarine, a total of \$1.9 billion.] **Yes.** Failed 150-266. 5/7/92.

(113) **H.R. 4990**. On passage of the bill to rescind \$5.8 billion in previously approved budget authority for FY 1992, including \$4.9 billion in defense, \$733.9 million in domestic programs, and \$123.8 million in foreign aid. **Yes.** Passed 412-2. 5/7/92.

(136) **H.Res. 462**, rule to consider the conference report to H.R. 4990, to rescind certain budget authority for FY 1992. **No.** Passed 267-142. 5/21/92.

(137) **H.R. 4990**, to agree to the conference report on the bill to rescind \$8.2 billion in previously appropriated budget authority for FY 1992, including \$7.2 billion in defense programs [including \$500 million for the B-2 bomber, \$200 million for the Strategic Defense Initiative, and terminate the third but not the second Seawolf nuclear submarine], \$761 million in domestic programs and \$164 million in foreign aid. **Yes.** Passed 404-11. 5/21/92.

(138) **H.Res. 463**, rule to consider the conference report to H.Con.Res. 287, budget resolution for FY 1993. **No.** Passed 253-160. 5/21/92.

(139) **H.Con.Res. 287**, to agree to the conference report on the resolution setting budget levels for FY 1993 at budget authority, \$1.516 trillion; outlays, \$1.500 trillion; revenues, \$1.173 trillion; deficit, \$327 billion. **No.** Passed 209-207. 5/21/92.

(174) **H.R. 5333**, to require the president to submit and the House and Senate Budget committees to report a FY 1994 budget that will provide for a balanced budget by FY 1998. **No.** Failed 199-220, under suspension of rules. 6/9/92.

(181) **H.Res. 450**, rule to consider H.J.Res. 290, to propose a constitutional amendment to mandate a balanced federal budget. **Yes.** Passed 326-91. 6/10/92.

(183) **H.J. Res. 290**, balanced budget amendment. Amendment (Kyl) as a substitute to prohibit total outlays from exceeding total revenues for each fiscal year and prohibit total outlays from exceeding 19 percent of the gross national product for

GLOSSARY OF TERMS USED IN VOTING RECORD REPORT

AMENDMENT—A proposal of a member of Congress to alter the language, provisions or stipulations in a bill or in another amendment. It is usually printed, debated and voted upon in the same way as a bill.

APPROPRIATIONS—Legislation which provides the actual funds approved by authorization bills, but not necessarily the full amount authorized. There are 13 regular appropriations bills which must be approved on an annual basis effective for the fiscal year which begins on Oct. 1 (Also see Continuing Resolution.)

AUTHORIZATION—Basic, substantive legislation that establishes or continues (reauthorizes) the legal operation of a federal program or agency, either indefinitely or for a specific period, or which sanctions a particular type of obligation or expenditure.

BILL—A legislative proposal, designated as H.R. in the House of Representatives and S. in the Senate, followed by a number assigned in the order in which it is introduced during the two-year period in which a Congress is convened. If approved by both houses of Congress in the same form and signed by the President, a bill becomes a law.

COMMITTEE OF THE WHOLE—A procedural device designed to expedite the legislative work of the House in which slightly less formal rules for conduct of debate and voting on amendments apply.

CONCURRENT RESOLUTION—A resolution, designated as House Concurrent Resolution (H.Con.Res.) or Senate Concurrent Resolution (S.Con.Res.), often used to express the "sense of Congress" on various domestic or foreign policy issues. Concurrent resolutions do not require or are not intended for approval by the President and therefore do not have the force of law.

CONFERENCE—A meeting between the representatives of the House and Senate to reconcile differences between the two houses over provisions of a bill or joint resolution passed by both chambers. A majority of the members of the conference from each chamber must agree on the provisions of a measure before it can be considered by either chamber in the form of a "conference report." Conference reports cannot be amended and if not approved, the legislation may go back to conference or a new conference must be convened. Legislation passed by both houses with only minor differences need not be sent to conference; either chamber may "concur" in the other's amendments, completing action on the legislation.

CONTINUING RESOLUTION—A joint resolution which continues in effect appropriations legislation for specific ongoing activities of federal departments or agencies when a fiscal year begins and Congress has not yet enacted all of the 13 regular appropriations bills for that fiscal year.

HOUSE—The House of Representatives, as distinct from the Senate, although each body is a "house" of Congress.

JOINT RESOLUTION—A resolution designated House Joint Resolution (H.J.Res.) or Senate Joint Resolution (S.J.Res.), followed by a number assigned in the order in which it is introduced during the two-year period in which a Congress is convened. If approved by both houses in the same form and signed by the President, it becomes a law just as a bill does. A joint resolution is generally limited to special circumstances and is also used to propose amendments to the Constitution. Under that purpose, it does not require a presidential signature and becomes part of the Constitution when three-fourths of the states ratify or approve it.

PREVIOUS QUESTION—A request for the previous question, or a motion to order the previous question in the House brings to a vote the question of whether debate and the possibility of amending the question should end and the merits of the pending issue should be voted upon. For example, the previous question is voted upon during consideration of a rule, which sets the time limits for debate and allows certain amendments to be considered on a bill. If a member wanted an additional amendment to be considered which was not made in order by the rule, he or she could work to defeat the previous question and if successful the rule could be amended to include the member's request. If the motion to order the previous question is approved, debate on the issue and the possibility of amendment end.

RESOLUTION—A simple resolution, designated House Resolution (H.Res.) or Senate Resolution (S.Res.), deals with matters entirely within the prerogatives of one house or the other. It requires neither passage by the other chamber nor approval by the President, does not have the force of law and is commonly used for internal business of that house or for expressing views of that house.

RULE—A resolution from the House Rules Committee which, if adopted by the House, sets the procedures and time limits for debate and voting on a pending bill or resolution. A rule can be open, which would allow any member to offer an amendment to the pending legislation; modified closed, which would allow only certain amendments approved by the Rules Committee to be offered; or closed, which would not allow any amendments to be offered.

SUSPENSION OF RULES—A procedure used in the House intended to speed the consideration of non-controversial legislation. Under suspension of rules, debate is limited to 40 minutes, no amendments from the floor are permitted, and a two-thirds vote of those members voting is required for passage.

each fiscal year, unless a three-fifths majority in each chamber votes to permit a deficit; grant the president line-item veto authority for all spending measures; provide that spending constraints would take effect the third fiscal year after ratification but not before FY 1996 and the line-item veto would take effect upon ratification. **Yes.** Failed 170-258. 6/11/92.

(184) **H.J.Res. 290.** Amendment (Barton) as a substitute to require the president to submit and Congress to approve a budget in which outlays do not exceed revenues unless a three-fifths majority in each chamber approves a specified deficit; to require that estimated revenues do not grow faster than the rate of increase in national income in the second prior fiscal year, unless a three-fifths majority in each chamber approves a tax increase; and provide that the amount of federal public debt on the first day of the second fiscal year beginning after ratification shall become a permanent debt limit unless a three-fifths majority in each chamber passes a bill approving an increase; provide that the amendment will take effect in FY 1998 or in the second year after ratification, whichever is later. **Yes.** Failed 200-227. 6/11/92.

(185) **H.J.Res. 290.** Amendment (Gephardt) as a substitute to require the president to submit and Congress to adopt a balanced budget in the first year after ratification unless there is a declaration of a national emergency by the president that is approved by a majority vote of both chambers of Congress; prohibit Congress from approving higher expenditures than recommended by the president in a fiscal year; and exempt Social Security from deficit calculations. **No.** Failed 103-327. 6/11/92.

(186) **H.J.Res. 290.** Amendment (Stenholm) as a substitute to prohibit deficit spending unless a three-fifths majority of both chambers of Congress approve a specific deficit amount or there is a declaration of war or a declaration of national military emergency enacted into law; require the president to submit a balanced budget each fiscal year; and require a three-fifths majority of both chambers of Congress to increase the public debt; provide that the amendment would take effect in FY 1998 or the second year after ratification, whichever is later. **Yes.** Passed 279-153. 6/11/92.
