The Committee on the Judiciary had referred to it 1,409 bills and resolutions during the 98th Congress. This represents 22% of the 6,442 bills and resolutions introduced in the U.S. House of Representatives for that Congress. Of this number, 978 were public bills and resolutions, and 431 were private bills and resolutions. A total of 53 which received consideration by the Committee were enacted into public law; and a total of 3 measures considered by the Committee were enacted into private law.
