1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Fiscal Responsibility
5 and Retirement Security Act of 2011”.

6 **SEC. 2. REPEAL OF CLASS PROGRAM.**

7 (a) **REPEAL.**—Title XXXII of the Public Health
8 Service Act (42 U.S.C. 3001 et seq.; relating to the
9 CLASS program) is repealed.

10 (b) **CONFORMING CHANGES.**—

11 (1) Title VIII of the Patient Protection and Af-
12 fordable Care Act (Public Law 111–148; 124 Stat.
13 119, 846–847) is repealed.

14 (2) Section 1902(a) of the Social Security Act
15 (42 U.S.C. 1396a(a)) is amended—

16 (A) by striking paragraphs (81) and (82);

17 (B) in paragraph (80), by inserting “and”
18 at the end; and

19 (C) by redesignating paragraph (83) as
20 paragraph (81).

21 (3) Paragraphs (2) and (3) of section 6021(d)
22 of the Deficit Reduction Act of 2005 (42 U.S.C.
23 1396p note) are amended to read as such para-
24 graphs were in effect on the day before the date of
25 the enactment of section 8002(d) of the Patient Pro-

19 through 2015.”.
