I would like to initiate a discussion of the possibility of being able to have the means of defending myself and others if something were to occur on my way to or from work. As things are, I am denied that right. Please reply on how we can explore this. Thank you.

Fort Gordon GC Mr. Snowberger, I appreciate your question and it is not the first time it has been addressed. There are many levels today who are considering this based on the incident at Ft Hood, but there are also as many who have the opposing view. Today, the only approved time to carry a weapon, and not concealed, is to the range or approved hunting areas. The regulation is not only a Fort Gordon, but a Department of

the Army regulation. In order to change this rule, we would have to have DA change their regulation. I hope this starts the discussion. COL Barker

The African American woman cashier came and stuffed a stick down it. This caused the machine to say the box was full and voided the .50 coupon. The cashier then tried to take the .50 cents off. Well she added .50 cents and proceeded to tell me see I took it off. I told her no you added .50 cents. She said no see it took it off because I can't click on the coupon button. She then clicked the check out button and then clicked the coupon button to take off .50 cents. I told her she needed to do it for a dollar because she added .50 cents. She then yelled at me and me told hold on and then typed in 5.50 as the coupon. She left disgruntled to get help because again she messed up. In the mean time, the other two machines are messing up. The one froze after she did something to it. People were getting really frustrated. So someone came, fixed the prices and I could check out. Well not so because so much had happened I could not check out without another scan from the cashier card. The lady left after my price was fixed hand the card to an African American male telling him people are getting mad at her. I truly believe what happened was this lady was not trained to help run those machines. She also had no people skills. I have never been yelled at like that before when I was trying to help her fix it. She refused to listen to me. So therefore I am not sure I would want to come back. With rude employees, expensive prices, and empty shelves this commissary has done nothing to have a draw back appeal. Thank you for reading! (1 like)

For units utilizing Fort Gordon ranges: all unit leaders are reminded that units needing to conduct live fire operations beyond the normal Range Operations Division duty ...hours will always be supported. That said, extended hour support does require us to coordinate scheduling of a very small Range staff. Units are asked to please schedule their extended range hours in advance with Range Operations Division if firing beyond 1630 is projected. Units are expected to begin scheduled firing at the time coordinated on the morning of scheduled range(s). We understand emergencies arise, and if unforecasted extended hours are required, advise Range Operations Division as soon as possible on the day of firing. Also, based on a question from one of our units, commands are permitted to schedule ranges for more than one day; we do expect firing to occur each of the scheduled days however. Units signing for ranges for more than one day, can put the range in a Cold Status, un-occupy the range when firing is complete, and reoccupy the following day to resume Hot firing status. Unit may NOT store ammo over night in the Range Ammo Breakdown buildings however. If a field ASP is required, please coordinate that in advance with the ASP and Range Control as there are specific physical security and safety requirements for field ASPs

Teri Stiffler Ryan My son is in college but is studying abroad this semester. I did not get a power of attorney to do his taxes. What do I do? (1 like)

Fort Gordon Garrison SJA There are several options available to your son. If he is overseas on April 15th, then he is granted an automatic 60-day extension to file his federal taxes. Note, this may or may not apply to his state taxes, if he has to file state taxes. And also, this extension is just to file, not to pay. If he does owe taxes, he will have to pay interest on amount of time he waits after April 15th to pay. Your son should be able to file electronically through the IRS website using E-File. That was an option last year. Your son can also use TurboTax if he can download from the website. If you can obtain a power of special power of attorney from him, specifically allowing you to file his taxes, you may be able to file his taxes through the Tax Center if he is a qualifying dependent (assuming you qualify for the Tax Center services).

There should be a policy that gives soldiers and their families coming from overseas location benefits of the incoming duty station upon arrival before warrant officer candidate school. Such as BAH and hotel lodging reimbursement. (1 like)

I plan on submitting to AFAP because this policy clearly needs to be changed not just little Army here but big Army. I have a friend who will be experiencing the same as us come the fall and I hope with enlightenment of a huge problem they will not go through this. Another note because my husband keeps saying it over and over again. We are not trying to get something we don't deserve. As I said we had no choice but to leave Okinawa.
