## **Fort Gordon Garrison**

**ISSUE:** Floor buffers - have (exposed) bare electrical wires -- a hazard to users. **ANSWER (DOL):** Individual needs to bring buffer into C&E Maintenance (Building 14608) of the Maintenance Division for repair. Buffer safety is the responsibility of the unit and once the item is identified as unsafe, it needs to be sent to maintenance for repair. POC is Mr. Ralph Gaines at 706-791-6024.

**ISSUE**: There is no consolidated and publicized list of local businesses that offer military discounts. The Army community would be able to make informed decisions when patronizing various establishments, or seeking services from local vendors. The listing could include the percentage of the discount and the name of the business. Soldiers and Family Members can be consulted to form the initial list. Recommendations: (1) Consult known establishments and gain permission to include their name on a consolidated list. (2) Publicize the list in the FYI on a monthly basis. (3) Publish the list in the Fort Gordon post phone book with an updated list each time the post phone book is updated. **ANSWER (SJA)**: The Federal Joint Ethics Regulation 3-209 prohibits endorsement by DoD or DoD employees in their official capacities of a non-Federal entity, event, product, service or enterprise. Because of this rule the command has to be very careful about giving the appearance that it endorses or otherwise publicizes a particular business. If an office on Fort Gordon were to consult establishments in order to list places that offered military discounts than it would give the impression that the Army is endorsing those businesses. Also the process of formulating the list would tend to give the appearance of the Army giving preferential treatment to certain business. There is no consolidated and publicized list of local business that offer military discounts in the Augusta GA area. However, a year ago The Augusta Chronicle published a list with multiple businesses in Augusta that offer military discounts. There are also many websites that allow individuals to search for businesses that offer military discounts. Unfortunately we are unable to use our resources at Fort Gordon for this type of project. The resources needed to set-up a website of this sort would be relatively significant and would require resources to maintain. The Command would not discourage efforts by private organizations or individuals to set-up a website that listed locally available military discounts.

**ISSUE**: Why is it so difficult to access Fort Gordon Regulations? Why are they apparently only available via AKO when they are intended to provide information to the general public? Fort Knox provides all of their policies and regulations with one click from their front page. I recommend that Fort Gordon prepare a similar link. (And as a follow up. When one gets to the Fort Gordon regulations there is no way of knowing if there are other current Fort Gordon regulations that might not be posted on AKO.)

Due to current Web security guidelines/requirements, we are compelled to abide by the changes that are now reflective on our website. The Fort Gordon website,

<a href="https://www.gordon.army.mil">www.gordon.army.mil</a>, is currently undergoing redevelopment and construction by the Public Affairs Office. They are exploring alternative options including one similar to Fort Knox's. We appreciate your patience and understanding in this matter.

Randy Faulkner: Why not post regs here? (1 likes)

**Fort Gordon Garrison**: Mr. Faulkner, please clarify your question.

Randy Faulkner: RE: Posting REGS here. Previously somebody had inquired about the difficulty in viewing FG Regs at the .mil site. The answer given centered around finding solutions to accessing REGS at .mil site. My question/comment was why not post the regs here on this FB site. FG has a healthy contingent of visitors - dinner theatre, riding stables, catering from the club, not to mention parents and families coming in just for AIT graduations. Regulations that could affect them - cell phone use, driving regs, etc would be of benefit and I will venture to say FB is easier to navigate than the official USASigCoE site.

**Sheryll Lander**: Good idea!

**Fort Gordon Garrison DHR**: Mr. Faulkner - if you mean posting the FG regulations on Facebook - we will explore this possibility. Thank you for your comment.

**ISSUE**: Do the people with the SKIES program understand that some children are raised by their fathers? The Mommy and me programs are great ideas, however, if one is not a "mommy," does it mean my child is left out? Open the programs. There are

fathers, grandparents, aunts and uncles caring for children. **ANSWER (DFMWR)**: Thank you for your suggestion. The "Mommy and Me" program is open to parents, guardians, etc, in the child's life who would like to participate, and are registered in CYSS. The names of all SKIES programs are provided by the contractor. We will request a name change with the contractor, will place that information on all marketing materials, and will ensure that no parent/guardian is denied access to the program.

**ISSUE**: Are there any arts programs for children during the summer and the school year? Not all kids are interested in football, soccer or other sports programs. For young people up to age 18, art, music, dance classes may provide an alternative to just "hanging out." Recommend art/dance/music clinics or programs. Augusta has a large artist community. Perhaps they could be part of our efforts to provide great art instruction to the children of Fort Gordon. ANSWER (DFMWR): Thank you for your interest. Fort Gordon's Schools of Knowledge, Exploration, Inspiration and Skills (SKIES) have been in partnership with the Augusta Arts Council since January of 2011. Our first partnership class has been in Art. We have also recently completed contracts for Tap, Ballet and Culinary Arts instruction. In addition to the Arts Council instructors, we have had a keyboard program since July 2009, offered by a local artist and former school music teacher. We now also offer the same instructor's Drum Circle Program also. We recently began a movement and music program (World Rhythms) for every age, using age appropriate music and dance moves for exercise and increased cardio. These instructors have a studio in town, have performed nationwide and have won many awards in competitions. Yoga, Drivers Ed and "Mommy and Me" are also current contracts under private instructors.

**ISSUE**: Georgia recently passed a law allowing the use of golf carts in local communities. This still has to be approved by the heads of the local communities and certain rules apply. The golf cart has to be road worthy (ie. headlights, tail and brake lights). Operators must have a valid driver's license to operate. Can this be done for personnel who live on Fort Gordon? This is an outstanding opportunity to help Soldiers and families to combat the high gas prices and save a huge amount of money being spent on routine travel on post. This would be an outstanding way for families to save a huge amount of money when it comes to routine travel to work, PX, or any other frequent trips on post. Electric golf carts are being used in numerous communities and towns. It saves the families money on gas as most of the carts are electric. These golf carts are advanced enough to have a long battery life. Routine trips around post are easily handled with plenty of battery life left over. Recommend someone look into approving the use of privately owned (electric) golf carts to families residing on FT Gordon. Operators must have a valid motor vehicle license to operate carts on FT Gordon. Golf Carts must be inspected and approved by Provost Marshal (or appropriate authority) before being allowed to operate on post (sticker system enforced). All speed limits will remain the same as most golf carts will run a maximum of 25 MPH. ANSWER (DES and DPW): Thank you for your suggestion. It will be taken under consideration for further study and staff evaluation.

**ISSUE**: Air Conditioning not operating for approximately two weeks - location: 447th Signal Battalion, Bravo CO (Building 25715). Repairs needed. **ANSWER (DPW)**: A review of our records shows three calls for air conditioning in isolated rooms of building 25715 over the last two weeks, but no instances of the air conditioning being out in the whole building. The three issues were quickly responded to and repaired. Current conditions in the building are good.

**ISSUE**: I am here TDY along with four of my Soldiers for seven weeks, swimming is an important part of our fitness program at our home station and a great no impact exercise, how can Fort Gordon not have one of two pools open during summer months. I am disappointed that I worked so hard to bring my Soldiers to Fort Gordon over another installation and what should have been accomplished during the winter months or one pool at a time, keeping one open was not managed. As I ride by the two facilities I see little to no work being done by contractors with my tax dollar. Not only do the Service Members need the pools but the youth of this installation are missing a great summer activity to fight the overweight problems we as a nation are combating with our youth. The sign on the door of the pool directs persons to travel 30 miles away during a time when fuel cost are too high and benefits are being cut (lower annual pay increases). At least find a close by pool and coordinate to support the post residents both permanent and TDY such as a YMCA and post that info somewhere during these 100 degree days. Thank you. ANSWER (DFMWR): We appreciate the opportunity to continue our efforts to share what is happening in our community. While it was not our intent to have both pools closed this summer, unforeseeable issues (infrastructure and contract) have resulted in delays to both projects. The good news is that the Courtyard Aguatics Complex will be open next summer and will be more family-oriented with ultramodern amenities to include a spray park. The indoor pool is expected to open in late October/early November of this year. Until the renovations and new construction are completed, there are two local aquatic facilities available for both recreation and physical training needs. They include:

services that a clerk would – except international and money orders. It is also open 24/7. The old stamp machines are not cost effective and have been removed from service. USPS will continue to pursue an APC for Fort Gordon.

**Patricia A. Sea**: What services do you or can you provide to Family members? Example, if a Soldier and family member are separating/divorcing and the spouse wants to come in?

**Fort Gordon SJA:** If you have a military ID then you are entitled to our services. We offer a divorce/separation brief every Thursday at 1500 for Soldiers and spouses to attend. This brief is mandatory prior to making an appointment to meet with an attorney individually. Our legal assistance office is only allowed to represent one individual from the marital unit but you are both entitled to come and receive information from the briefing on Thursday. Then appointments are made on a first come first serve basis after that.

**Patricia A. Sea:** But is this for the Soldier or is this for the Spouse of the Soldier as well?

Fort Gordon SJA: You are both entitled to our services and to attend the briefing, but only one of you will be able to see an attorney at our office. We are not able to see both of you because it would create a conflict of interest. The decision of who we... see is based on who is able to make an appointment first. If you are unable to make an appointment to see an attorney at our office due to this conflict then you are able to go to Fort Stewart or Benning to meet with one of the attorneys there. All of this will be explained in greater detail during the divorce brief on Thursday at 1500.

**Patricia A. Sea:** What assistance can you provide to a Soldier who is in an off post rental and the housing may be that of sub-standard living conditions (i.e., mold, unfinished wiring/building etc) especially if it could be causing medical harm to the Soldier and Family?

**Fort Gordon SJA**: In reference to the off-post rental - you should make an appointment to speak with one of the legal assistance attorneys. Bring your lease and any other pertinent information. They will sit down with you and listen to your concerns and assist to the best of their ability.

Patricia A. Sea: Thank you.

Been asking but no one at bb seems to know. Just to make clear not interested in fencing whole bark yard just a safety fence on account of both my baby and dog have almost fallen over it. Thank you.

Fort Gordon Garrison: Ma'am, we do have mass notification systems that are operated from the Installation Operations Center and ICW Balfour Beatty for the Housing Areas as long as we get notice. That isn't always possible. If we get warning that a Tornado is likely or in vicinity of Fort Gordon, we along with the local news stations who have real time Dopler weather feeds, will transit tornado warnings from those systems. We do not have tornado shelters per se as we are not in a tornado prone area. Understanding they are not choosy about where they touch down, residents are advised to seek shelter in the central portion of their quarters, in the bathtub / bathroom or similar. Our Soldiers in the barracks move to the central hallways, and the units in the field are directed toward our Gyms and Reserve Center or seek appropriate outdoor cover if they are far from shelter facilities.

**Susan Taylor Carvalho**: Thank you. Coming from "tornado alley" you can be understanding of my concern...

**Fort Gordon Garrison DES**: Completely! While we are not completely immune, as we have had strays, we are more prone to severe thunderstorms with hail. We actually just received a Storm warning and are notifying our field units. We welcome you and your family to Fort Gordon. Thanks for participating tonight! (1 likes)
