A recorded vote by electronic device was ordered in the Committee of the Whole on the following amendments en bloc submitted by Mr. CLAY:

At the end of paragraph (6) of section 4 strike "or", at the end of paragraph (7) strike the period and insert "; or", and add after paragraph (7) the following:
