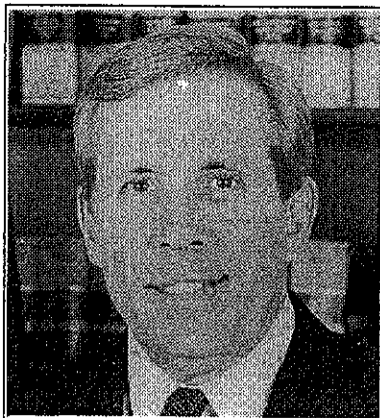

Congressman Wolf's Voting Record

FIRST SESSION, 101st CONGRESS • JANUARY 3–NOVEMBER 21, 1989

Dear Friends:

This report includes the votes I cast for the First Session of the 101st Congress, continuing my practice of making my complete voting record available to the people of the 10th District of Virginia. This record has been mailed to every household in the 10th District each year since I began serving in the House of Representatives in 1981 because I believe it is important for you to know how I have voted on all matters coming before Congress.

There were 379 roll call votes during the First Session of the 101st Congress which convened on January 3 and adjourned on November 21, 1989. Of those 379 roll calls, I missed only three votes, for a voting attendance record of 99 percent. The 379 roll calls included 57 procedural votes such as approving the Speaker's journal, quorum calls and motions to adjourn. Because of space limitations, those procedural votes are not listed in this record. To assist you in understanding the terminology used in the legislative process, a glossary of terms used in this report to describe the votes may be found on page 2.

This report is arranged by general subject areas as follows: each vote begins with the roll call number, followed by the number of the bill or resolution being considered and a short descrip-

tion of the question on which the vote was taken, including amendments, motions and passage. Next my own vote on the measure is listed by a "yes" or "no." The vote of the entire House of Representatives is next indicated by "passed" or "failed" with the vote total, followed by the date on which the vote occurred. Votes taken under suspension of the rules are so indicated and an explanation of that procedure may be found in the glossary.

I hope you find this voting record information helpful. As the 101st Congress continues its work in the Second Session beginning in January 1990, I encourage you to share your comments on this report and let me know your views on the challenging issues which face our district and the nation and other matters of interest to you.

(141) **H.R. 2883**, to appropriate \$42.1 billion in FY 1990 for the U.S. Department of Agriculture and related agencies, including \$38 billion in new budget authority and \$4.1 billion in transfers from Customs receipts. **Yes.** Passed 394-26. 7/18/89.

(228) **H.R. 2869**, to authorize \$40 million in FY 1990 and \$44 million in FY 1991 for the operations of the Commodity Futures Trading Commission and to amend the Commodity Exchange Act to improve CFTC enforcement and regulation, place limits on certain trading practices, and increase penalties for violators of the act. **Yes.** Passed 420-0. 9/13/89.

BUDGET, TAXES & REVENUE

(39) **H.Con.Res. 106**, concurrent resolution on the budget for FY 1990. Amendment as a substitute to provide for a deficit reduction of \$62 billion through refinancing the government's debt by issuing 40-year, gold-backed bonds and declaring a one-time tax amnesty. **No.** Failed 72-350. 5/4/89.

(40) **H.Con.Res. 106**. Amendment as a substitute to reduce the FY 1990 defense authority by \$35.4 billion and raise \$20.1 billion in additional revenues through various tax measures targeted at the very wealthiest individuals and corporations. **No.** Failed 81-343. 5/4/89.

(41) **H.Con.Res. 106**. Amendment as a substitute to provide for a further \$8.6 billion in deficit reduction by freezing all discretionary spending at the FY 1989 programs levels, reducing Medicare by an additional \$2.7 billion and providing for \$300 million in additional savings. **No.** Failed 30-393. 5/4/89.

(42) **H.Con.Res. 106**. Amendment as a substitute to raise an additional \$9 billion in revenue through a \$5-per-barrel oil import fee and provide \$5.8 billion for various high priority domestic programs and \$3.2 billion for additional deficit reduction. **No.** Failed 49-373. 5/4/89.

(43) **H.Con.Res. 106**. binding federal budget levels for the U.S. government for FY 1990-92: budget authority, \$1.3294 trillion; outlays, \$1.1652 trillion; revenues, \$1.0655 trillion; deficit, \$99.7 billion; to raise the national debt limit to \$3.1227 trillion, and to recommend general spending levels for the various functions of government conforming to the bipartisan budget agreement with the White House on defense and non-defense discretionary spending levels. **Yes.** Passed 241-185. 5/17/89.

(249) **H.R. 3299**. Amendment to delete a provision in the bill that requires trustee boards that administer single-employer pension plans to consist

of equal representation of employees and employers. **Yes.** Passed 250-173. 9/27/89.

(250) **H.R. 3299**. Amendment to repeal Section 89 of the 1986 tax code overhaul that requires employers to prove their health benefit plans are non-discriminatory. **Yes.** Passed 390-36. 9/27/89.

Amendment to strike the capital gains tax cut provisions in the bill and instead expand the availability of Individual Retirement Accounts (IRAs) by allowing a 50 percent deduction of IRA contributions, allow funds to be withdrawn from IRAs without penalty if used to help buy a first home or to pay college costs, extend the current 33 percent tax rate to apply to incomes above the level at which the rate drops from 33 to 28 percent under current law, and place the resulting net revenue gain in a special Deficit Reduction Trust Fund. **No.** Failed 190-239. 9/28/89.

(263) **H.R. 3299**. Amendment to delete provisions in the bill that would enact the "fairness doctrine" requiring broadcasters to air both sides of political issues and permit the Federal Communications Commission to fine broadcasters for violation of the doctrine. **No.** Failed 162-261. 10/3/89.

(267) **H.R. 3299**. Amendment to repeal nearly all of the 1988 Medicare Catastrophic Coverage Act (PL 100-360) retaining only the non-Medicare provisions, primarily selected Medicaid expansions. **Yes.** Passed 360-66. 10/4/89.

(268) **H.R. 3299**. Amendment to repeal the surtax and all stop-loss coverage of hospital and doctor bills under the 1988 Medicare Catastrophic Coverage Act, while retaining broad prescription drug coverage and non-Medicare provisions. **No.** Failed 156-269. 10/4/89.

(272) **H.R. 3299**. Amendment to strike all child care provisions in the bill and replace them with an expansion of Earned Income Tax Credit plus a new supplemental tax credit for working-poor families with children under age 5. **Yes.** Failed 140-285. 10/4/89.

GLOSSARY OF TERMS USED IN VOTING RECORD REPORT

AMENDMENT—A proposal of a member of Congress to alter the language, provisions or stipulations in a bill or in another amendment. It is usually printed, debated and voted upon in the same way as a bill.

APPROPRIATIONS—Legislation which provides the actual funds approved by authorization bills, but not necessarily the full amount authorized. There are 13 regular appropriations bills which must be approved on an annual basis effective for the fiscal year which begins on October 1. (Also see Continuing Resolution.)

AUTHORIZATION—Basic, substantive legislation that establishes or continues (reauthorizes) the legal operation of a federal program or agency, either indefinitely or for a specific period, or which sanctions a particular type of obligation or expenditure.

BILL—A legislative proposal, designated as H.R. in the House of Representatives and S. in the Senate, followed by a number assigned in the order in which it is introduced during the two-year period in which a Congress is convened. If approved by both houses of Congress in the same form and signed by the President, a bill becomes a law.

COMMITTEE OF THE WHOLE—A procedural device designed to expedite the legislative work of the House in which slightly less formal rules for conduct of debate and voting on amendments apply.

CONCURRENT RESOLUTION—A resolution, designated as House Concurrent Resolution (H.Con.Res.) or Senate Concurrent Resolution (S.Con.Res.), often used to express the "sense of Congress" on various domestic or foreign policy issues. Concurrent resolutions do not require or are not intended for approval by the President and therefore do not have the force of law.

CONFERENCE—A meeting between the representatives of the House and Senate to reconcile differences between the two houses over provisions of a bill or joint resolution passed by both chambers. A majority of the members of the conference from each chamber must agree on the provisions of the measure before it can be considered by either chamber in the form of a "conference report." Conference reports cannot be amended and if not approved, the legislation may go back to conference or a new conference must be convened. Legislation passed by both houses with only minor differences need not be sent to conference; either chamber may "concur" in the other's amendments, completing action on the legislation.

CONTINUING RESOLUTION—A joint resolution which continues in effect appropriations legislation for specific ongoing activities of federal departments or agencies when a fiscal year begins and Congress has not yet enacted all of the 13 regular appropriations bills for that fiscal year.

HOUSE—The House of Representatives, as distinct from the Senate, although each body is a "house" of Congress.

JOINT RESOLUTION—A resolution designated House Joint Resolution (H.J.Res.) or Senate Joint Resolution (S.J.Res.), followed by a number assigned in the order in which it is introduced during the two-year period in which a Congress is convened. If approved by both houses in the same form and signed by the President, it becomes a law just as a bill does. A joint resolution is generally limited to special circumstances and is also used to propose amendments to the Constitution. Under that purpose, it does not require a presidential signature and becomes part of the Constitution when three-fourths of the states ratify or approve it.

PREVIOUS QUESTION—A request for the previous question, or a motion on the previous question in the House brings to a vote the question of whether debate and the possibility of amending the question should end and the merits of the pending issue should be voted upon. For example, the previous question is voted upon during consideration of a rule, which sets the time limits for debate and allows certain amendments to be considered on a bill. If a member wanted an additional amendment to be considered which was not made in order by the rule, he or she could work to defeat the previous question and if successful the rule would be amended to include the member's request. If the motion to order the previous question is approved, debate on the issue and the possibility of amendment end.

RESOLUTION—A simple resolution, designated House Resolution (H.Res.) or Senate Resolution (S.Res.), deals with matters entirely within the prerogatives of one house or the other. It requires neither passage by the other chamber nor approval by the President, does not have the force of law and is commonly used for internal business of that house or for expressing views of that house.

RULE—A resolution from the House Rules Committee which, if adopted by the House, sets the procedures and time limits for debate and voting on a pending bill or resolution. A rule can be open, which would allow any member to offer an amendment to the pending legislation; modified closed, which would allow only certain amendments approved by the Rules Committee to be offered; or closed, which would not allow any amendments to be offered.

SUSPENSION OF RULES—A procedure used in the House intended to speed the consideration of non-controversial legislation. Under suspension of the rules, debate is limited to 40 minutes, no amendments from the floor are permitted, and a two-thirds vote of those members voting is required for passage.

(13) **H.R. 2,** minimum wage increase. Amendment as a substitute to raise the minimum wage from its current \$3.35 an hour to \$4.25 over three years; create a new hire training wage of \$3.35 an hour in 1990 (and not less than 80 percent of the minimum wage in subsequent years) payable for up to 180 days to a first-time employee; and call for a three-year study of the enforcement and demographics of the training wage. **Yes.** Failed 198-218. 3/23/89.

(14) **H.R. 2.** Amendment as a substitute to raise the minimum wage in October of each year to levels of \$3.85 in 1989, \$4.25 in 1990, and \$4.55 in 1991; establish a 60-day training wage equal to 85 percent of the minimum for those beginning their first job and which would expire Sept. 30, 1992; and increase the small employer exemption to \$500,000. **No.** Passed 240-179. 3/23/89.

(15) **H.R. 2.** Amendment to provide harsher administrative penalties to employers who violate the minimum wage rules and Fair Labor Standards Act requirements. **No.** Failed 98-321. 3/23/89.

(16) **H.R. 2.** On passage of the bill to increase the minimum wage from its current \$3.35 an hour to \$4.55 over three years and provide for a 60-day training wage (with an expiration date of Sept. 30, 1992) equal to 85 percent of the minimum for employees who have never held a job before. **No.** Passed 248-171. 3/23/89.

(31) **H.R. 2.** Motion to instruct House conferees on the bill to insist on the Senate provision calling for a review of the Medicare Catastrophic Coverage Act of 1988. **Yes.** Passed 408-0. 4/18/89.

(52) **H.R. 2.** To agree to the conference report on the bill to amend the Fair Labor Standards Act of 1938 to increase the minimum wage to \$4.55 per hour over three years, establish a 60-day training wage and Minimum Wage Review Board to annually review and recommend changes in the minimum wage rate. **No.** Passed 247-172. 5/11/89.

(85) **H.Res. 173,** rule to consider H.R. 1278, to reform, recapitalize, and consolidate the federal deposit insurance system, and to enhance the regulatory and enforcement powers of federal financial institutions regulatory agencies. **Yes.** Passed 330-95. 6/14/89.

(86) **H.R. 2.** To pass, over the veto of the President, the bill to raise the minimum wage from \$3.35 to \$4.55. **No.** Failed 247-178. (2/3 vote required).

(87) **H.R. 1278,** Financial Institutions Reform, Recovery and Enforcement Act. Amendment to allow the FDIC or the Office of Thrift Supervision to decide on a case-by-case basis whether or not the supervisory goodwill that a savings and loan institution carries on its books is based on a valid contract with the government and may therefore continue to be counted toward the thrift's capital requirements. **No.** Failed 94-326. 6/15/89.

(88) **H.R. 1278.** Amendment to authorize civil penalties of up to \$1 million a day for certain criminal offenses involving financial institutions. **Yes.** Passed 382-41. 6/15/89.

(89) **H.R. 1278.** Amendment to make the Resolution Funding Corporation an on-budget government agency but eliminate the Gramm-Rudman-Hollings deficit reduction law exemption. **No.** Failed 171-256. 6/15/89.

(90) **H.R. 1278.** Amendment to make the Resolution Funding Corporation (REFCORP) an on-budget government corporation that would borrow directly from the Treasury and exempt REF-CORP's borrowing from Gramm-Rudman-Hollings budget deficit calculations. **No.** Passed 280-146. 6/15/89.

(91) **H.R. 1278.** Amendment to require federal regulatory agencies to disclose the ratings and evaluations that they give to banks and thrifts regarding lending to the communities that they serve and require mortgage lenders to disclose the number of applications they receive and approve by categories of race, income, and gender. **No.** Passed 214-200. 6/15/89.

(92) **H.R. 1278.** Amendment to prohibit federally insured savings and loans institutions from investing in high-risk "junk bonds." **Yes.** Passed 303-114. 6/15/89.

(93) **H.R. 1278.** Amendment to strike provisions requiring the 12 regional Federal Home Loan banks to earmark a portion of their annual earnings to subsidize the making of low-income mortgages by savings and loan associations. **Yes.** Failed 206-208. 6/15/89.

(94) **H.R. 1278.** Motion to recommit the bill to the Banking, Finance and Urban Affairs Committee with instructions to report it back to the House without certain special-interest provisions benefiting only a few financial institutions. **Yes.** Passed 412-7. 6/15/89.

(95) **H.R. 1278.** On passage of the bill to raise \$50 billion to close and liquidate insolvent savings and loan associations and to restructure the thrift industry to create a new regulatory structure to oversee the industry and put in place safeguards to prevent events which created the current savings and loan crisis. **Yes.** Passed 320-97. 6/15/89.

(212) **H.Res. 222,** rule to consider the conference report to H.R. 1278, Financial Institutions Reform, Recovery and Enforcement Act (savings & loan reform bill). **Yes.** Passed 348-74. 8/3/89.

(213) **H.R. 1278.** Motion to recommit the bill to the conference committee with instructions to revise the bill's mechanism for financing \$50 billion to close insolvent thrifts. **Yes.** Failed 170-250. 8/3/89.

(214) **H.R. 1278.** To agree to the conference report on the bill to salvage the nation's savings and loan industry and overhaul federal thrift regulation. **No.** Passed 221-199. 8/3/89.

(219) **H.R. 1278.** To agree to the revised conference report on the bill to reform, recapitalize, and consolidate the federal deposit insurance system and to

enhance the regulatory and enforcement powers of the federal financial institutions regulatory agencies. **Yes.** Passed 201-175. 8/4/89.

Motion to further insist on the House's disagreement with the Senate's proposal to retain unlimited hospital coverage and several other Medicare benefits from the 1988 act. **Yes.** Passed 352-63. 11/21/89. (Note: the House had voted to repeal virtually all of the 1988 law, retaining only provisions affecting the Medicaid program.)

(378) **H.R. 3607**. To concur in the Senate amendment to retain a slightly scaled-back hospitalization benefit and to preserve several other Medicare benefits from the 1988 Medicare Catastrophic Coverage Act. **No.** Failed 55-346. 11/21/89.

(50) **H.Res. 87**, to impeach U.S. District Judge Walter L. Nixon of the U.S. District Court for the Southern District of Mississippi for high crimes and misdemeanors, while specifying the three articles under which the impeachment is warranted, including two counts of lying under oath and one of undermining the integrity of the judiciary. **Yes.** Passed 417-0. 5/10/89.

(111) **H.Res. 186**, to express the House of Representatives' "profound concern" over the Supreme Court's June 21 decision declaring unconstitutional a Texas statute and, as a result, similar state and federal laws prohibiting the desecration of the U.S. flag, and to state the House's "continued commitment to preserving the honor and integrity of the flag." **Yes.** Passed 411-5, under suspension of rules. 6/27/89.

(194) **H.R. 2991**, Commerce, Justice, State and Judiciary appropriations for FY 1990. Motion that the Committee of the Whole rise and report the bill back to the House. **No.** Failed 197-227. 8/1/89. (Note: the effect of the vote was to allow consideration of amendments limiting spending on the appropriations bill, in

this case an amendment to bar use of census funds to count illegal aliens. Such amendments are in order only following a defeated motion to rise and report.)

(195) **H.R. 2991**. To sustain the ruling of the chair that an amendment to prohibit the use of appropriated funds to count illegal aliens was out of order because it constituted legislation on an appropriations bill. **Yes.** Passed 228-134. 8/1/89.

(196) **H.R. 2991**. To table the appeal of the chair's ruling that the motion to recommit the bill with instructions that no census funds be used to count illegal aliens was out of order because such a limiting amendment is barred from an appropriations bill. **No.** Passed 249-172. 8/1/89.

On passage of the bill to appropriate \$5.8 billion for the departments of Commerce, Justice, and State, the federal judiciary and 23 related agencies in FY 1990. **Yes.** Passed 258-165. 8/1/89. (260) **H.Res. 251**, **H. Res. 252**. Resolutions en bloc to make technical amendments in the articles of impeachment against Walter L. Nixon, Jr., judge of the U.S. District Court for the Southern District of Mississippi, for high crimes and misdemeanors, and to notify the Senate of the adopted amendments. **Yes.** Passed 370-0. 10/2/89.

(282) **H.R. 2991**. Motion to order the previous question (thus ending debate and possible amendment) on the motion to instruct House conferees on the FY 1990 appropriations bill for the departments of Commerce, Justice, and State and the Judiciary. **No.** Passed 232-184. 10/11/89. (Note: Motion to instruct would have been amended if previous question defeated to instruct conferees to accept a Senate provision which does not permit the use of funds to count illegal aliens in the 1990 census.)

(283) **H.R. 2991**. Motion to instruct House conferees on the FY 1990 appropriations bill to the departments of Commerce, Justice and State and the judiciary to agree to the Senate amendment which calls on the President to include in the agenda of the proposed international drug summit the removal of General Manuel Noriega from any position of power in Panama. **Yes.** Passed 399-0. 10/11/89.
