Important Information: *Although each member of Congress is allotted a limited number of nominations to the service academies, a congressional nomination does not guarantee an appointment or an offer of admission. The President of the United States officially makes all appointments to the service academies.*



ELIGIBILITY

Each applicant for a service academy nomination must meet the following eligibility requirements as of July 1 of the year of admission to an academy:

- Age:** At least 17 years old, but not yet 23 years old (age 25 for the Merchant Marine Academy.)
- Citizenship:** Must be a U.S. citizen and a permanent resident of the Commonwealth of Pennsylvania.
- Marital Status:** Unmarried, not pregnant, and have no legal obligation to support children or other dependents.

Please do not send your application materials to any office other than Harrisburg. Failure to do so could result in processing delays and missed deadlines.
