

YOUTH ART MONTH 2012 and 2nd Congressional District Art Competition 2012 "Kaha Ki'hi – An Artistic Discovery

Youth Art Month (YAM) includes the following competitions:

- YAM State Capitol Exhibit 2012 Open to students grades K-12 on all islands
- YAM Flag Event Judging completed early December: First Place – Selena Vanapruks, Kapolei Middle School, Oahu Second Place – Kelley Donaghy, St. Anthony Jr./Sr. High School, Maui Third Place – Nate Biondi, Parker School, Big Island
- 2nd Congressional Art Competition 2012 "Kaha Ki'i-An Artistic Discovery" Open to students grades 9-12 from the Second Congressional District (rural Oahu and neighbor island schools only).

YAM State Capitol Exhibit and Congressional Art Competition Guidelines

Eligibility

Students in grades K-12 enrolled in any public, private, charter, or parochial school. Grades 9-12 only for Congressional Art Competition.

Any artwork that has been previously accepted into the **Scholastic Art Awards Exhibition** cannot be reentered into the YAM/Congressional competitions. This is a **violation** of Scholastic Art's exclusive exhibit agreement.

Medium

Only 2D submissions (drawings, paintings, photographs, computer art, mixed media, and printmaking) will be accepted for this exhibit.

Artwork will be judged in the following age categories:

- K-2
- 3-5
- 6-8
- 9-12

The amount selected for the exhibit will vary based on the **percentage of artworks** submitted for jurying.

Winning artworks will be on display at the State Capitol throughout the month of March.

Cash prizes (amount to be determined) will be awarded to the best in show from each age category.

Size Restriction

Actual artworks (including the outside dimensions of mat) may not exceed the following sizes:

- Elementary (K-5) submissions: 18" x 24"
- Middle (6-8) and High School (9-12) submissions 36" x 48"
- Congressional Art submissions 28" L x 28" H x 4" D

Adjudication

All artwork for jury submissions will be sent, viewed, and judged as computer image files.

Image files that are **not labeled properly** (see below) or **not received by the submission deadline** will be disqualified.

Image file specifications:

- **JPG files:** JPG files should be captured by a high-resolution camera.
- **Image Size:** Each JPG file must be at least 1500 by 2100 pixels
- **Image Quality:** 300 dpi
- File Size: Each JPG file should be at least 1 megabyte but no greater than 10 megabytes.
- Save File As: Grade School Student Last Name First Name Media "Title" (example:
- 7_Dole Middle_Smith_John_Pencil_"Self Portrait".jpg)
- For Congressional Art only Save File As: CON_School_Student Last_First Name _Media_"Title".jpg

Submission Date

Email files to hawaiiyouthartmonth@gmail.com between January 9 - February 10, 2012. Judging will take place on Saturday, February 18.

Exhibition Fee

There is no fee to submit entries for judging for either the YAM or Congressional competition. However, to defray costs (shipping of works from the neighbor islands, use of the Capitol auditorium), a \$5.00 exhibition fee will be collected for every artwork selected for the YAM exhibit only. Make checks out to **Hawaii Art Education Association**. Oahu schools can submit payment during drop off. Neighbor island schools will mail payment, address TBA.

No fee will be collected for the Congressional Art semi-finalists from each island. Congressional Art entrants can contact Kehau Yap at Congresswoman Hirono's Hawaii office to arrange for a pre-paid shipping label, tel 808-541-1986 or Hirono.HawaiiOffice@mail.house.gov.

Matting

Works that are selected for YAM and Congressional must be matted and adhere to the above size restrictions. The purpose of the mat is to enhance the presentation of the artwork. Also, adhesives (used to hang up the artwork at the exhibit) are applied to the mat to prevent damage to the artwork itself.

- All work must be matted with no more than 4 inches in framing width.
- Use white mat only (no black or colored mats). Elementary entries may be matted with oak tag, railroad board, or mat board. No construction paper or foam core.
- Middle and high school entries must use mat board.
- No matting is necessary for canvas painting entries. The edge of the canvas should be painted to make the work exhibit ready.
- Any work that is easily smeared (such as pastels, chalk, charcoal, etc.) should be covered with acetate.
- Please follow the labeling directions on page 4 to expedite identification of art work.

Drop Off of Selected Artworks

After selections are made, a list of YAM and Congressional semi-finalists will be sent via email to all participating schools on **February 19-20**.

Artwork will be prepared for exhibition by the school and dropped off at the following designated locations on Oahu and the neighbor islands.
