The Committee on the Judiciary had referred to it 1,081 bills and resolutions during the 100th Congress. This represents 19% of the 5,585 bills and resolutions introduced in the U.S. House of Representatives for that Congress. Of this number, 812 were public bills and resolutions, and 252 were private bills and resolutions. A total of 58 which received consideration by the Committee were enacted into public law; and no measures considered by the Committee were enacted into private law.
