



# Congressman Wolf's Voting Record

Second Session, 97th Congress — January 25 - December 21, 1982

This voting record for the second session of the 97th Congress which adjourned in the House of Representatives on December 21, 1982, is arranged by general subject areas as follows: Each vote begins with the roll call number, followed by the number of the bill or resolution and a description of the question on which the vote was taken including amendments, motions and final passage. This is followed by my own vote on the issue. Finally, the vote of the entire House of Representatives is indicated by

passed or failed followed by the yes-no vote totals. There were a total of 488 roll call votes for the second session. That total includes 72 procedural votes such as approving the speaker's journal and resolving into the Committee of the Whole House to consider legislation, and 29 quorum calls. Those procedural votes are not listed. Votes indicated under suspension of the rules require two-thirds of those voting for passage.

## AGRICULTURAL AND RURAL AFFAIRS

(2) H.Res. 355. Rule to consider H.J.Res. 389, making urgent supplemental appropriation of \$5 billion in borrowing authority for FY 1982 for the Commodity Credit Corporation. Yes. Passed 329-72.

(3) H.J.Res. 389. Motion to recommit the resolution to the Committee on Appropriations with instructions to report it back with an amendment to the supplemental appropriation for the Commodity Credit Corporation to prohibit use of funds for payment on guaranteed loans to Poland. Yes. Failed 152-256.

(4) H.J.Res. 389. On passage of the supplemental appropriation for the Commodity Credit Corporation. Yes. Passed 320-86.

(21) H.R. 2160. Bill to increase the maximum assessment rate charged potato farmers for participation in the federally sponsored potato promotion program. Yes. Passed 361-8.

(211) H.Res. 528. Rule to consider H.R. 5203, a bill to amend the Federal Insecticide, Fungicide and Rodenticide Act. Yes. Passed 301-2.

(282) H.R. 5618. Bill to require the U.S. Department of Agriculture to establish six regional organic farming pilot projects with a network of volunteer experts to provide advice on and assistance with organic agriculture methods to family farms and other agricultural enterprises. No. Failed 189-198.

(314) H.R. 5831. Bill to provide lending limits for FY's 1983, 1984 and 1985 for certain programs under the Consolidated Farm and Rural Development Act Administered by the Farmers Home Administration. Yes. Passed 372-39.

(347) H.R. 7072, FY 1983 Agriculture, Rural Development and related agencies appropriations. Amendment to provide that the food stamp program appropriation be for all of FY 1983 rather than just the period from Oct. 1, 1982, through July 15, 1983. No. Failed 125-246.

(348) H.R. 7072. On passage of the bill appropriating \$23.1 billion for agriculture, rural development and related programs and agencies in FY 1983. Yes. Passed 264-105.

(363) H.Res. 566. Rule to consider H.R. 5447 relating to commodity futures trading. Yes. Passed 387-0.

(365) H.R. 5447, bill to extend the Commodity Exchange Act. Amendment to impose transaction fees on futures and options transactions to help pay the costs of Commodity Futures Trading Commission regulatory programs. No. Failed 170-216.

(366) H.R. 5447. On passage of the bill to extend the Commodity Exchange Act codifying jurisdictional authority of the Commodity Futures Trading Commission, authorizing sums to continue CFTC activities under the Act through FY 1986, and other purposes. Yes. Passed 319-59.

(456) H.R. 7072. To agree to the conference report on the bill making appropriations of \$31.7 billion for agricultural, rural development, domestic food and international programs within the U.S. Department of Agriculture and related agencies for FY 1983. Yes. Passed 324-73.

(41) H.J.Res. 409. Resolution to extend through Sept. 30, 1982, the FY 1982 continuing appropriations resolution, H.J.Res. 370, which expires March 31, 1982. Yes. Passed 299-103.

(60) H.Res. 415, the rule to consider H.R. 5922, making urgent supplemental appropriations for FY 1982. Motion to order the previous question and end debate on the closed rule which did not allow amendment to the bill. No. Passed 240-158. (A "no" vote was in support of an amendment to transfer \$1 billion from the synfuels program to an emergency housing program.)

(61) H.Res. 415. On passage of the rule to consider H.R. 5922. Yes. Passed 338-54.

(71) H.R. 5922, urgent supplemental appropriations for FY 1982. Amendment to provide \$1 billion in funds for a new mortgage subsidy assistance program administered by the Department of Housing and Urban Development. Yes. Passed 343-67.

(72) H.R. 5922. Amendment to prohibit expenditure of HUD funds if in violation of the balanced budget provisions of the International Monetary Fund Act of 1978. Yes. Failed 132-276.

(73) H.R. 5922 Amendment to delete language restoring enforcement authority to the Mine Safety and Health Administration of safety and health standards on surface mining or stone, clay, gravel, phosphate, or on surface construction on mine property. Yes. Failed 186-220.

(134) H.R. 5922. Motion to order the previous question and end debate on the motion to instruct conferees on the urgent supplemental appropriations bill. No. Failed 176-218.

(135) H.R. 5922. Amendment to motion to instruct conferees to accept Senate amendments to the supplemental appropriations bill which provide that any legislation entailing an authorization for expenditure from appropriations remain within the limits of revenue and provide for repeal of the special tax deductions for members of Congress. Yes. Passed 356-43.

(136) H.R. 5922. Motion to instruct conferees to agree to amendments as explained in roll 135. Yes. Passed 378-7.

(147) H.Res. 502. Rule to consider the conference report on H.R. 5922, urgent supplemental appropriations. Yes. Passed 257-155.

(148) H.R. 5922. Motion to recede from disagreement and concur, with amendment, to a Senate amendment to the conference report on the bill relating to payments for operation of HUD low-income housing projects. Yes. Passed 312-96.

(149) H.R. 5922. Motion to recede from disagreement and concur in a Senate amendment to the conference report on the bill relating to a rescission in the rent supplement program. Yes. Passed 299-104.

(150) H.R. 5922. Motion to concur, with amendment, to a Senate amendment to the conference report on the bill relating to tax breaks for members of Congress, repealing the \$75/day tax break and restoring the \$3,000 limit on business tax deductions, and adding language to the Senate amendment capping outside earned income for all members at 30 percent of congressional pay. (174) H.R. 5922, urgent supplemental appropriations for FY 1982. To reconsider and pass the bill over the veto of the President. Yes. Failed 253-151 (two thirds vote in favor needed to override).

(175) H.R. 6682. Bill making urgent supplemental appropriations of \$5.9 billion for FY 1982. (Note: this bill differs from H.R. 5922 in that the \$3 billion housing stimulus program is omitted; the bill does contain the repeal of the members of Congress tax break.) Yes. Passed 267-106.

(176) H.R. 6685. Bill making urgent supplemental appropriations of some \$4 billion for FY 1982 to July 20, 1982. Yes. Passed 342-25.

(179) H.R. 6682, urgent supplemental appropriations for FY 1982. To reconsider and pass the bill over the veto of the President. Yes.

Failed 242-169 (two-thirds vote in favor needed to override).

(185) H.R. 6685, urgent supplemental appropriations. To recede from disagreement and concur in the Senate amendment to the bill providing funds for summer youth employment, nursing research grants, the Work Incentive Program, refugee and entrant assistance, the Federal-Aid Highway Program and the Postal Service Fund. Yes. Passed 389-13.

(229) H.R. 6863. Bill making supplemental appropriations for FY 1982 in the amount of \$14.2 billion. Yes. Passed 282-111.

(293) H.R. 6863, FY 1982 supplemental appropriations. Adoption of the conference report on the bill to appropriate \$14.2 billion in new FY 1982 budget authority for federal military and civilian employee pay raises, commodity credit programs, defense and other programs. Yes. Passed 348-67.

(294) H.R. 6863. Motion to recede from disagreement and concur with a Senate amendment to the conference report on the bill to appropriate \$350 million for President Reagan's Caribbean Basin Initiative. Yes. Passed 281-129.

(295) H.R. 6863. Motion to recede from disagreement and concur with a Senate amendment to the conference report on the bill to provide funds for Military Assistance Program (MAP) grants, with an amendment to provide \$2 million in new budget authority and to reprogram \$25 million in already appropriated funds as follows: \$10 million for Honduras, \$5 million for Somalia, \$2 million for Costa Rica and \$10 million for Portugal. The effect of the amendment was to eliminate \$20 million in military aid to El Salvador and halve the amount to Somalia. Yes. Passed 237-175.

Motion to agree to a Senate amendment to the conference report on the bill to help the U.S. copper industry by requiring that all proceeds from sales of material in the government's national defense stockpile between July 31, 1982, and Oct. 1, 1983, be used to purchase copper mined and smelted in the U.S. after July 31, 1982, for the stockpile. No. Failed 62-339.

(316) H.R. 6863, supplemental appropriations for FY 1982. To reconsider and pass the bill making \$14.2 billion in supplemental appropriations for FY 1982 over the veto of the President. Yes. Passed 301-117 (two-thirds vote in favor needed to override).

(357) H.Res. 596. Rule to consider H.J.Res. 599, making continuing appropriations for FY 1983. No. Passed 280-120.

(358) H.J.Res. 599. Motion to recommit the resolution to the Committee on Appropriations with instruction that it be reported back containing an amendment to provide continuing appropriations until final adjournment of the 2nd session of the 97th Congress, rather than Feb. 28, 1983. Yes. Failed 188-215.

(359) H.J.Res. 599. On passage of the resolution making continuing appropriations for FY 1983. Yes. Passed 242-161.

(388) H.J.Res. 599. To agree to the conference report on the resolution making continuing appropriations for FY 1983. Yes. Passed 290-123.

(389) H.J.Res. 599, continuing appropriations for FY 1983. Motion to concur in a Senate amendment with an amendment relating to the air traffic controllers pay package to allow in effect the rehiring of striking controllers. No. Failed 128-267.

(443) H.Res. 626. Rule to consider H.J.Res. 631, making further continuing appropriations and providing for productive employment for FY 1983. No. Passed 223-163.

(444) H.J.Res. 631, continuing appropriations resolution. Amendment to require that at least 50 percent of the Agency for International Development bilateral assistance funds must be used to finance projects which directly benefit

those living in absolute poverty. No. Passed 227-184.

(445) H.J.Res. 631. Amendment to increase pay for members of Congress by 15 percent and to provide pay increases of varying percentages for senior level federal officials and employees. Yes. Passed 303-109.

(446) H.J.Res. 631. Amendment to continue the current cap on salaries for members of Congress at \$60,662 a year. No. Failed 208-208.

(447) H.J.Res. 631. Amendment to delete all funds provided by the resolution for the Clinch River Breeder Reactor, except those for termination costs. Yes. Passed 217-196.

(448) H.J.Res. 631. Amendment to prohibit any expenditure for the Bureau of Reclamation's O'Neill Irrigation Unit in Nebraska. Yes. Passed 245-144.

(449) H.J.Res. 631. Amendment to delete all funds provided by the resolution for the Garrison Diversion water project in North Dakota. Yes. Passed 252-152.

(450) H.J.Res. 631. Motion to recommit the resolution to the Committee on Appropriations with instructions to delete jobs program funding (Title II) and add \$44 million in funding for Voice of America and Radio Free Europe/Radio Liberty. Yes. Failed 191-215.

(451) H.J.Res. 631. On passage of the resolution making continuing appropriations from Dec. 18, 1982, until the earlier of March 15, 1983, or enactment of the individual FY 1983 appropriations bills, and providing \$5.4 billion in additional FY 1983 authority for "emergency jobs stimulus" programs. No. Passed 204-200.

(79) H.R. 6068. Bill to provide FY 1983 and supplemental FY 1982 authorization for the intelligence and intelligence-related activities of the CIA and other federal agencies at levels specified in a classified schedule of authorizations. Yes. Passed 357-23.

(131) H.R. 4. To agree to the conference report on the Intelligence Agents' Identities Protection Act, a bill to prohibit the unauthorized disclosure of information identifying certain U.S. intelligence officers, agents, informants and sources. Yes. Passed 315-32.

(186) H.Res. 520. Rule to consider H.R. 5617, Coast Guard authorization bill. Yes. Passed 394-1.

(187) H.R. 5617. Bill to authorize \$2.6 billion in FY 1983 and \$2.8 billion in FY 1984 for the U.S. Coast Guard. Yes. Passed 348-25.

(189) H.R. 5228. Bill to implement the Convention on the Physical Protection of Nuclear Material by designating as a federal crime actual or attempted unlawful use, possession or transfer of nuclear material. Yes. Passed 396-9.

(192) H.R. 6030. Department of Defense authorization act for FY 1983. Amendment to reduce the authorization for the Trident submarine program by \$699 million. Yes. Passed 344-65.

(193) H.R. 6030. Amendment to reduce Army, Navy and Air Force procurement authorizations by \$2.07 billion. Yes. Passed 406-6.

(194) H.R. 6030. Amendment to reduce the Department of Defense operation and maintenance authorization by \$398.5 million. Yes. Passed 386-19.

(195) H.R. 6030. Amendment to provide for a \$125 billion defense budget rather than the \$180.3 billion provided by the Armed Services Committee. It would have deleted funding for the MX missile, B1 bomber, Pershing II missile, binary chemical weapons, nuclear aircraft carrier and other weapons systems. No. Failed 55-348.

(197) H.R. 6030. Amendment to restrict expenditure of MX missile basing system funds until the President reports to Congress on the type of system to be deployed. Yes. Passed 212-209.

(198) H.R. 6030. Amendment to reduce by \$860 million procurement funds for strategic airlift aircraft, other than the KC-10 aircraft for the Air Force. No. Failed 74-344.

(199) H.R. 6030. Amendment to authorize procurement of commercial cargo aircraft (747's) in lieu of C-5 aircraft for the Air Force. Yes. Failed 127-289.

(200) H.R. 6030. Amendment to delete \$549.6 million for procurement of the Pershing II missile for the Army. No. Failed 74-311.

(202) H.R. 6030. Amendment to prohibit use of authorized funds for procurement of binary chemical munitions or for production facilities for such. No. Passed 232-181.

(203) H.R. 6030. Amendment to prohibit use of authorized funds for binary chemical weapons unless for each new binary chemical weapon produced, an equivalent number of unitary chemical munitions from the existing arsenal be rendered permanently useless for military purposes, and to express the sense of Congress that the President should promote negotiations for a treaty on chemical weapons. Yes. Failed 192-225.

(204) H.R. 6030. Amendment to delete \$54 million authorized for production of binary chemical weapons. No. Passed 251-159.

(206) H.R. 6030. Amendment to delete \$4 billion authorized for the B-1 bomber. No. Failed 142-257.

(207) H.R. 6030. Amendment to delete \$6.87 billion provided for the procurement of two CVN nuclear aircraft carriers. No. Failed 83-303.

(208) H.R. 6030. Amendment to delete \$10.5 billion for nuclear weapons programs including the Trident submarine, Trident I missile, sea-launch cruise missile, air-launch cruise missile, ground-launch cruise missile, Pershing II missile, B-1 bomber and MX missile. No. Failed 21-355.

(212) H.Res. 529. Rule to consider H.R. 5427; bill to authorize support to Radio Broadcasting to Cuba, Inc. Yes. Passed 254-22.

(219) H.R. 6030. Amendment to permit divorce courts to award former spouses of armed forces members a portion of entitlements relating to military retirement, survivors benefits and health benefits; requiring that former spouses must be married to the armed forces member for at least 10 years and providing for termination of the payments if the former spouse remarries before age 60, and reaffirming state community property laws. Yes. Passed 332-74.

(220) H.R. 6030. Amendment to extend for one year the Defense Logistics Agency test program that provides for a price differential to firms located in labor surplus areas on contracts not involving weapons. No. Passed 237-170.

(221) H.R. 6030. Amendment to provide that in order to receive federal educational assistance, a person must prove to the educational institution that he has registered for the draft, or complete such registration at the time of applying for assistance. No. Failed 161-241.

(222) H.R. 6030. Amendment to prohibit persons in violation of the Draft Registration Act from receiving any financial assistance under Title IV of the Higher Education Act. Yes. Passed 303-95.

(226) H.R. 6030. Amendment to reduce civil defense funding by \$108 million. No. Failed 163-240.

(227) H.R. 6030. Amendment to delete \$336.7 million from the research, development, test, and evaluation authorization for the Trident II missile, \$26 million from the title I authorization for the production of equipment for carrying the Trident II missile on the Trident submarine, and add \$26 million for the procurement of the AXE anti-air base missile. No. Failed 89-312.

(228) H.R. 6030. Amendment to reduce by 50 percent over the next four years the number of military personnel stationed abroad. No. Failed 87-314.

(230) H.R. 6030. Amendment to an amendment to reduce defense spending by 1 percent across-the-board instead of the amendment language of 5 percent across-the-board. Yes. Passed 238-136.

(231) H.R. 6030. Amendment to reduce the defense authorization by 1 percent across-the-board. Yes. Passed 235-135.

(232) H.R. 6030. On passage of the defense authorization act for FY 1983 authorizing appropriations of \$175 billion. Yes. Passed 290-73.

(234) S. 2248, defense authorization act for FY 1983. Motion to close the conference meetings on the bill to the public when classified national security information is under consideration. Yes. Passed 372-0.

(238) H.R. 5427, bill to authorize establishment of a radio broadcasting program to Cuba (Radio Marti). Amendment to require the Federal Communications Commission in consultation with the Department of Commerce to determine which frequencies would be used if AM frequencies were authorized for Radio Marti. No. Failed 136-244.

(248) H.J.Res. 521, resolution calling for a mutual and verifiable freeze on and reductions in nuclear weapons and for approval of the SALT II agreement. Amendment stating that a verifiable freeze on the testing, production and further deployment of nuclear weapons is not an end in and of itself but a logical first step toward achieving nuclear arms reductions. Yes. Passed 323-84.

(249) H.J.Res. 521. Amendment as a substitute resolution to express the support of Congress for the U.S. and the Soviet Union to engage in substantial, verifiable, equitable and military significant reductions of their nuclear weapons, resulting in equal and sharply reduced force levels which would contribute to peace and stability. Yes. Passed 204-202.

(250) H.J.Res. 521. Motion to recommit the nuclear freeze resolution to the Committee on Foreign Affairs. No. Failed 175-229.

(251) H.J.Res. 521. On passage of the amended nuclear freeze resolution calling for mutual reductions in nuclear weapons before achieving a freeze at substantially reduced levels. Yes. Passed 273-125.

(292) H.R. 5540, Defense Industrial Base Revitalization Act. Amendment to assure that funds to support the new defense-related vocational education and higher education equipment programs would not come from funds authorized for ongoing federal education and training programs. No. Passed 242-180.

(297) S. 2248. To agree to the conference report on the bill authorizing \$177.9 billion for defense programs for FY 1983. Yes. Passed 251-148.

(304) H.R. 6968, military construction appropriations for FY 1983. Amendment to reduce by 30.8 percent each appropriation for any account, activity, or project in the bill. No. Failed 34-322.

(305) H.R. 6968. On passage of the bill to appropriate \$7 billion for military construction for FY 1983. Yes. Passed 325-31.

(353) H.R. 6317. Bill to revise the manner in which the Oct. 1, 1982, pay increase for members of the uniformed services is to be determined and to make adjustments in military personnel and compensation programs. No. Failed 214-186 under suspension of rules.

(368) H.R. 5540, defense production act. Amendment to strike all Davis-Bacon wage law provisions in the bill. Yes. Failed 162-189.

(369) H.R. 5540. Amendment to prohibit the extension of any loan or loan guarantee unless the Treasury determines that such will not increase interest rates and will not adversely affect the thrift industry. Yes. Passed 173-154.

(423) H.R. 7355, defense appropriations for FY 1983. Amendment to delete all funds (\$988 million) in the bill for the procurement of the MX missile. No. Passed 245-176.

(424) H.R. 7355. Amendment to prohibit use of funds by the CIA or DOD to overthrow the government in Nicaragua or provoke a war between Nicaragua and Honduras. Yes. Passed 411-0.

(425) H.R. 7355. On passage of the bill making appropriations of \$231 billion in new budget authority for the Department of Defense for FY 1983. Yes. Passed 346-68.

(43) H.Res. 413. Resolution to express the sense of the House emphasizing and reaffirming the House's right and decision to establish a chaplain and open the daily sessions of the House with prayer. Yes. Passed 388-0.

(47) H.Res. 378, resolution to provide funding for House committees in the 2nd session, 97th Congress. Amendment as a substitute to reduce funding for House committees by \$700,000 and provide the same authorization for House committees as was provided in 1981. Yes. Passed 416-0.

(48) H.Res. 378. Motion to recommit the committee funding resolution to the Committee on House Administration. Yes. Failed 148-270.

(49) H.Res. 378. On passage of the amended resolution to authorize \$39.6 million for committees and the House Information Systems for the 2nd session, 97th Congress. No. Passed 282-132.

(50) S.Con.Res. 78. Resolution providing for an adjournment of the Senate on April 1 or 2 to April 13, 1982, and an adjournment of the House from April 6 to April 20, 1982. No. Passed 209-173.

(479) H.Res. 621. Resolution to amend the Rules of House of Representatives to establish an Office for the Bicentennial of the House of Representatives. Yes. Passed 230-97.

(272) H.R. 5595, federal payments to the District of Columbia. Amendment that requests at least \$14.3 million of the funds provided by the bill to be used to eliminate any deficits in the D.C. Teachers, Police Officers and Fire Fighters Retirement Funds. Yes. Passed 221-181.

(273) H.R. 5595. On passage of the bill to increase the authorization for the annual federal payment to the District of Columbia from \$336.6 million to \$361 million beginning in FY 1983. Yes. Passed 279-122.

(52) H.R. 5789, bill to amend the Energy Policy and Conservation Act. Amendment to provide a two-month extension of the antitrust immunity.

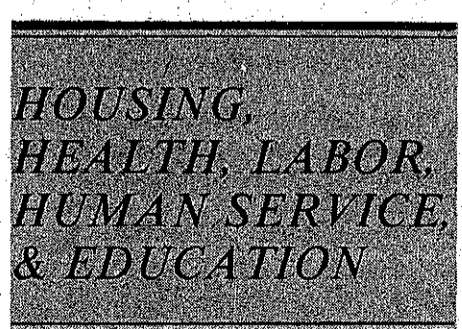

### LYNN STREET RAMP OPENED

Access to I-66 from the Lynn Street ramp in Rosslyn, which connects Lee Highway to the portion of I-66 leading to the Roosevelt Bridge, has also been the subject of controversy and commuter inconvenience. When I-66 opened, Virginia highway officials said that ramp would be restricted to HOV traffic.

I agreed with scores of constituents who contacted our office that the Lynn Street ramp, which leads to a portion of I-66 which has been opened for years, should not be restricted. When state troopers issued notice they would begin writing \$45 tickets to noncomplying commuters, I contacted Governor Robb on Jan. 5. He agreed to extend the grace period on the ramp for several days. Then following my con-

and the tremendous back-ups which would occur on the GW Parkway if the ramp were restricted, further aggravating the already congested traffic situation on the parkway, especially at Spout Run.

I was pleased that the FHWA agreed to my request and announced on Dec. 20 that the parkway ramp to the bridge would remain open for all traffic without restriction.

tinued lobbying efforts with the governor and state highway officials, the state highway commissioner announced on Jan. 7 that the restrictions on the Lynn Street ramp had been lifted and it would be open to all traffic at all times.

That decision was based in part on the Federal Highway Administration decision to keep the GW parkway ramp to Roosevelt Bridge open to all traffic. Virginia officials qualified the Lynn Street announcement, however, that if future traffic conditions on the Roosevelt Bridge require restricted access at Lynn Street, HOV restrictions will be reinstated. I oppose such reimposition and will work to keep the ramp open because access to the bridge from that ramp saves commuting time and eases travel into Washington.

The calls my office received from scores of 10th District citizens helped make strong cases to highway officials to lift the Lynn Street restrictions and to keep the GW Parkway ramp unrestricted. These are examples of what people working together can accomplish and I am committed to working to assure these access routes to I-66 remain available, that a fair assessment be given to changing the HOV requirements on I-66, and to solving other local transportation problems.

### ROSSLYN DECKING WORK CONTINUES

Still to be completed on the I-66 project are the deck and park plaza to be built over the highway in Rosslyn. Late last October, I worked with Virginia highway and Arlington County officials and Rosslyn business and citizen groups in successfully appealing to the Federal Highway Administration for the use of interstate construction funds to complete this project.

Our appeal was based on the fact that the decking and plaza are needed to lessen the impact of I-66 through Arlington and make the highway more compatible with the community and the project should be eligible for the construction funding. After reconsideration the FHWA agreed. The

Rosslyn Pedestrian Park Plaza project will include landscape plantings, fountains and benches and provide people living and working in Rosslyn an attractive park-like setting for their community.

### CLARIFICATION

My December 1982 special report on the opening of I-66 contained a cost figure for the interstate which may have been confusing. The \$22.9 million cost as reported then is for the traffic management system for the 10.1 mile portion of I-66 from the Beltway to the Roosevelt Bridge. The total cost for that section of I-66 is \$285 million.
