

Fourth Series of CCEs Reflects New Law

The Catalog of Copyright Entries covering registrations during and since 1978 will be issued in a new series. This new Fourth Series will reflect changes made as a result of the Copyright Act (title 17 of the United States Code).

EXPLANATION OF THE CHANGES
The Catalog will change from 14

The Catalog will change from 14 parts to the 8 parts listed below. Parts 1 and 3 will be published quarterly (i.e., in numbers 1 through 4); all other parts, semi-annually (i.e., in numbers 1 and 2). Arrangement within each part will be alphabetical by title, with an index of authors and claimants.

Part 1.
Nondramatic Literary Works.
(All material registered in Class TX except serials and periodicals.)

Part 2. Serials and Periodicals.

Part 3.
Performing Arts.
(All material registered in Class PA except motion pictures and filmstrips.)

Part 4.

Motion Pictures and
Filmstrips.

Part 5.

Visual Arts.

(All material registered in Class VA except maps.
Includes pictorial, graphic, and sculptural works.)

Part 6. Maps.

Part 7. Sound Recordings.

Part 8. Renewals.

ISBD (International Standard Bibliographic Description) format will be used in the descriptive portion of each entry, which will include available ISBNs and ISSNs (International Standard Book and Serial Numbers). Essential copyright data will be given in a statement following each descriptive entry.

Unpublished as well as published materials will be included in the first seven parts.

Orders for individual numbers, subscriptions for one or more parts, or subscriptions for the complete Catalog should be sent to the Superintendent of Documents, U.S. Government Printing Office, Washington, D.C. 20402. Prices were formally established by law. Beginning with the Fourth Series, the Superintendent of Documents is authorized to determine prices annually. Prices for the 1978 Catalogs are shown below.
