# NEW COMPENDIUM OF PRACTICES

The Copyright Office has issued Compendium II, a new *Compendium of Copyright Office Practices* under the copyright law which became effective January 1, 1978, including title 17 of the U.S. Code and amendments.

Compendium II contains approximately 500 pages, including an index, and is a manual intended primarily for the use of the staff of the Copyright Office as a general guide to its examining and related practices. It is reproduced from typescript on letter-size paper appropriate for maintenance in looseleaf form.

Copies of Compendium II may be purchased from the Superintendent of Documents, U.S. Government Printing Office, by using the attached Order Form. The price for each copy is \$51.00, including postage to any point in the United States, and \$63.75 for each copy mailed outside the United States. Current prices are subject to change without notice.

Amendments and supplements may be made and will be issued in the form of additional or replacement pages as changes are made. Such issuances will automatically be mailed free of charge to those who have purchased Compendium II from the Superintendent of Documents.

Compendium I, issued to reflect the Copyright Office practices under the Copyright Act of 1909 as amended, still applies to Copyright Office actions where provisions of that act are dispositive. Copies may be purchased from the National Technical Information Service (NTIS), U.S. Department of Commerce, 5285 Port Royal Road, Springfield, Virginia 22161. The price is \$16.50 for a paper copy and \$4.00 for microfiche; current prices are subject to change without notice. The NTIS Accession number for Compendium I is PB82 172032.
