UNANIMOUS CONSENT AGREEMENT
Ronald Kirk (Cal. No. 24)

Ordered, That upon the conclusion of morning business, on Wednesday, March 18, 2009, the Senate proceed to executive session to consider the nomination of Ronald Kirk, of Texas, to be United States Trade Representative, with the rank of Ambassador Extraordinary and Plenipotentiary; that there be up to 90 minutes of debate with respect to the nomination, with the time divided as follows: 30 minutes under the control of the Majority and 60 minutes under the control of the Republicans; that upon the use or yielding back of time, the Senate proceed to vote on confirmation of the nomination; that upon confirmation, the motion to reconsider be laid upon the table; no further motions be in order; the President be immediately notified of the Senate's action, and the Senate resume legislative session.
