Jeffrey L. Viken (Cal. No. 422)

Ordered, That at 4:30 p.m. on Tuesday, September 29, 2009, the Senate proceed to executive session to consider the nomination of Jeffrey L. Viken, of South Dakota, to be United States District Judge for the District of South Dakota; that there be 60 minutes of debate, with the time equally divided and controlled between the Chairman of the Committee on the Judiciary and the Ranking Member or their designees; that at 5:30 p.m. the Senate proceed to vote on confirmation of the nomination; that upon confirmation, the motion to reconsider be made and laid upon the table; that the President be immediately notified of the Senate's action, and the Senate resume legislative session.
