UNANIMOUS CONSENT AGREEMENT

Irene Cornelia Berger (Cal. No. 470)

Ordered, That upon the conclusion of Morning Business on Tuesday, October 27, 2009, the Senate proceed to executive session to consider the nomination of Irene Cornelia Berger, of West Virginia, to be United States District Judge for the Southern District of West Virginia; that debate be limited to 60 minutes equally divided and controlled between the Senator from Vermont (Mr. Leahy) and the Senator from Alabama (Mr. Sessions) or their designees, with the 5 minutes immediately prior to the vote be available to the Senator from West Virginia (Mr. Byrd); that at 2:20 p.m., the Senate proceed to vote on confirmation of the nomination, that upon confirmation, the motion to reconsider be laid on the table, the President be immediately notified of the Senate's action and the Senate resume legislative session.
