WORK HANDLED BY UNITED STATES ATTORNEYS' OFFICES
DURING FISCAL YEAR 1968

CRIMINAL CASES

FILED - Criminal filings amounting to 32,528 showed a decrease of 1,457 or 4.2 per cent from the number filed in the previous fiscal year. About 74.9 per cent of the total was in 15 offenses having 500 or more cases; 5 showed increases while 10 showed decreases. The largest increases occurred in Selective Service (1306 to 1754), Bank Robbery (1016 to 1169), Narcotics (2636 to 3018), Counterfeiting and Forgery (1936 to 1964) and National Motor Vehicle Act dropped from 4742 to 4272 and Income Tax from 782 to 684. Increases took place in 37 districts ranging from 208 in California Eastern to 1 in Guam. Decreases took place in 56 districts ranging from 395 in Texas Western to 2 in Utah.

TERMINATED - Cases terminated decreased 272 or .09 per cent under the previous year's total. Of the total of 30,961 closed, 19,085 involving 22,826 defendants were by pleas of guilty, 2,943 (involving 3,834 defendants) were found guilty after trial and 927 (involving 1,360 defendants) not guilty, includes not guilty verdicts by reason of insanity.

PENDING - With 17,119 cases, the pending caseload showed an increase of 10.07 per cent over 15,552* cases pending at the close of fiscal year 1967. Of the pending cases 8,765 cases were awaiting arraignment in court or trial, while 2,214 were awaiting court decision or sentence. 2,553 were in a fugitive or other status beyond the control of the United States Attorney.

GRAND JURY PROCEEDINGS

Grand Jury proceedings, comprised of 18,569 indictments and 322 No True Bills, amounted to 18,891, a decrease of 1.6 per cent from the previous fiscal year.

CRIMINAL COMPLAINTS

RECEIVED - Complaints received decreased to 127,366; this is 3.5 per cent less than the 132,101 received in fiscal year 1967. Southern New York with 5,109 had the most complaints and Eastern New York with 4,959 and District of Columbia with 4,584 were the next highest. 85,278 of the complaints were in eleven offenses as shown below:

PENDING - Criminal Complaints pending as of June 30, 1968 rose to 22,452, an increase of 4,092 or 22.3 per cent over the 18,360 pending as of June 30, 1967.

CIVIL CASES

FILED - Civil cases filed amounted to 25,027, a decrease of 3,649 or 12.7 per cent under the previous year's total. 22 districts had increases, and 71 districts showed decreases from the previous year. 10,169 or 40.6 per cent of the total was in thirteen districts having filings ranging from 510 to 1,180. Tax Lien cases with 4,417 Tort cases with 2,070 and General Claims cases with 3,987 had 17.7, 8.3, and 15.9 per cent respectively of the cases filed.

TERMINATED - With 75 districts showing decreases, civil cases terminated dropped to 24,506. This total is under fiscal year 1967's total by 4,481 or 15.4 per cent. Decreases ranged from 312 in New York Eastern to 1 in Georgia Middle and Iowa Southern while increases ranged from 1 in Guam to 170 in Florida Middle.

1,459 of these cases were suits in which the government as defendant was sued for \$118,176,730. 777 of them involving \$52,582,301 were closed by compromises amounting to \$4,071,065 and 307 involving \$25,701,200 resulted in judgments against the government amounting to \$3,941,673. The remaining 375 cases involving \$39,893,229 were won by the government, thus bringing the savings to \$110,163,992, an increase of 25,571,812 or 30.2 per cent from the \$84,592,180 saved in Fiscal Year 1967.

PENDING - Civil cases pending as of the close of the fiscal year increased by 521 or 2.1 per cent to 24,484. 10,221 or 41.8 per cent of the caseload was in twelve districts with caseloads ranging from 1,376 in New York Southern to 610 in California Northern. Tax Lien cases with 3,981 decreased to 16.3 per cent of the total as compared to 4,090 or 16.7 per cent of the total pending as of June 30, 1967. Land cases with 1,837 or 8.2 per cent decreased from 1,841 or 7.5 per cent of the total.

CIVIL MATTERS

RECEIVED - 30,243 civil matters decreased 3,397 or 10.1 per cent from the 33,640 matters received in Fiscal Year 1967.

Tax Lien matters with 4,465 and Tort matters with 2,264 comprised 14.8 per cent and 7.5 per cent respectively of the total. Delegated General Claims matters amounted to 5,558 or 24.3 per cent of the total. 8,595 or 28.4 per cent of the total was in eight districts having totals ranging from 834 in District of Columbia to 1,343 in New York Southern.

TERMINATED - Civil matters terminated without reaching court dockets amounted to 6,824, an increase of 1.7 or 107 from the fiscal year 1967 total of 6,717.

PENDING - 8,086 civil matters were pending as of June 30, 1968 as compared to 9,469 as of June 30, 1967. This is a decrease of 1,383 or 14.6 per cent.

MAN-HOURS

A total of 213,750 man-hours were spent in court during Fiscal Year 1968. This is an increase of 31,000 or 16.9 per cent over Fiscal Year 1967. Following is a breakdown of those hours:

Based on an average employment of 691.8 each Assistant United States Attorney averaged 30.9 hours per month in courtroom work during the fiscal year. This compares with an averaged 27.5 hours per month in Fiscal Year 1967.

COLLECTIONS

Collections for Fiscal Year 1968 amounted to \$57,954,015, a decrease of \$22,265,400 or 27.7 per cent under the \$80,219,415 collected in Fiscal Year 1967. Fiscal Year 1968 declines are attributable to FHA and VA policy changes which emphasize rehabilitation of properties in financial difficulties rather than utilizing judicial foreclosure, e.g. 6 Districts (Arizona, Texas Northern, Florida Southern, Oregon, Ohio Northern and Texas Eastern) registered declines of \$23.1 million attributable to this policy change. This year's amount represents a return of \$2.73 for each dollar of the \$22,195,000 appropriated for United States Attorneys' Offices for the year ending June 30, 1968.

PERSONNEL

During the year United States Attorneys' employment averaged 1,807 employees, 365 employees were appointed and 282 were separated a net increase of 83 and 1,899 were on the rolls as of June 30, 1968. Cases handled per Assistant United States Attorney decreased from 149.7 in Fiscal Year 1967 to 140.3 in the current year while cases terminated decreased from 90.5 to 80.2.

CASES PENDING IN UNITED STATES ATTORNEYS' OFFICES

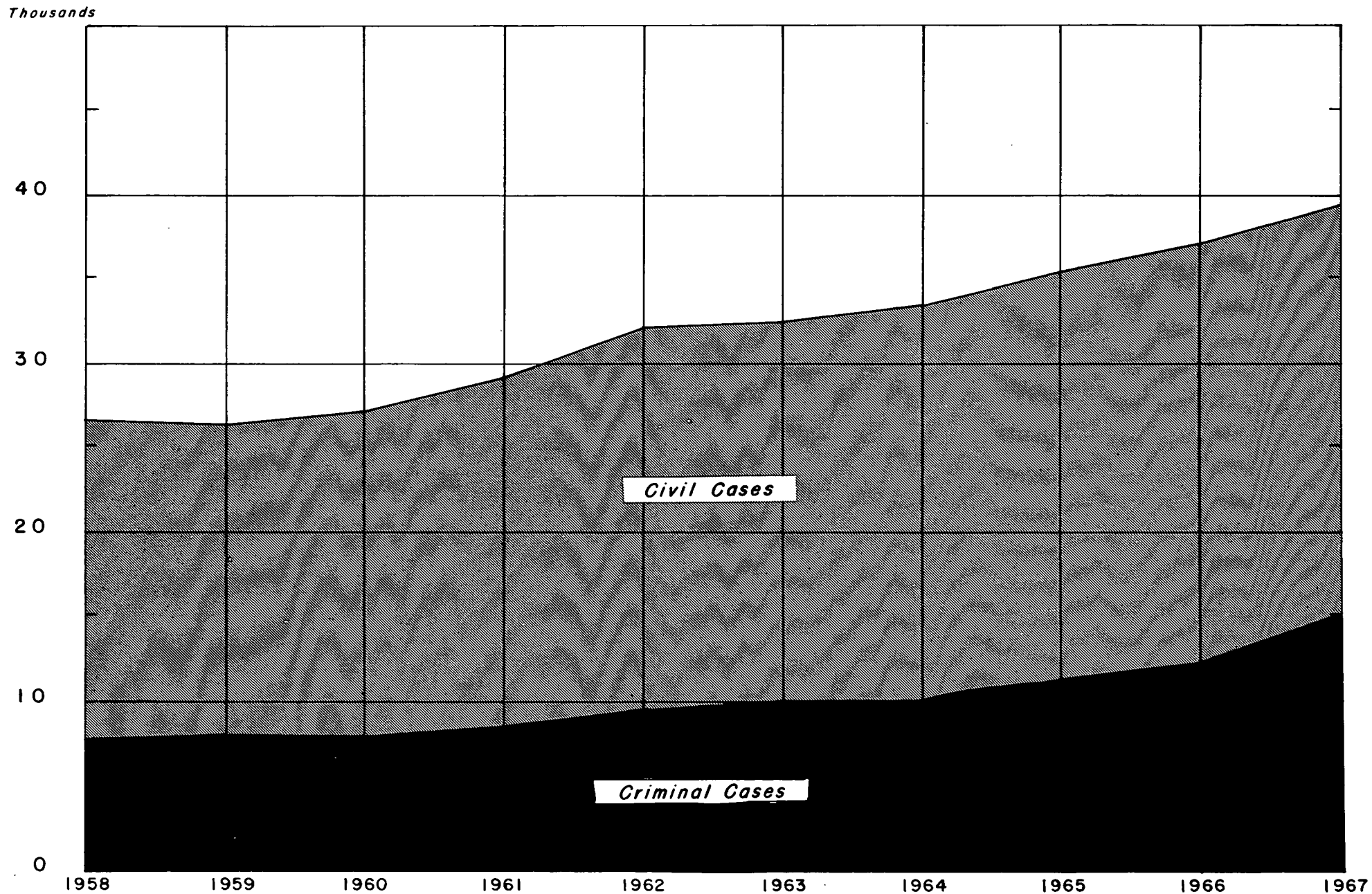

IN UNITED STATES ATTORNEYS' OFFICES

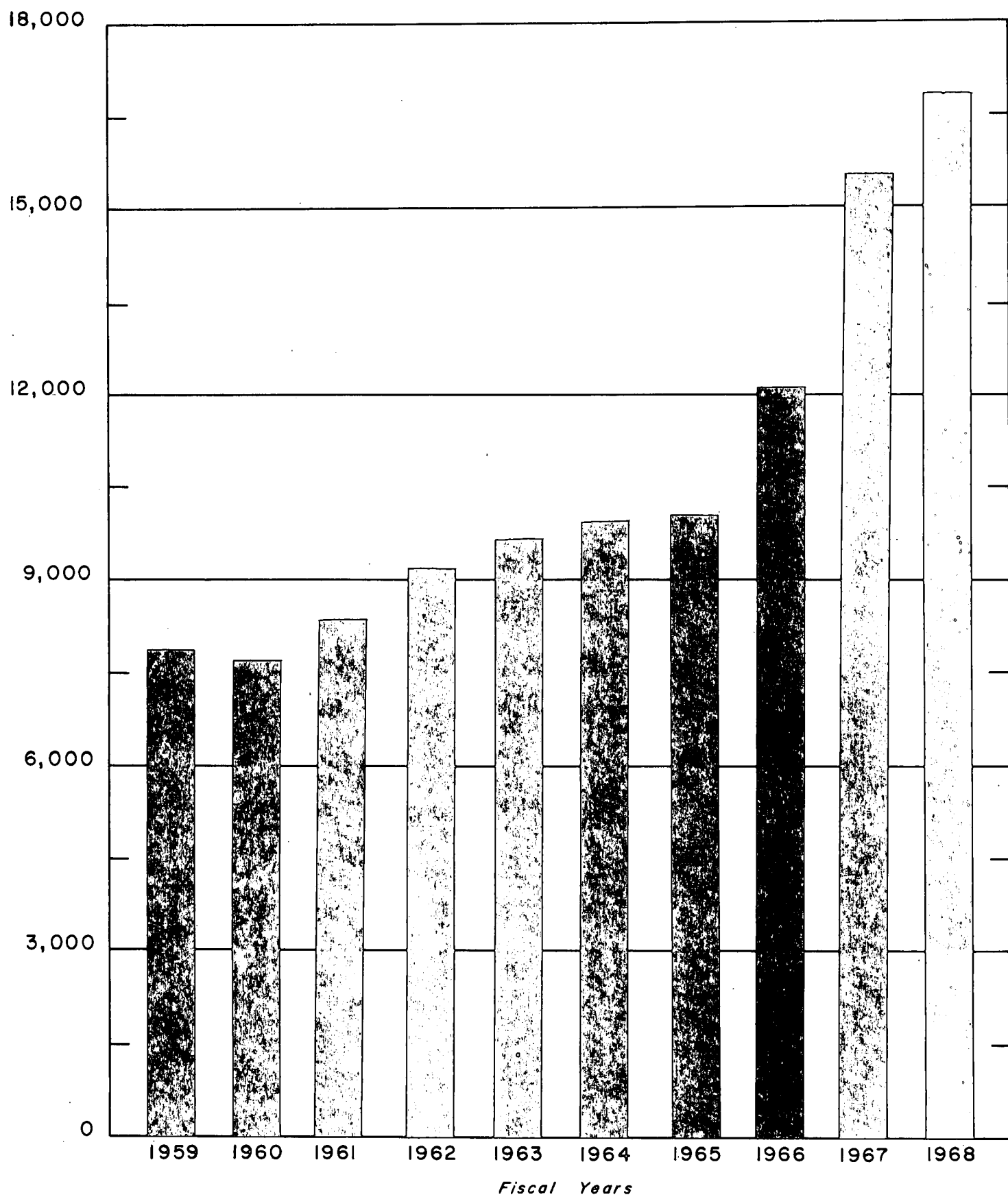

TOTAL 17,119 CASES

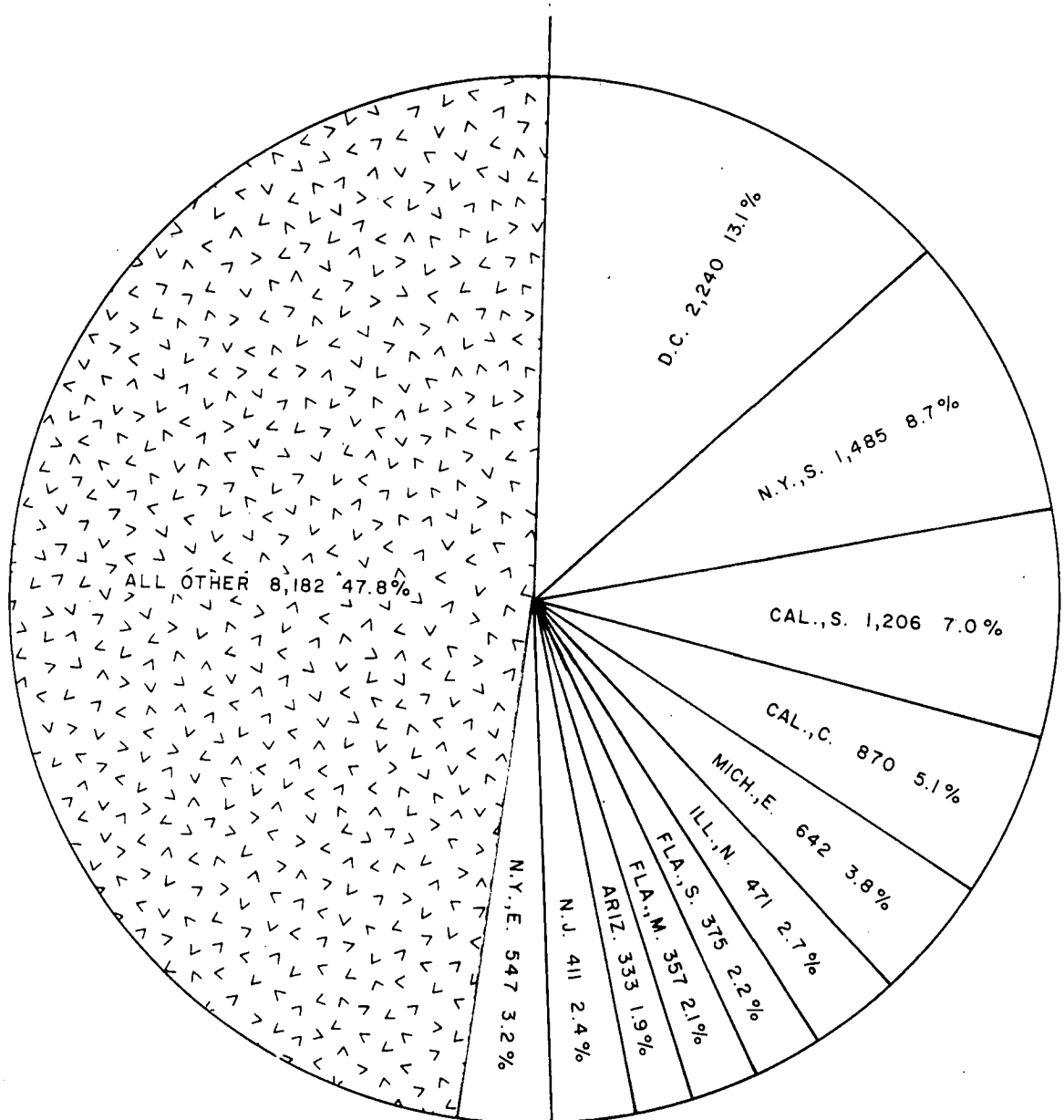

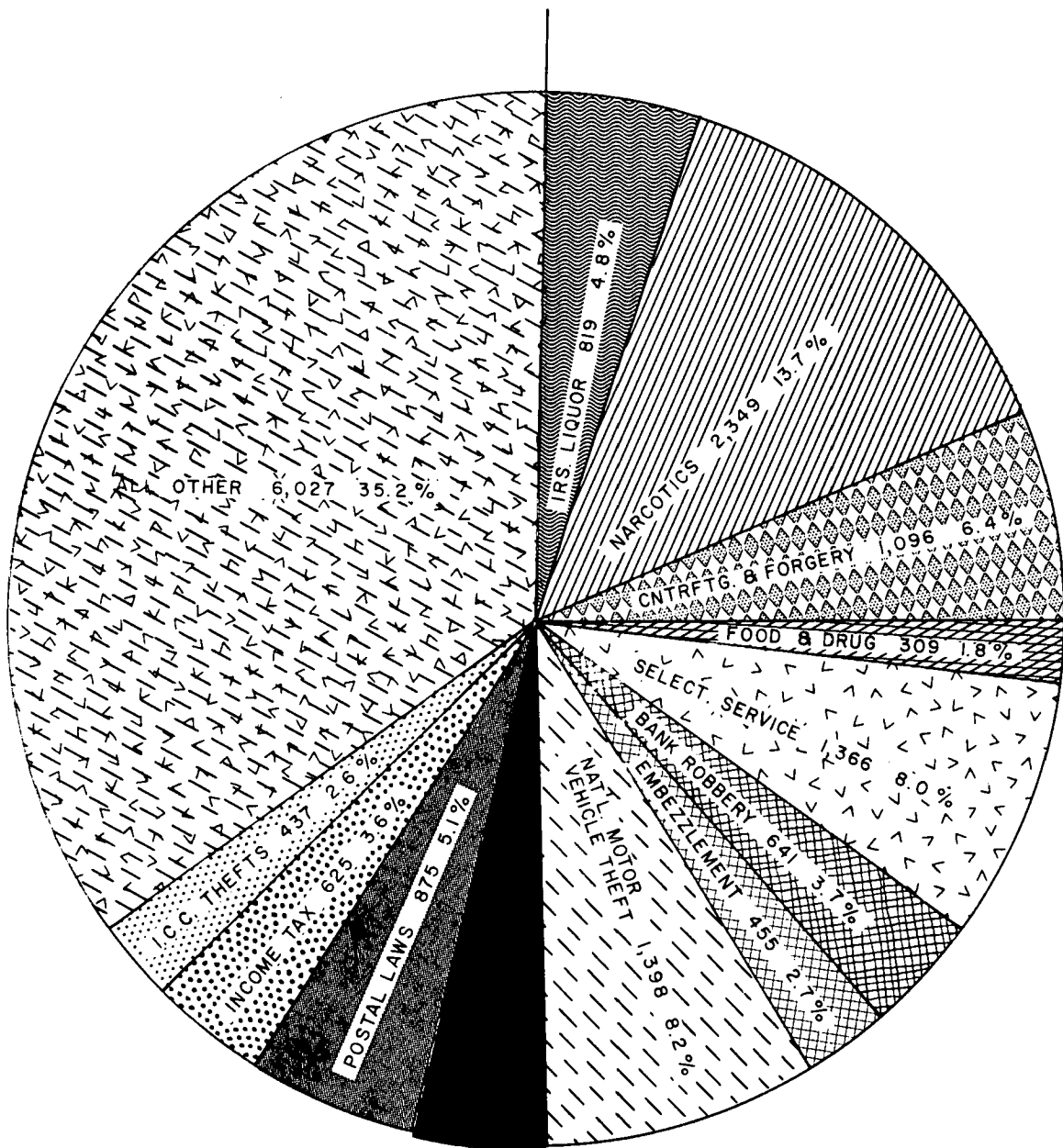

TOTAL 17,119 CASES

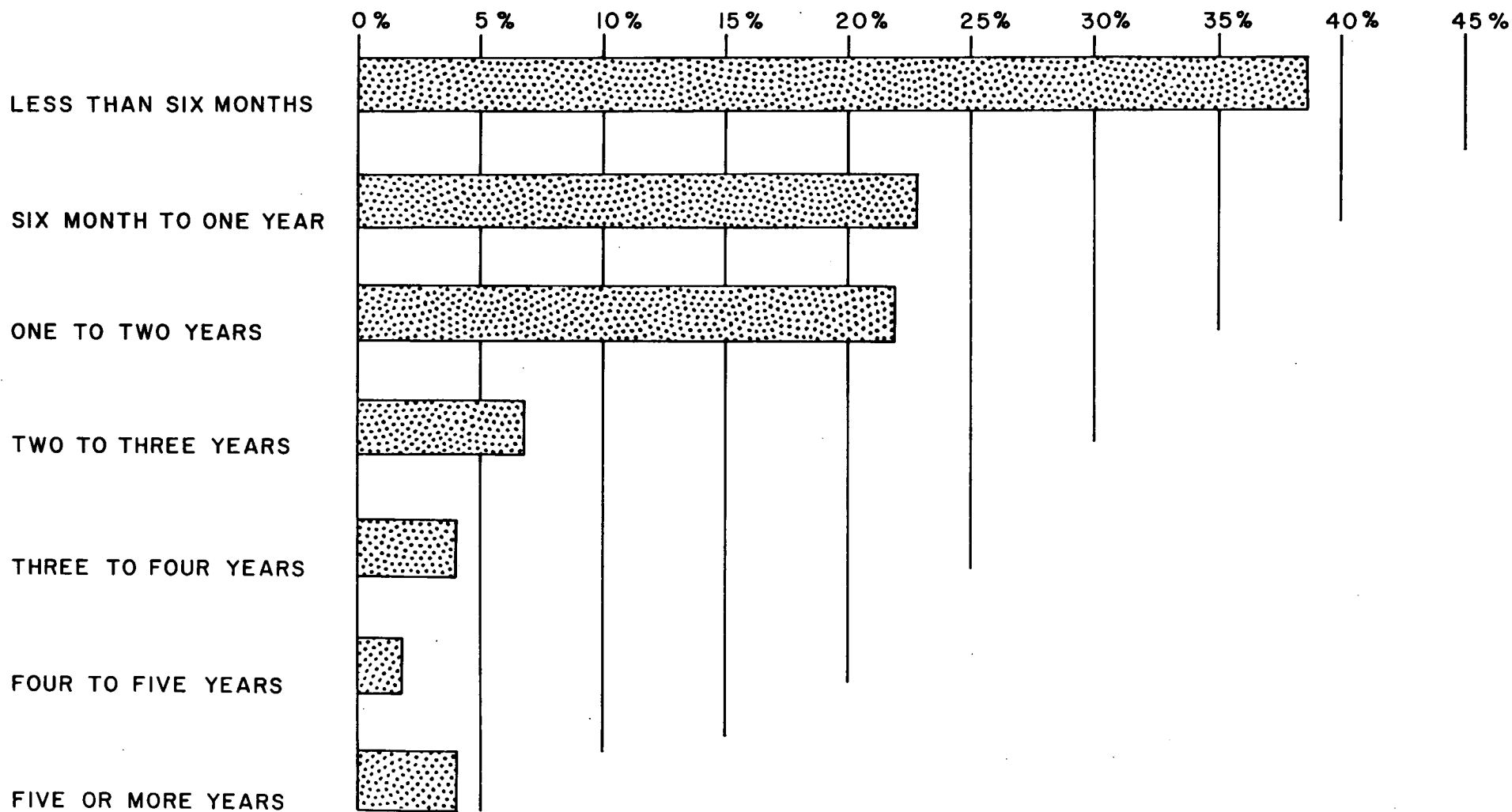


CHART NO. 6

IN UNITED STATES ATTORNEYS' OFFICES

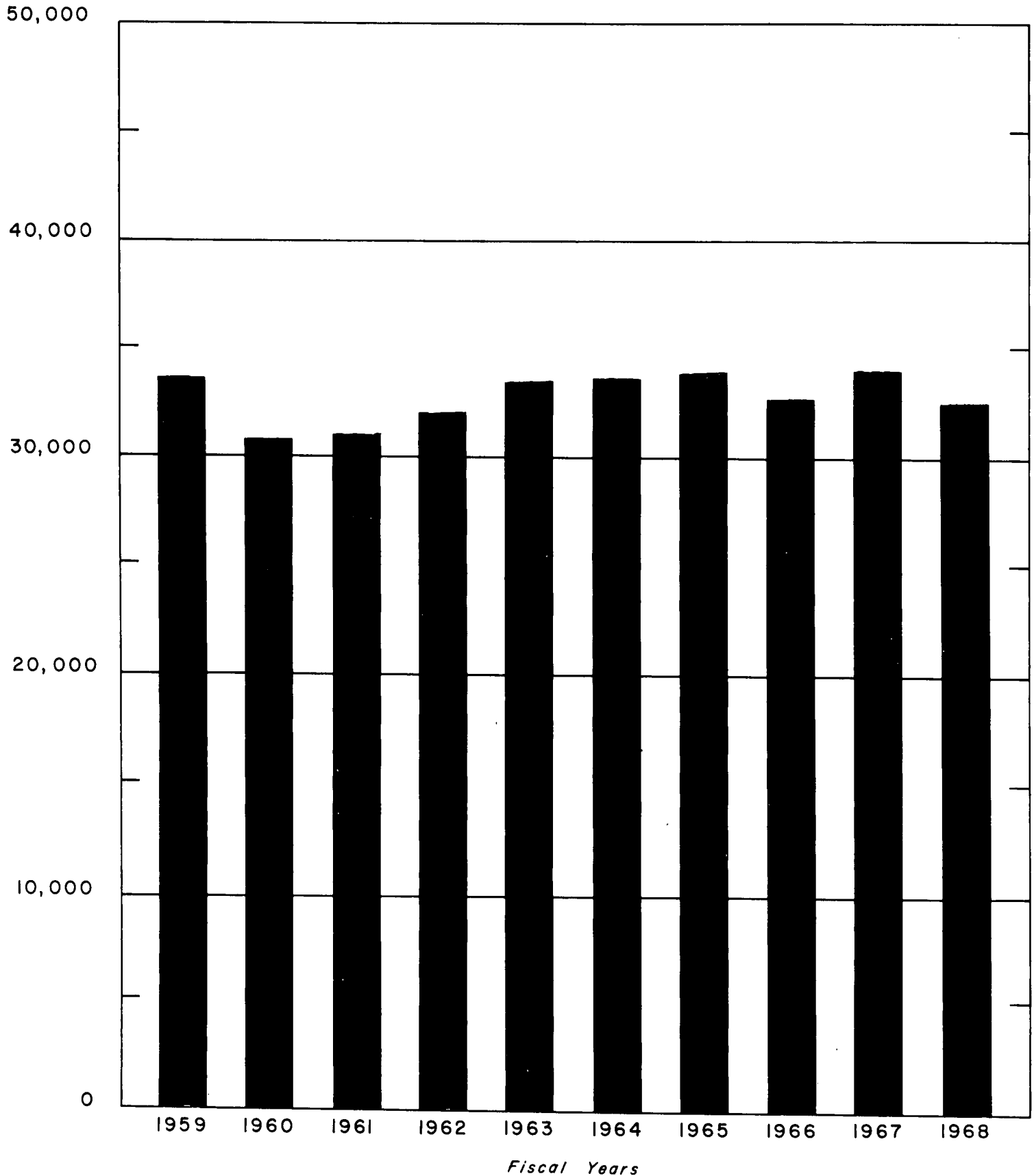

IN UNITED STATES ATTORNEYS' OFFICES

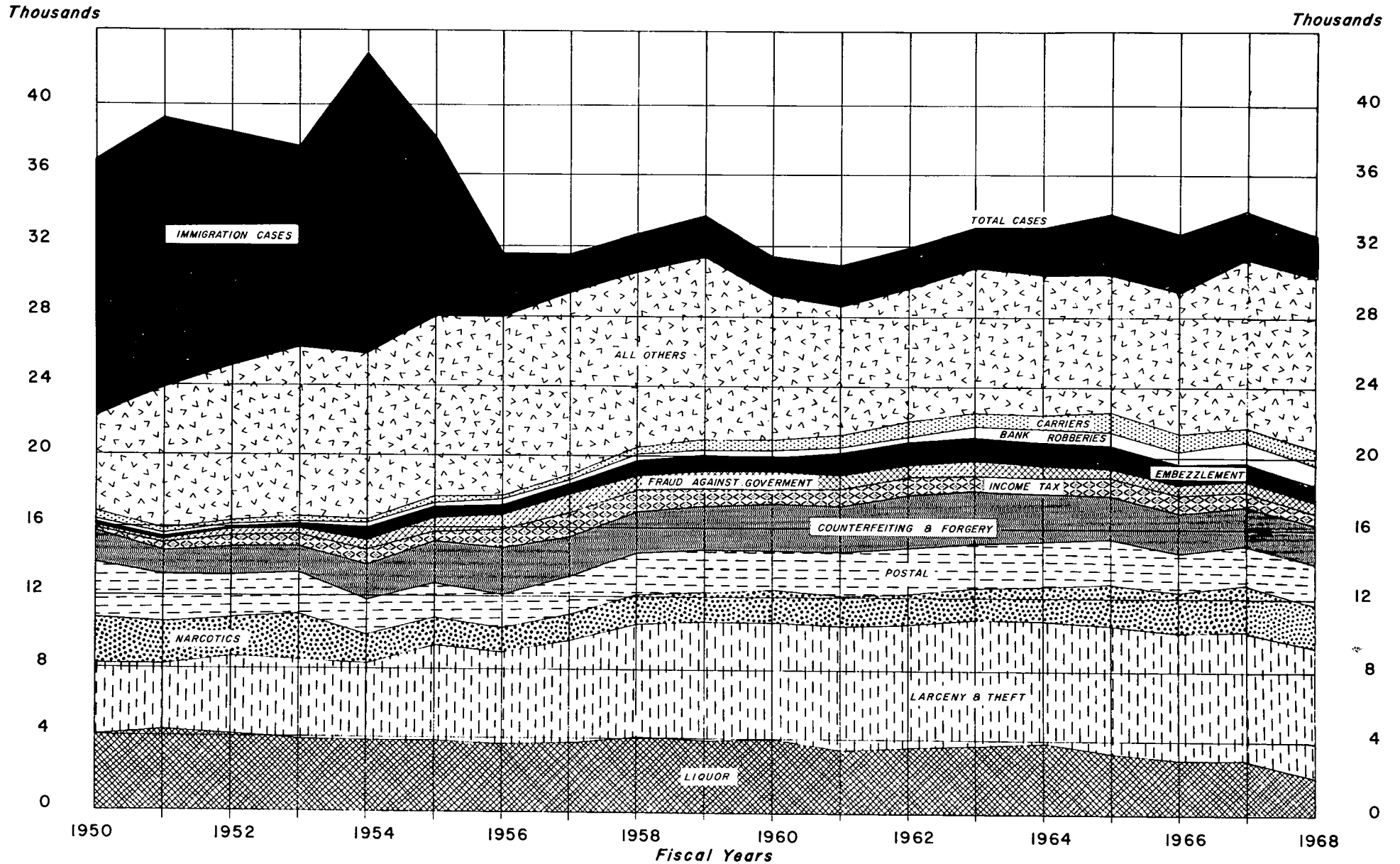

PROCEEDINGS BEFORE GRAND JURY IN UNITED STATES ATTORNEYS' OFFICES

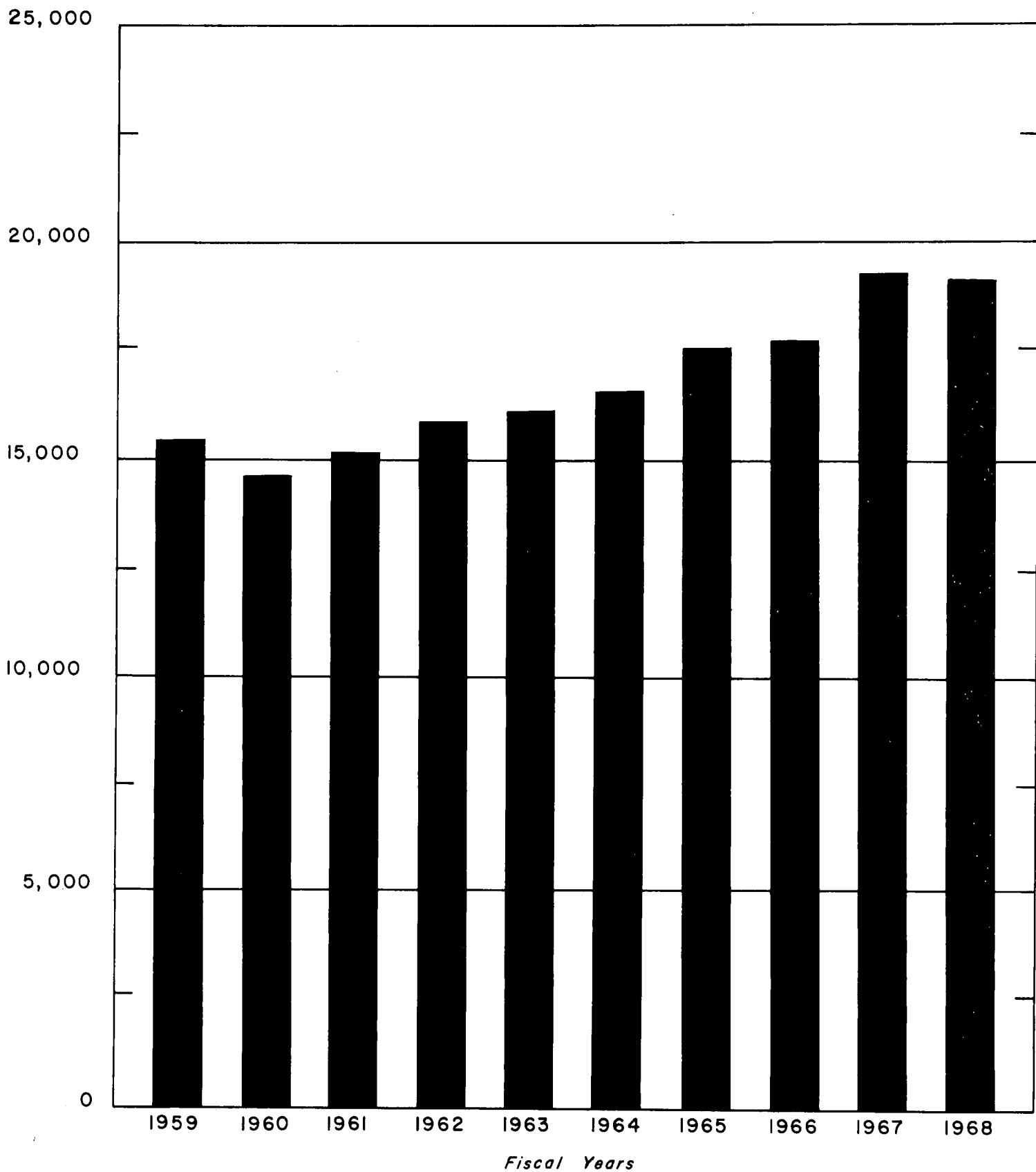

IN UNITED STATES ATTORNEYS' OFFICES

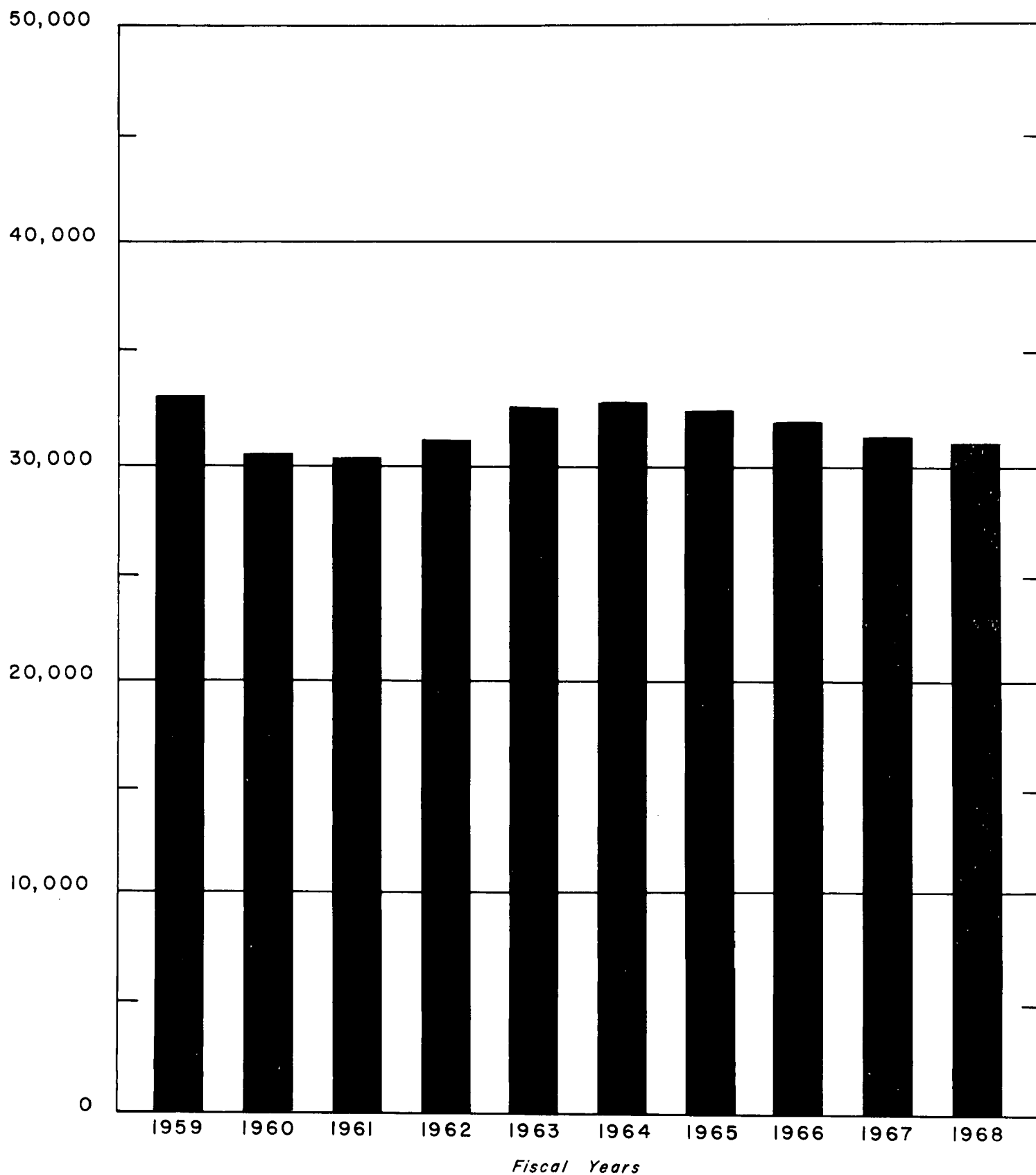

Fiscal Years

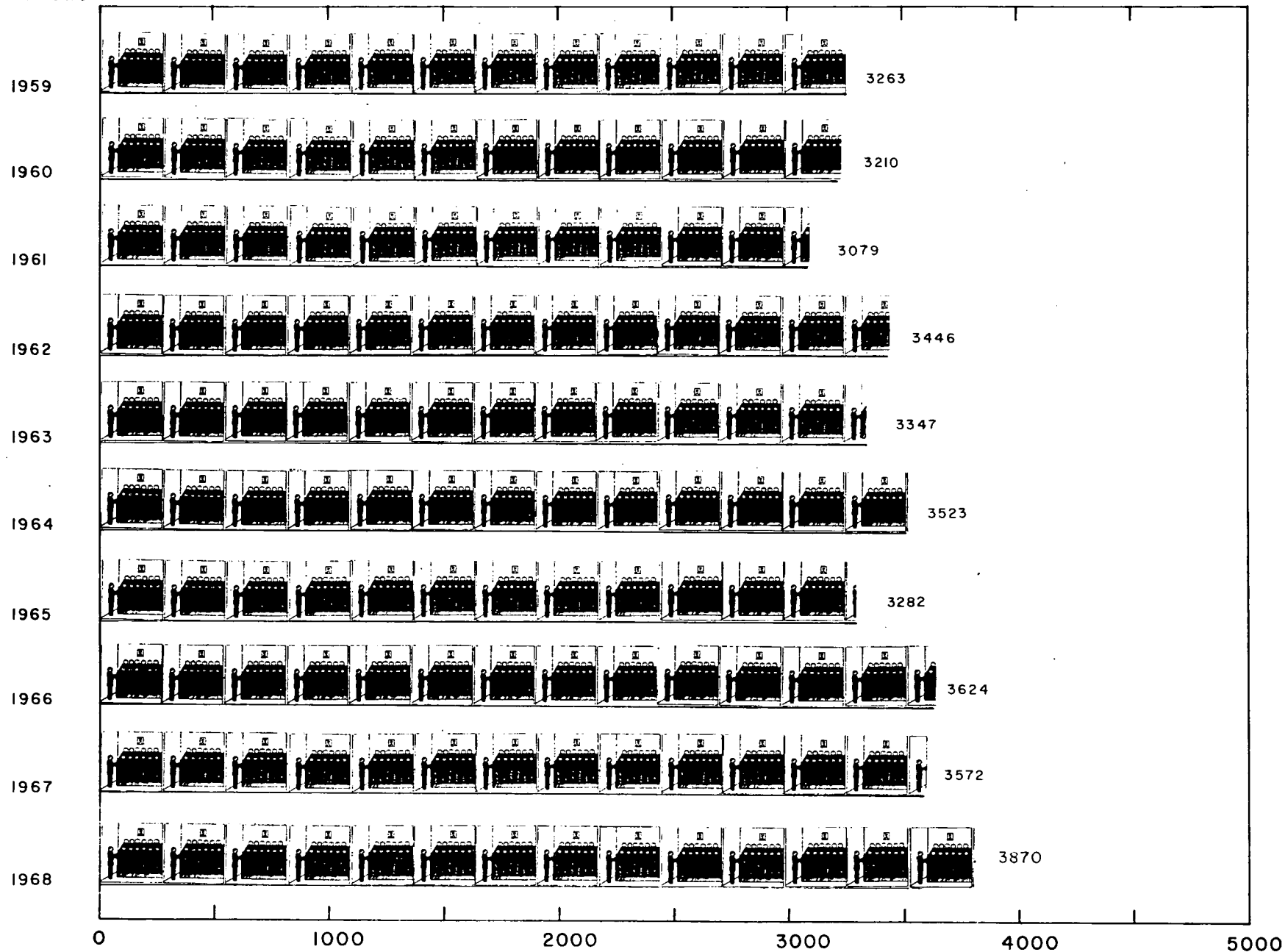

IN UNITED STATES ATTORNEYS' OFFICES

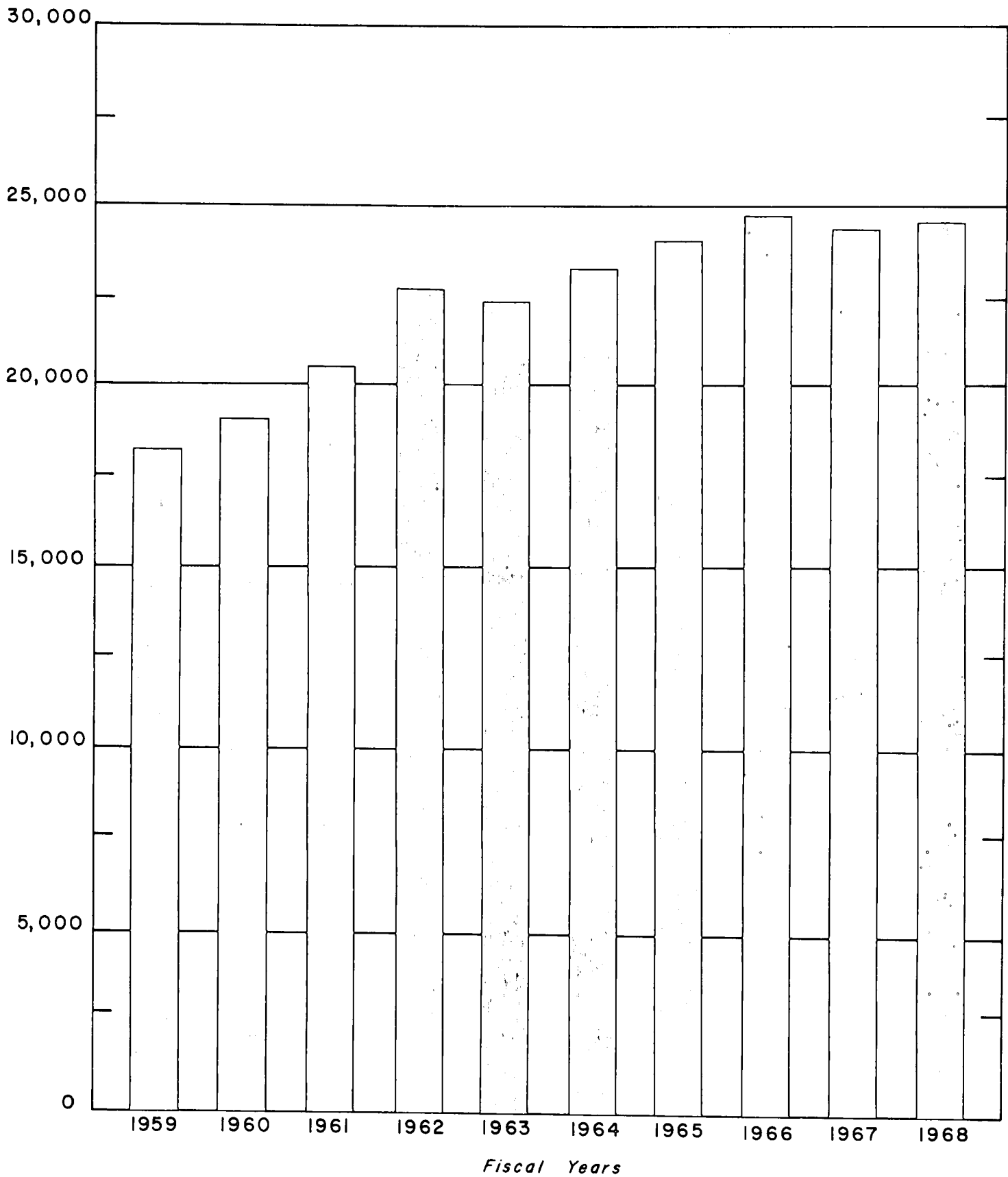

TOTAL 24,484 CASES

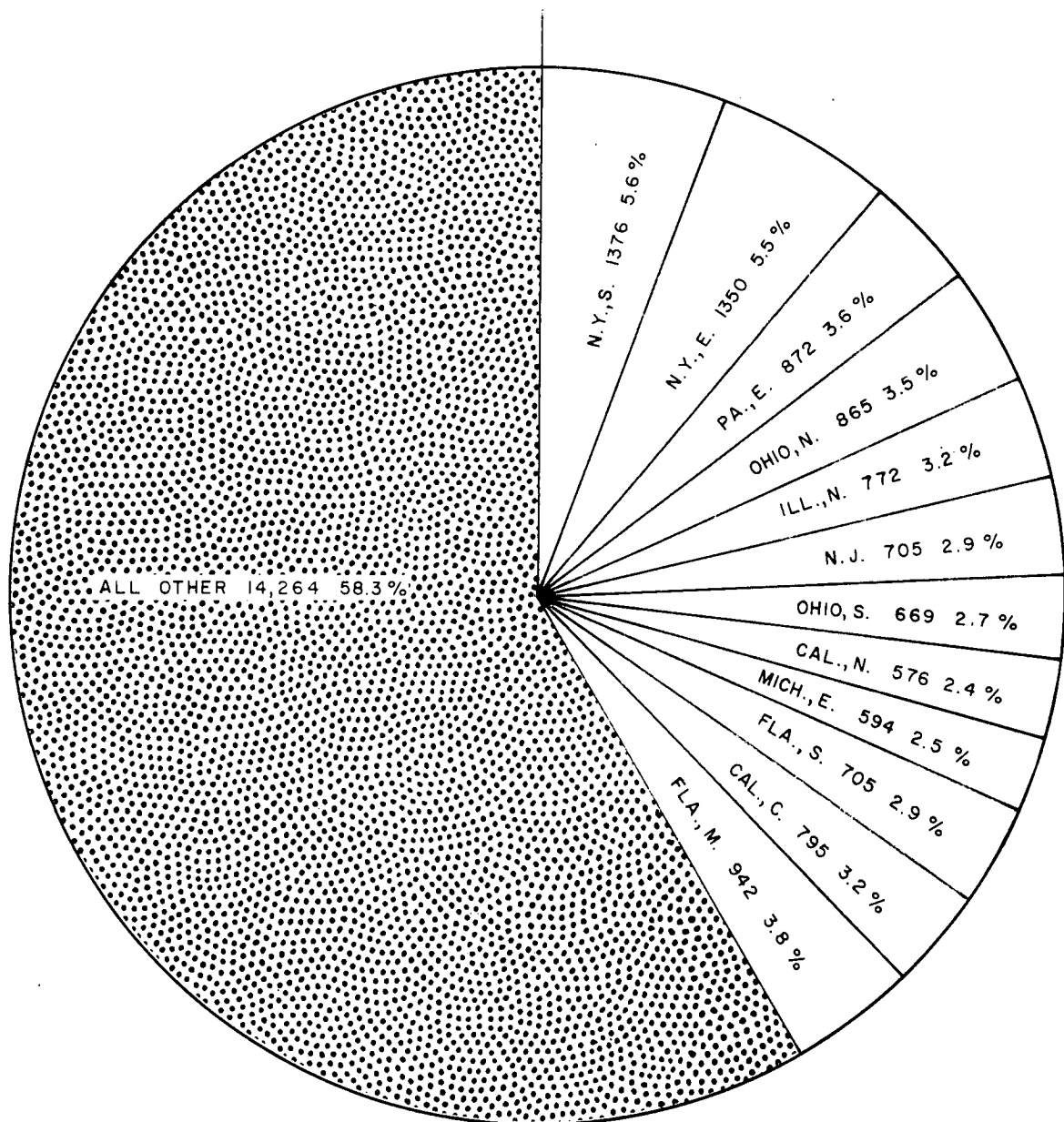
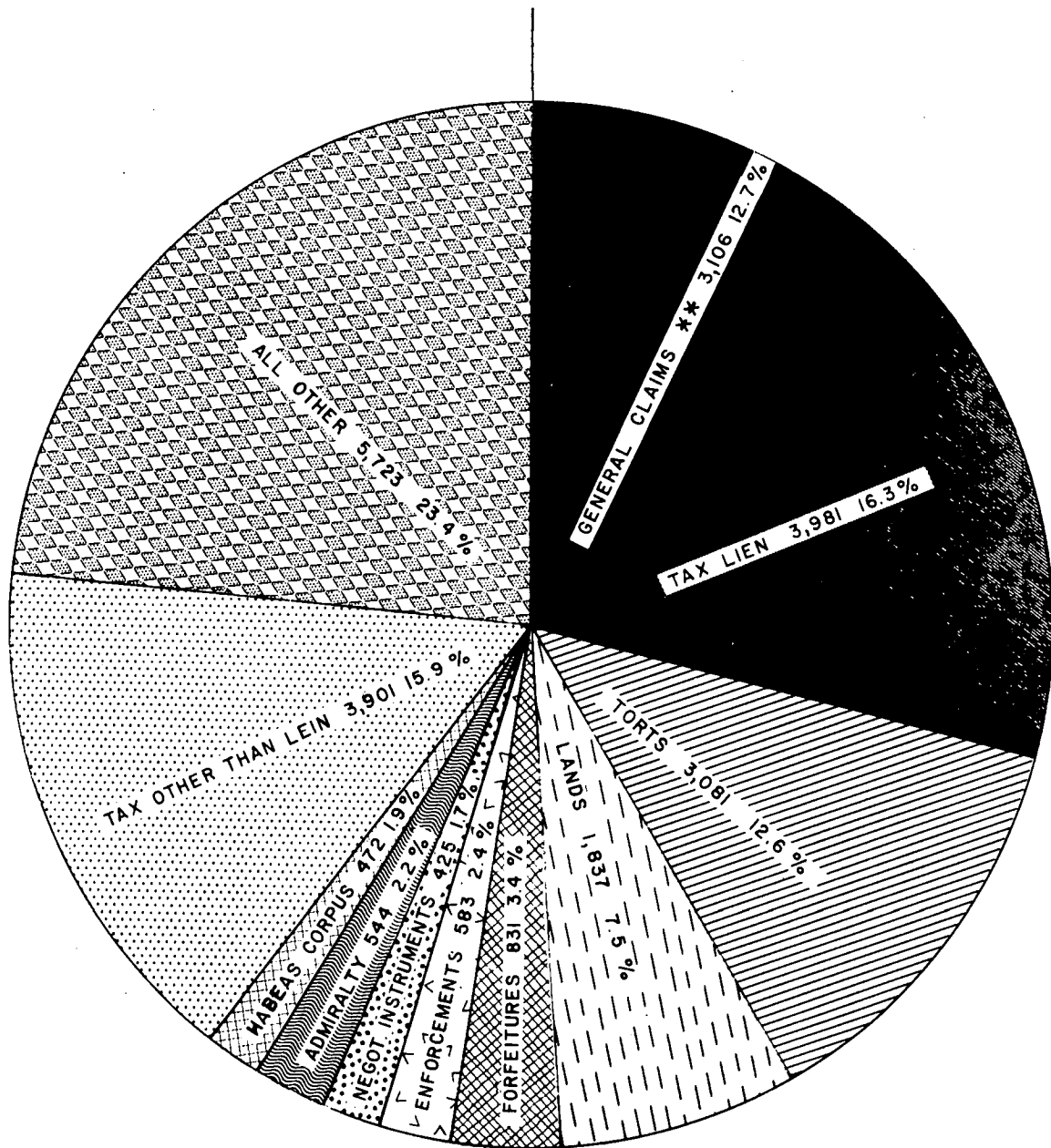

TOTAL 22,647 CASES

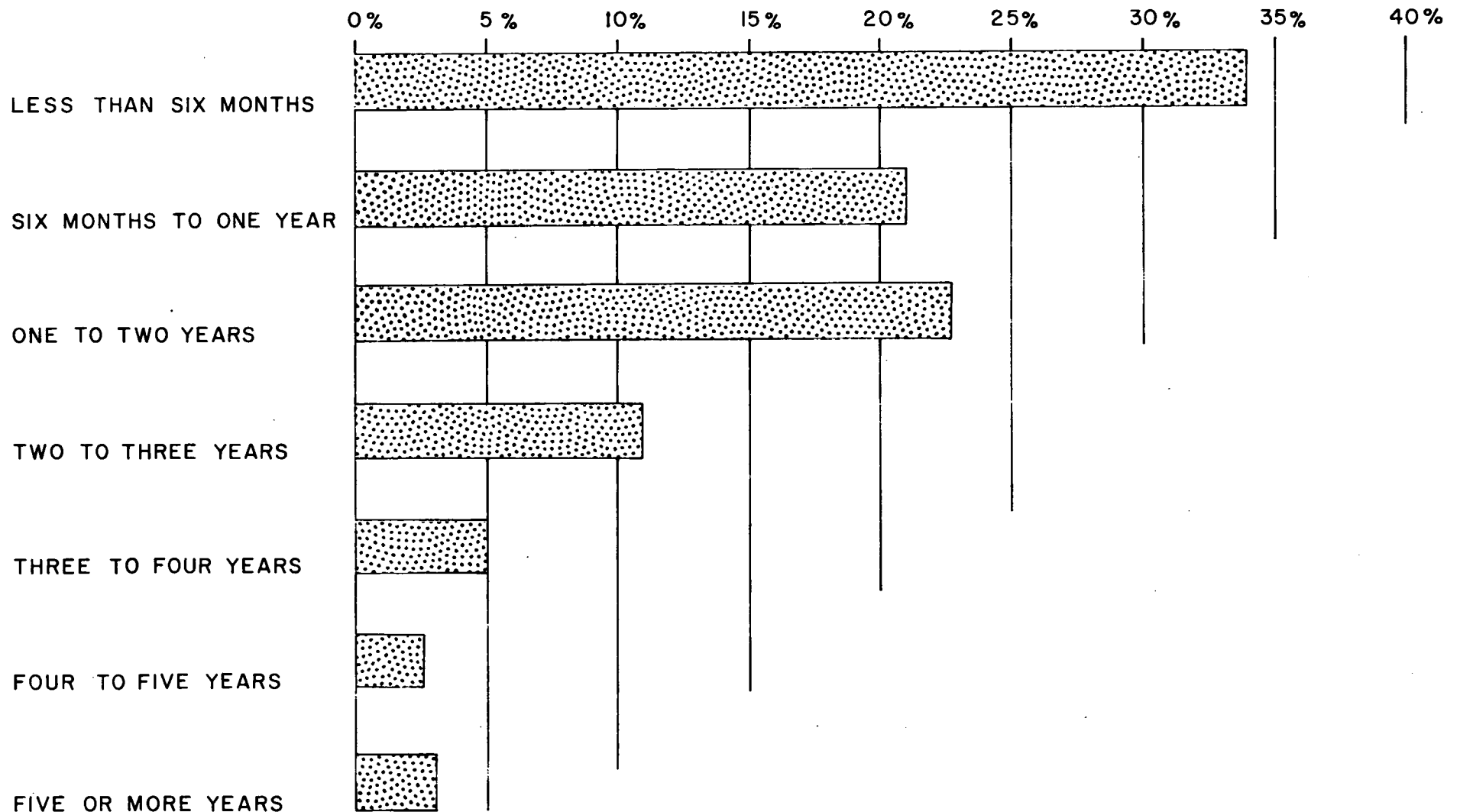

IN UNITED STATES ATTORNEYS' OFFICES

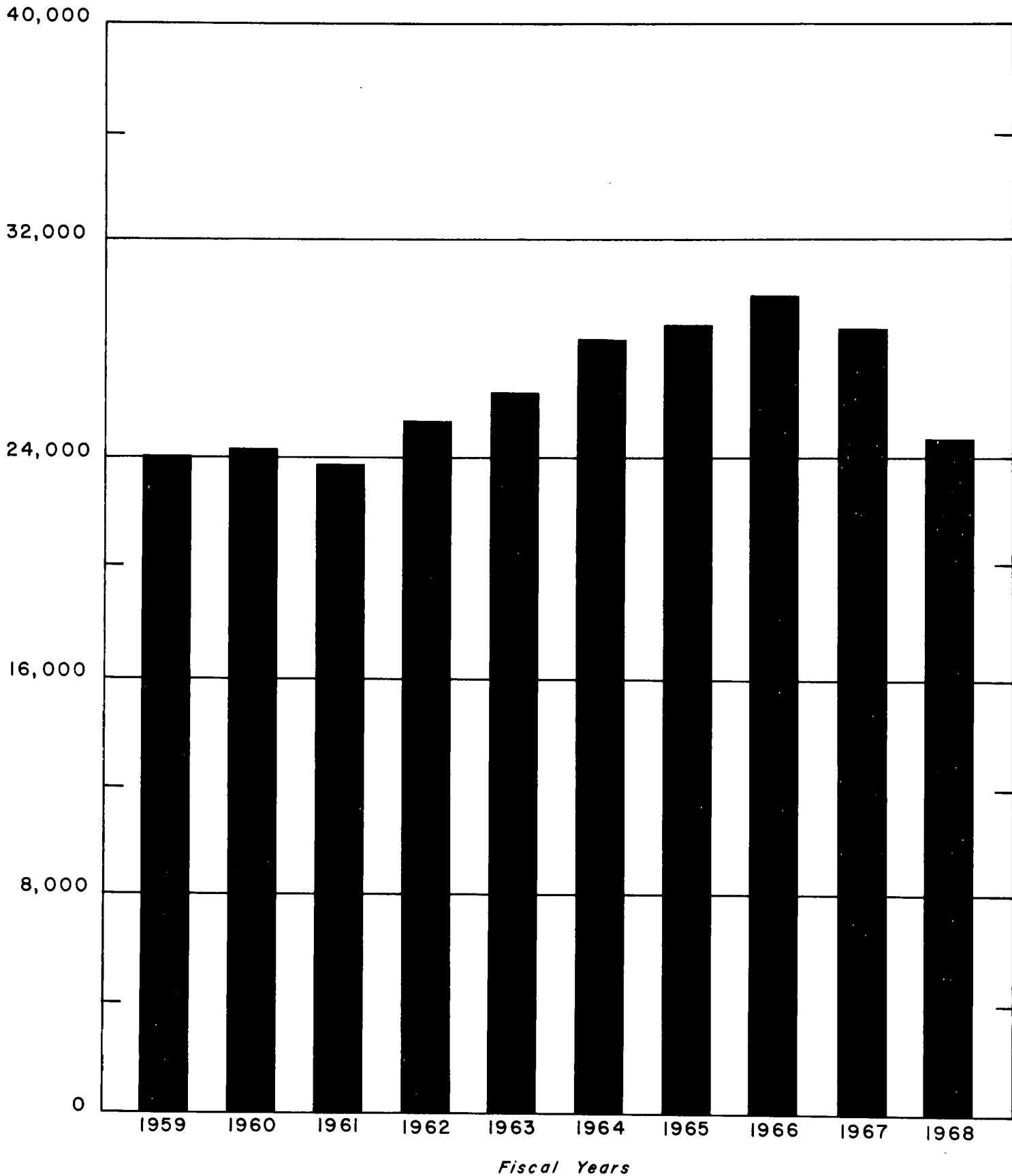


CHART NO. 16

IN UNITED STATES ATTORNEYS' OFFICES

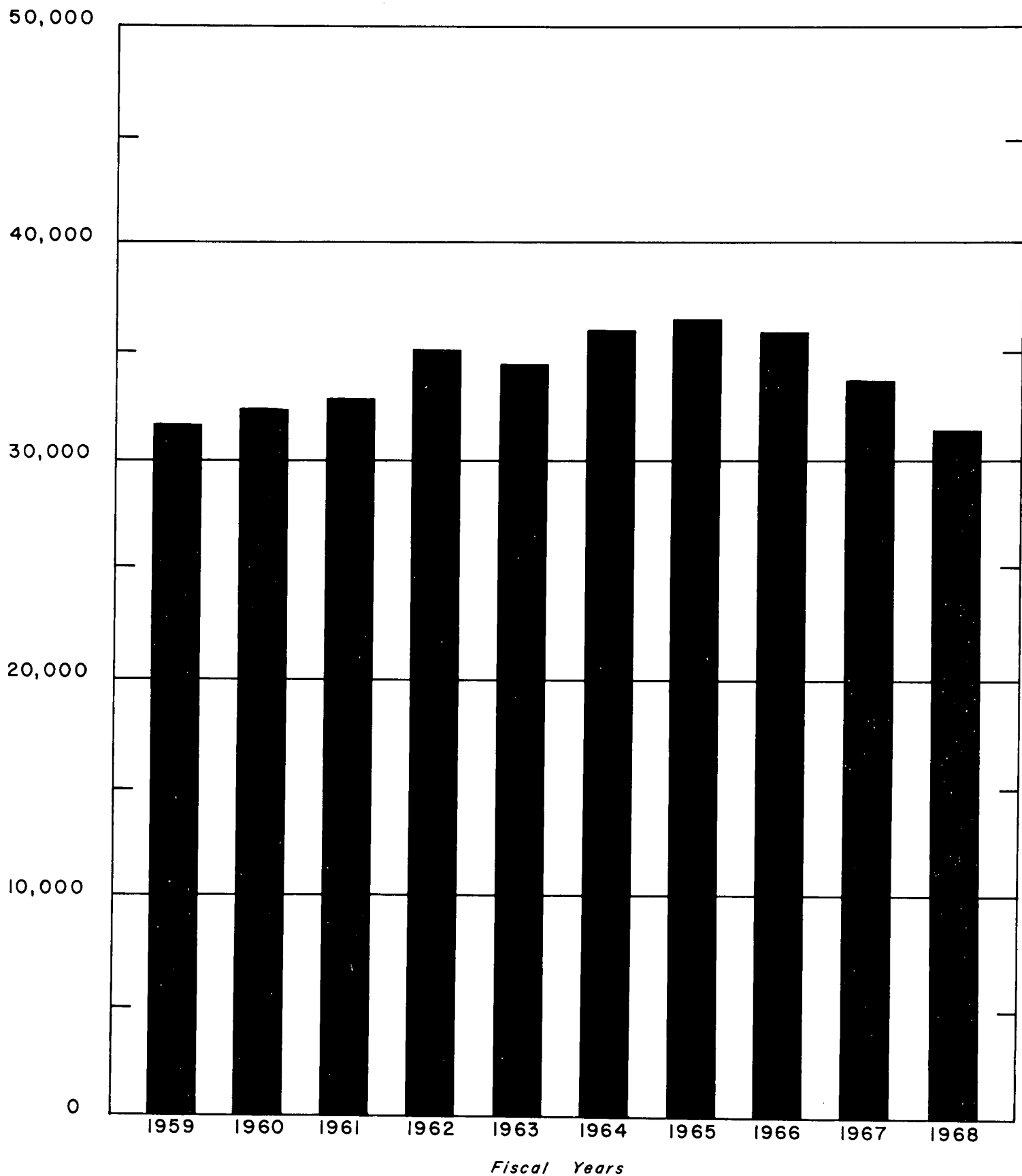


CHART NO. 17

IN UNITED STATES ATTORNEYS' OFFICES

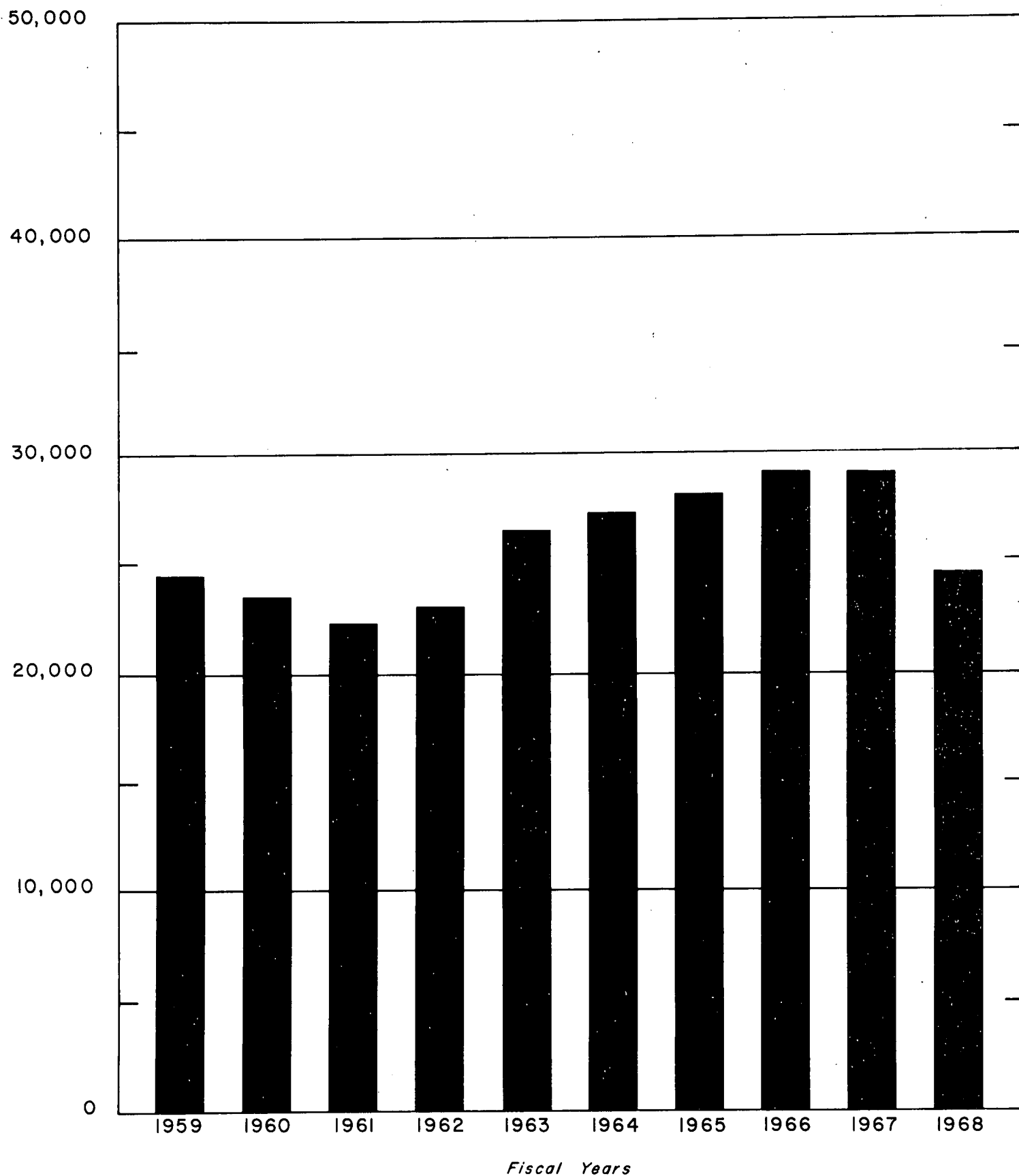

Millions of Dollars

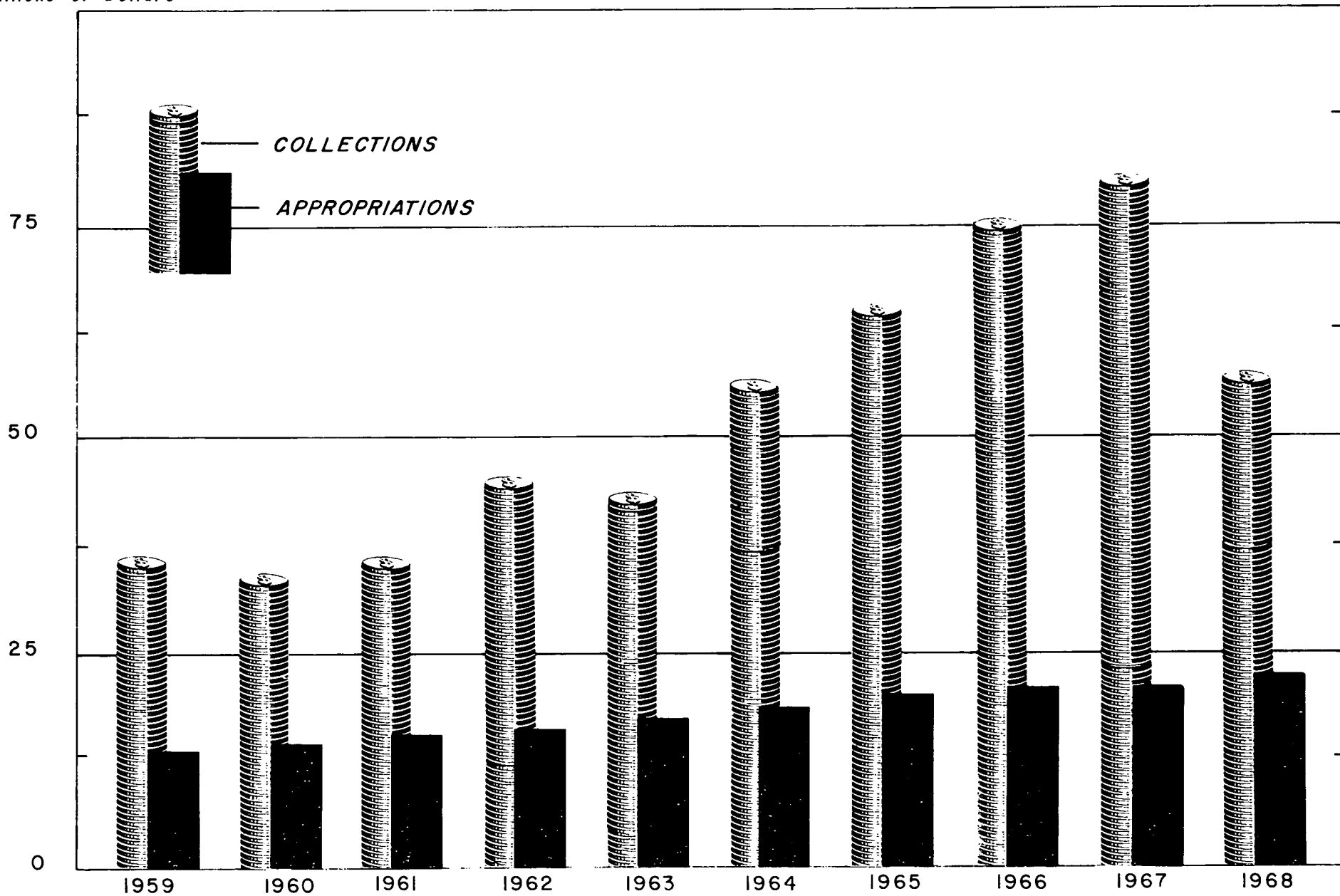

IN UNITED STATES ATTORNEYS' OFFICES

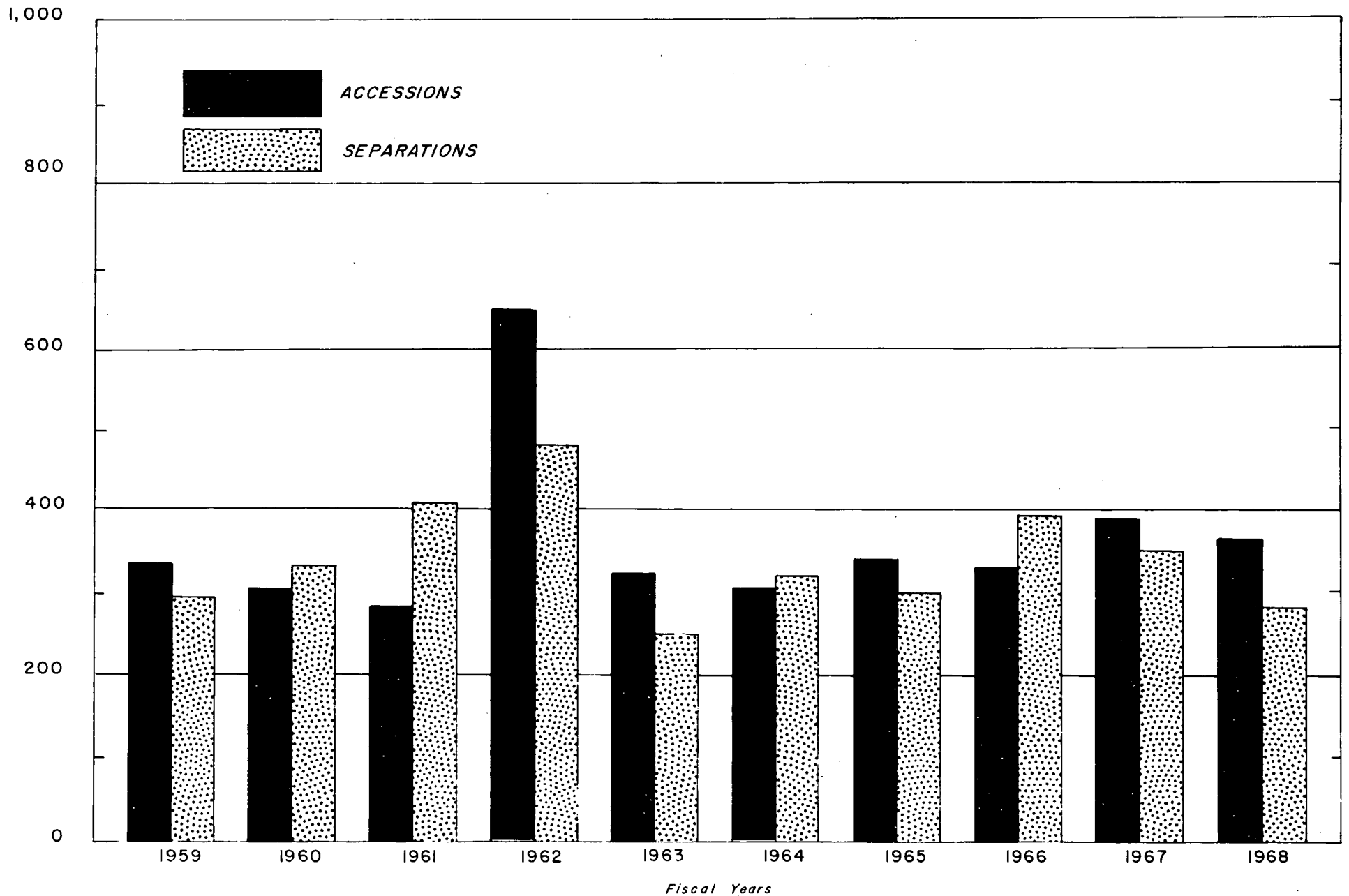

Fiscal Years

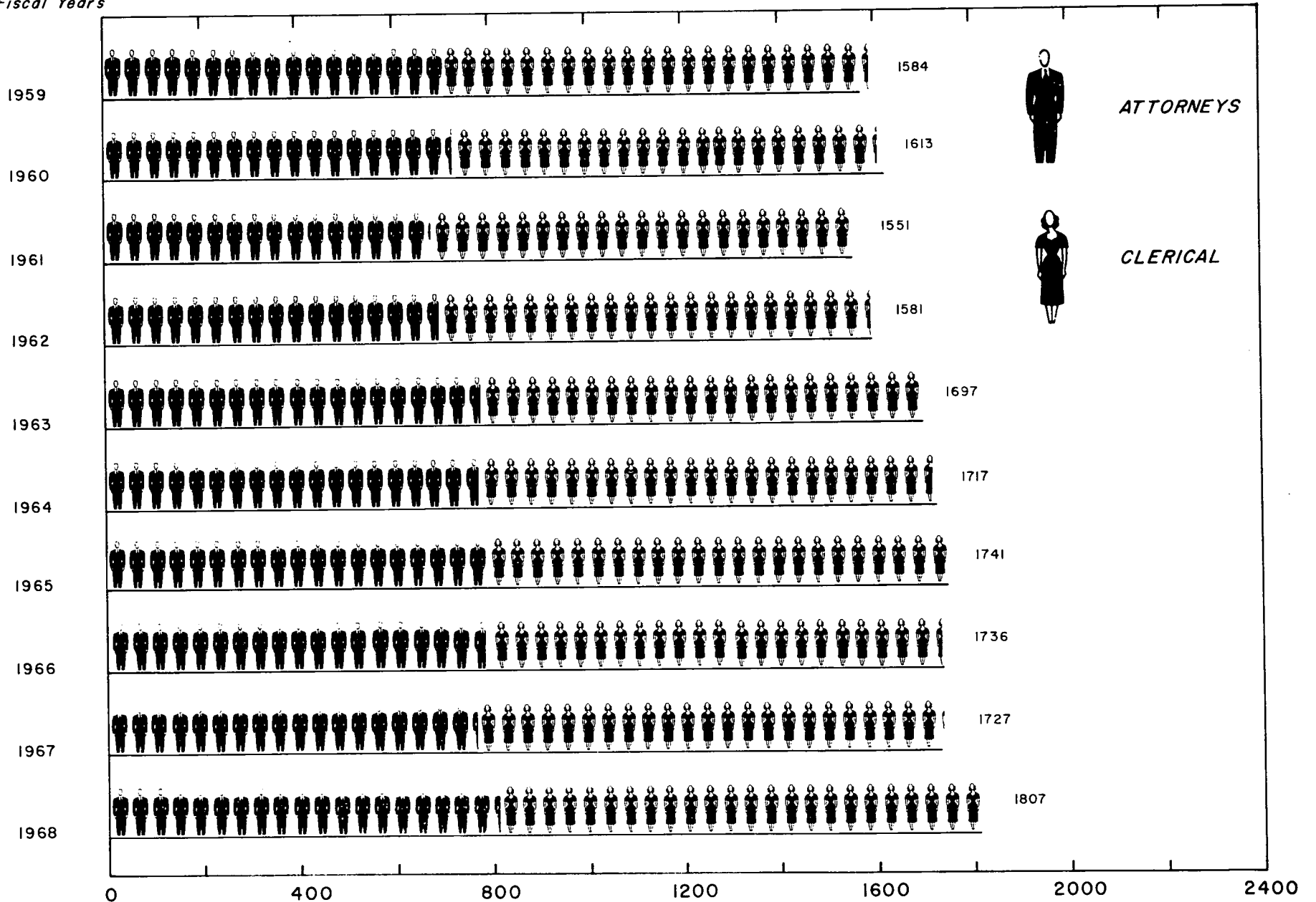
