

# FEDLINK Awards Web-Based Foreign Language BOAs

FEDLINK has just announced four basic ordering agreements (BOAs) for Web-Based Foreign Language Courseware. (Vendors and contact information follow.) Using a competitive procurement to determine vendors' ability to provide foreign language courseware to federal libraries, FEDLINK established these agreements with leading foreign language vendors to streamline procurement procedures for its customers. The BOAs are awarded for one base year FY2010 and four one year options.

All vendors can deliver the basic foundation needed to develop the skill of reading, listening and speaking a foreign language including an understanding of the foreign language and its culture. Some vendors can provide additional services including foreign language courseware in other formats and other delivery methods.

### **Agency Competitions**

FEDLINK customers must determine which of the vendors is best suited to meet their local agency's needs by competing their Web-Based Foreign Language Courseware requirements. Individual agency requirements may vary widely based on the number of languages required, the number of FTEs, and any technical issues that may need to be addressed. Each customer's cost is determined by a quote from the vendor based on the agency's specifications and technical requirements. This competition secures the best technical service for a particular agency at the best price.

For transfer pay customers anticipating orders over the current micropurchase threshold of \$3,000, LC/Contracts and Grants Management staff will issue a Request for Quote (RFQ) to the vendors. FEDLINK members may choose any foreign language vendor, if the anticipated order will be \$3,000 or less. For the RFQ customers must identify the languages required, any agency local technical requirements, and contact information including the FEDLINK ID. During the FEDLINK registration process, add funding to the FEDLINK LZ – Generic foreign language vendor account until competition is completed. Transfer pay customers needing assistance with their web-based foreign language courseware requirements should contact Georgette Harris at 202-707-4850 or gharris@loc.gov.

Direct Express customers will need to work directly with their agencies' contracting officials. All individual orders over \$3,000 must be competed among all foreign language courseware vendors participating in the FEDLINK program. Competition for accounts over \$25,000 require synopsis on the Federal Business Opportunities web site at http://www.fbo.gov. FedBizOpps notices should include the FEDLINK ID and indication that the order will be placed under the FEDLINK program. After competition is completed, simply cite the FEDLINK contract number on the agency's purchase order and send it directly to the vendor. Direct Express customers are responsible for initiating the purchase, managing delivery of the products and services and paying invoices.
