## UNANIMOUS CONSENT AGREEMENT

**Timothy S. Hillman (Cal. No. 613)**

*Ordered further*, That there be 30 minutes for debate equally divided in the usual form; that upon the use or yielding back of time the Senate proceed to vote without intervening action or debate on the Hillman nomination; that the motion to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order; that the President be immediately notified of the Senate's action and the Senate then resume legislative session.
