UNANIMOUS CONSENT AGREEMENT

Ordered, That at 4:30 p.m. on Monday, June 11, 2012, the Senate proceed to executive session for up to 60 minutes of debate on the motion to invoke cloture on the nomination of Andrew David Hurwitz, of Arizona, to be United States Circuit Judge for the Ninth Circuit, with the time equally divided between the two Leaders, or their designees, that upon the use or yielding back of time, the Senate proceed to vote on the motion to invoke cloture on the nomination; *provided further*, that if cloture is not invoked on the nomination, the Senate resume legislative session.

Ordered further, That relative to the cloture motion filed on the nomination of Andrew David Hurwitz, the mandatory quorum required under Rule XXII be waived.
