**UNANIMOUS CONSENT AGREEMENT**  
**Jimmie V. Reyna (Cal No. 42)**

*Ordered*, That at 4:30 p.m. on Monday, April 4, 2011, the Senate proceed to executive session to consider the nomination of Jimmie V. Reyna, of Maryland, to be United States Circuit Judge for the Federal Circuit; that there be one hour for debate equally divided in the usual form; that upon the use or yielding back of time, the Senate proceed to vote without intervening action or debate on the nomination; that the motion to reconsider be considered made and laid upon the table with no intervening action or debate; that no further motions be in order; that the President be immediately notified of the Senate's action and the Senate then resume legislative session.
