## UNANIMOUS CONSENT AGREEMENT

**Christopher H. Schroeder (Cal. No. 699 )**  
**Thomas I. Vanaskie (Cal. No. 578)**  
**Denny Chin (Cal. No. 607)**

*Ordered,* That following morning business on Wednesday, April 21, 2010, the Senate proceed to executive session to consider the nomination of Christopher H. Schroeder, of North Carolina, to be an Assistant Attorney General; that there be 3 hours of debate with respect to the nomination; that upon the use or yielding back of time, the Senate proceed to vote on confirmation of the nomination; that upon confirmation, the motion to reconsider be considered made and laid upon the table; further that the cloture motion with respect to the nomination be withdrawn.

*Ordered further,* That upon disposition of the Schroeder nomination, the Senate proceed to the nomination of Thomas I. Vanaskie, of Pennsylvania, to be United States Circuit Judge for the Third Circuit; that there be 3 hours of debate with respect to the nomination; that upon the use or yielding back of time, the Senate proceed to vote on confirmation of the nomination; that upon confirmation, the motion to reconsider be considered made and laid upon the table; that the cloture motion with respect to the nomination be withdrawn.

*Ordered further,* That following morning business on Thursday, April 22, 2010, the Senate proceed to executive session to consider the nomination of Denny Chin, of New York, to be United States Circuit Judge for the Second Circuit; that there be 60 minutes for debate with respect to the nomination, that upon the use or yielding back of time, the Senate proceed to vote on confirmation of the nomination; that upon confirmation, the motion to reconsider be considered made and laid upon the table; with the cloture motion withdrawn; and the President be immediately notified of the Senate's action with respect to the above referenced nominations; with all time covered under this agreement equally divided and controlled between the Senator from Vermont (Mr. Leahy) and the Senator from Alabama (Mr. Sessions).
