National Registry Test Organization Application

- Testing Organizations must first apply to be part of the registry online
 - Apply at http://nationalregistry.fmcsa.dot.gov under Testing & Training
- Application will collect the essential information about your organization
 - Name, address, POC information
 - Be prepared to upload electronic forms of critical documents (policies, procedures, security information)

National Registry Test Organization Application

- FMCSA will review online applications and determine the Test Orgs with whom they will move forward
 - POC may receive requests for additional information about TO business processes
- A security site visit will be scheduled for TOs whose applications meet FMCSAs requirements

National Registry Site Visit Requirements

Document Site Visit/security criteria

- The site visit will include an assessment of the NIST 800-53 security controls that are relevant to the location (Physical and Environmental)
 - Access control
 - Personnel Security
 - Configuration Management
 - and Auditing
- As a part of the site review the assessor would need to not only describe and document the controls but also verify and validate that the controls are actually in place
- The mitigation of security control weaknesses would depend upon the type, severity and impact of the weakness. Security control weaknesses can be documented and tracked through acceptance and/or remediation using the Plan of Action and Milestone (POA&M) document for the National Registry system with the approval of the FMCSA Security officer



- Once all the steps have been completed, FMCSA will make a decision to approve/decline to approve
 - An e-mail notification will be sent out once the application has been dispositioned in the National Registry system
- Approved Testing Organizations will need to do the following:
 - Load the National Registry test forms into their internal test delivery system
 - Provide a list of test centers to the National Registry team to be loaded into the National Registry database
 - Develop an interface to upload test results to the National Registry system



Test Centers will be loaded into the National Registry Database via a flat-file

- Standard CSV file format
- Includes essential test center information such as name, address, and contact information
- File is sent to the FMCSA help desk and will be loaded in by their personnel
- A National Registry account will be created for each test center

Test Center locations are searchable on the National Registry website

 Provides Medical Examiners a convenient way to find the closest testing location across testing organizations



National Registry test forms are provided to Testing Organizations

- Tests are multiple choice tests, with 120 questions
- 20 out of the 120 questions are non-graded "prototype" questions
- Forms are represented as XML documents that specify question, answer options, answer key, scoring criteria
- Some questions have associated images
- Four different test forms that will be offered to medical examiner based on their past history taking the exam



- Medical Examiner identity must be verified at center prior to delivering the test
 - Medical examiner will arrive with identification (photo ID, medical license, and training certificate)
 - Test center will log into the National Registry and look up ME by National Registry #
 - Test Center employee will confirm that the information in the Registry matches their physical documents
- After verification the National Registry system will provide the test center employee the test form ID to be issued

Interfacing with the National Registry for Test Result Upload

- Test results are transmitted to the National Registry system via web service (SOAP) over HTTPs
 - Username / password
 - Test organization & test center identification
 - Call may include results for 1 or more applicants
- Test Results for each applicant include:
 - Name and National Registry Number
 - Test Date
 - Test Version
 - Result (P/F)
 - Test Answers
