





This authorization is for the period of 10/29/12 to 12/29/12.

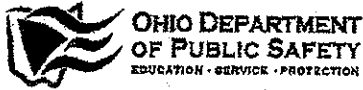
