# THE DURHAM VETERANS AFFAIRS MEDICAL CENTER PGY-2 RESIDENCY TRAINING PROGRAM IN GERIATRICS

This is a one-year, PGY-2 residency training program in Geriatrics accredited by the American Society of Health-System Pharmacists. It has been developed by the Durham Veterans Affairs Medical Center in cooperation with the School of Pharmacy at the University of North Carolina and Duke Center for the Study of Aging and Human Development. The resident will also complete a research project under the supervision of a research faculty member affiliated with the Durham VA's Geriatric Research, Education and Clinical Center.

The resident will have the opportunity to gain valuable clinical, teaching, and scholarly skills through interaction with an interdisciplinary staff, faculty, and trainees practicing in multiple sites along the continuum of care including a skilled nursing facility, hospital, and ambulatory settings. The resident will work with a diverse group of experienced clinicians, educators and researchers from the major local universities, including Duke, UNC, and Campbell University.

Benefits include a generous stipend, 13 vacation days, and travel funding. The resident may be eligible for a faculty appointment with the UNC School of Pharmacy.

#### Eligibility Requirements

The applicant should possess a Doctor of Pharmacy degree. Candidates must have completed an ASHP pharmacy practice or PGY-1 residency. A candidate who feels they have an equivalent level of experience must demonstrate that the prior experience in pharmacy practice is suitable to ASHP.

By January 3<sup>rd</sup>, interested individuals should send:

- 1) a cover letter indicating why advanced training through a geriatric residency program is desired
- 2) a curriculum vitae including names and addresses of references
- 3) three letters of support and
- 4) transcripts from your pharmacy school curriculum

**4. Geriatrics Friday Morning Conference:** *Conference is held every Friday,* 

9:00 – 9:45 AM. Coordinator: Second year fellows and Tom Simmons –286-6932.

Educational objective: Fellows and pharmacy residents present journal clubs, board reviews, or clinical case conferences in an interactive format with candid follow-up discussions among division members.

# General formats include the following:

- 1. EBM or Journal club: Review of specific article or topic addressing an important clinic question. Fellows expected to utilize critical appraisal skills and facilitate discussion of application of evidence. Ideal to distribute article 2-4 days in advance via email or photocopy to allow attendees to read. May ask Mr. Simmons to copy.
- 2. <u>Board Review</u>: Fellow usually prepares questions from Geriatric Review Syllabus (GRS) available in fellows room. Possible formats include Geriatrics Jeopardy or simply round robin questioning of attendees. Need to copy and distribute questions at conference.
- 3. <u>Clinical case conference</u>: Review of clinical topic based on recent case. May choose to copy and distribute key resources.
