We accept three residents each year for a 12-month program beginning July 1.

Throughout the year, mornings are spent in core or elective rotations and afternoons are dedicated to longitudinal clinics.

### HOW TO APPLY

#### Applicant Qualification Requirements:

- Graduate of an accredited School or College of Pharmacy
- Eligible for licensure within three months of starting the program
- United States citizen
- Registered in the ASHP Matching Program

#### Candidates Must Submit:

- Letter of intent
- Curriculum vitae
- Official pharmacy school transcripts
- Three letters of recommendation with ASHP Residency Recommendation forms
