VA Health Care System

The Department of Veterans Affairs is the largest integrated health care provider in the United States. Through its investments in people, cutting-edge technology and research, VA leads the health care field. With 600 health care facilities throughout the country, VA treats more than half a million veterans on an inpatient basis and manages nearly 40 million outpatients each year.

VA Pharmacy Residency Programs

VA Pharmacy Residency Program is the largest training program for advanced clinical pharmacy training in the country. VA trains approximately 333 residents annually in 83 American Society of Health-System Pharmacists (ASHP) accredited residencies. The training includes a variety of practice areas, such as: Pharmacy Practice, Specialty Residencies (e.g. Geriatrics, Ambulatory Care, Infectious Disease, Psychiatry, Intensive Care, etc.) and Research. VA also funds the advanced training of Pharmacy Fellows.
