The purpose of this PGY-2 Psychiatric Pharmacy Residency is to develop clinical competency as a practitioner in psychiatric pharmacotherapeutics with a patient centered focus. Areas of emphasis will include inpatient and outpatient clinical practice, teaching, and research in an inter-professional model.

The PGY-2 Psychiatric Pharmacy resident will gain experience in inpatient and outpatient settings. The resident will be actively involved in an outpatient, interdisciplinary, evidence-based medicine team. Various experiences are available including: PTSD, telepsychiatry, clozapine management, smoking cessation, buprenorphine clinic, memory disorders clinic, geriatrics, among others. Also, the resident will participate in journal clubs, literature reviews, and case conferences. Precepting opportunities are also offered. Additional experiences may be available depending on the resident's interests.
