This selected bibliography lists references for readings on Jointness, an enduring theme of the U.S. Army War College. A revised and updated version of our earlier bibliographies on jointness, it focuses on aspects of United States armed forces such as joint operations, joint logistics, interservice cooperation, interservice rivalry, joint communications, joint training, and Goldwater-Nichols.
