SUBJECT: Request for Quote, 126ARW-13-0002, Repair Hydrant Fueling System Pit Lid

This is a combined synopsis/solicitation for commercial service prepared in accordance with the format in Subpart 12.6, as supplemented with additional information included in this notice. This announcement constitutes the only solicitation; quotes are being requested and a written solicitation will not be issued.

This solicitation, 126ARW-13-0002, is being issued as a Request for Quotation (RFQ). This solicitation document and incorporated provisions and clauses are those in effect through Federal Acquisition Circular (FAC) 2005-23. This procurement is a 100% Small Business set-aside IAW FAR 19.502-2 (a). The NAICS code is 237120 and the small business size standard is \$33.5 million and/or NAICS code 336413 and the small business size standard is 1,000 employees. All repair work should be in accordance with attached Statement of Work, 2 pages, dated 16 October 2012.

The following provisions and clauses apply to this acquisition: The provision at FAR 52.212-1, Instructions to Offerors--Commercial Items. Quotes will be evaluated and awarded to the offeror with the lowest price technically acceptable.
