Background

The Office of Personnel Management (OPM) soon will implement new student employment programs and opportunities for recent graduates – Pathways. The Pathways Programs replaces earlier programs, including the Federal Career Intern Program (FCIP), Student Temporary Employment Program (STEP) and the Student Career Experience Program (SCEP). The new Pathways Program also modifies the Presidential Management Fellows (PMF) program for high-potential graduate students. OPM expects to implement the Pathways programs in May 2012.

OPM repealed FCIP earlier in the year; STEP and SCEP programs continue until the implementation of the new Pathways program. The DON has limited numbers of individuals participating in the PMF program. Pathways includes the Internship Program, Recent Graduates Program and the modified PMF Program. From STEP and SCEP to the Internship Program (eff. May 2012)


Current STEP positions are **temporary** (less than one year); often seasonal appointments open to all students regardless of academic goals. These appointments do not have conversion eligibility to the competitive service. SCEPs are longer term appointments available to students whose academic goals relate to the position to which they are appointed and have conversion eligibility to the competitive service.

The Pathways Internship Program combines the existing STEP and SCEP programs. It enables students to explore federal careers. Applicants must meet the definition of student - an individual who has been accepted for enrollment or who is enrolled and seeking a degree in a qualifying education institution on a full- or half-time basis. Unlike the current STEP program, all participants in the Pathways Internship Program are eligible for conversion to the competitive service if all program requirements are met.

New - Recent Graduates Program (begins May 2012)

Until its repeal, FCIP was a key tool used to hire recent graduates. The new Pathways Recent Graduates Program will provide a two-year developmental experience designed to lead to a civil service career in the federal government. To be eligible for the program, applicants must meet the definition of a recent graduate — an individual, who within the previous two years completed a qualifying degree or technical program. Veterans precluded from doing so due to their military service obligation, will have up to six years after degree or certificate

Graduates Program are eligible for conversion to the competitive service if all program requirements are met.

Frequently Asked Questions

Q. How do I find out about Pathways opportunities?

A. Once Pathways is implemented; a summary of all opportunities will be listed on USAJOBS.

Q. What will happen to current STEP and SCEP employees?

A. Many STEP and SCEP participants will be eligible to convert to a Pathways Internship appointment. Commands will evaluate participants to ensure they continue to meet activity needs and Pathways Program requirements in order to convert them to a Pathways Internship.

Q. Can commands continue to hire students until Pathways is effective?

A. Yes. STEPs and SCEPs will be eligible for conversion to a Pathways appointment. Additionally, all pending offers under STEP and SCEP will be honored and brought on as a Pathways appointment when Pathways regulations are final.

Q. When will Pathways opportunities be available?

A. Once OPM publishes final regulations, information and other materials will be posted on the DON HR website <u>www.public.navy.mil/donhr/Employment/InternApprentice/Pages/Default.aspx</u>. OPM expects to implement Pathways May 2012.
