\*Delta has advised that, beginning on June 1, 2007, ExpressJet will operate flights in the Los Angeles-La Paz market (in lieu of ASA), and the Los Angeles-Ixtapa/Zihuatanejo market (in lieu of Delta), and that ExpressJet will place Delta's "DL\*" code on ExpressJet's flights in these two markets.

\*\* Delta has advised that it no longer serves this market with its own aircraft, but will serve the market on a code-share basis, whereby ASA will place Delta's "DL\*" code on ASA's flights on the route.

\*\*\* Delta has advised that this dormancy notice refers only to its code-share service. It continues to operate direct-carrier service in the Salt Lake City-Mexico City, New York-Puerto Vallarta, and Boston-Cancun markets (see Dockets OST-2006-25433, OST-2005-22243, and OST-2005-222620, respectively).

\*\*\*\* Delta and Shuttle (joint applicants) advised by letter dated April 27, 2007, that Shuttle will no longer operate this service as a "Delta Connection" carrier, and that Delta will operate mainline seasonal service in the Salt Lake City-Mazatlan market until Skywest Airlines (Skywest), obtains its authority from the Mexican Government (Skywest already holds exemption authority from the Department to serve this route (see Notice of Action Taken dated September 1, 2006, in Docket OST-2006-25495).
