Dear Secretary Strickling,

In accordance with Public Law 111-5, the State of Florida respectfully submits the following comments on applications for Florida in Round 2 of BTOP funding. Per your request of March 24, 2010, and consistent with § 6001 of the Recovery Act, we are providing comments "on those geographic areas within the state for which NTIA should give priority in selecting projects for funding" and which "meet the greatest needs of the state."

Your staff has indicated that NTIA is looking for the Governor to provide feedback that only the state is able to provide and we have focused our efforts accordingly. Our review was undertaken by representatives for the following constituencies: economic development, health care, higher education, K-12, public safety and public sector anchor institutions.

As we reviewed over 85 applications with a proposed funded service area in Florida, we focused on the project's purpose as it relates to Florida's needs and the approach taken to meet those needs. We are relying on NTIA to conduct its intensive review of a project's technical feasibility, reasonableness of development and operational costs, sustainability, etc.

We recognize that \$7.2 billion is not sufficient to meet the incredible demand throughout the country and that only a limited number of applications will be funded. Florida is a very large state (almost 60,000 square miles) and our 18 million residents and their schools, businesses, homes and community institutions have many unmet needs, as represented by the large number of applications for the state. While many parts of the state need enhanced or more affordable broadband service, there are several parts of the state that are of greater state concern. These areas are largely rural areas that require investment in broadband for economic development and upgraded service for education, public safety and health care. As in Round 1, we have placed a priority on service to anchor institutions and those projects that can serve the broadest base of users in the long-term.

Comprehensive Community Infrastructure (CCI)

We considered the following factors in determining areas of need for infrastructure investment:

- Alignment with statutory intent of the American Recovery and Reinvestment Act of 2009 and Florida’s Consumer Choice and Protection Act (Chapter 2009-226, Laws of Florida),
- Governor’s declaration of Rural Areas of Critical Economic Concern counties,
- Counties prioritized by the Agency for Health Care Administration to prepare for health information technology and health information exchange,
- Counties prioritized by the Department of Education for K-20 service,
- Counties prioritized by the Department of Management Services for telecommunications service to anchor institutions and public safety based on input from state, city and county government, and
- Counties identified as needing enhanced broadband by the Bill and Melinda Gates Foundation 2008 survey of public libraries.

The high priority counties for infrastructure are shown in the attached map.

While some project areas overlap, there is little duplication due to differing audiences for the services.

For public computer centers and sustainable adoption needs, we considered:


- Population below the poverty level,

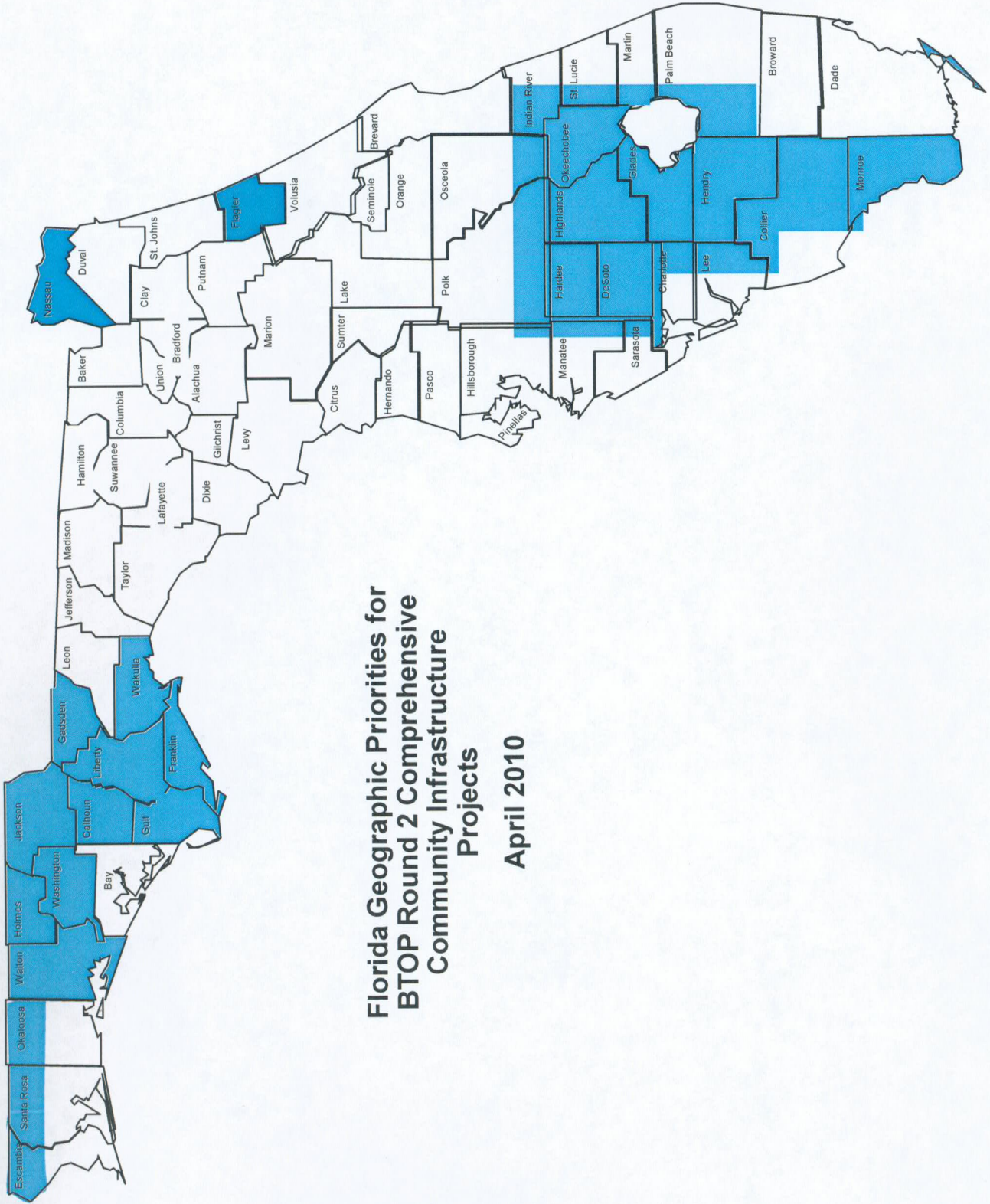

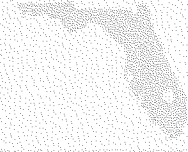

Dear Secretary Strickling,

On May 19, 2010, NTIA issued a Notice of Funding Availability for entities that received waiver authority from the Federal Communications Commission to use 700 MHz public safety broadband. In accordance with the funding priorities stated in the NOFA, the State of Florida is amending its list of Round 2 recommended projects that we sent to you on May 3, 2010.

The City of Pembroke Pines received waiver authority from the FCC and plans to build out 700 MHz broadband service for public safety. The Pembroke Pines 700 MHz system will provide a platform for implementing and testing a public safety broadband network, a priority of the FCC, NTIA and NIST. This public safety network will be a complement to the community network for which funding was requested in Round 2.

In light of these new priorities, we highly recommend you consider the following application for funding:
