# Wine Shipping Allowances for a PCS Move

- Army has changed it's policy on shipping of Alcoholic beverages
- Member shipping alcohol must obtain final designation state permit, pay any appropriate taxes or obtain an exemption letter from their states Alcohol Beverage Control board.
- It is the members responsibility to obtain these forms, individual state requirements can be found at http://ttb.gov/wine/control\_board.shtml
- Cannot ship Alcohol unless above listed documents are present at the time of counseling.
- Cannot be shipped as Un-accompanied baggage.
- Cannot be placed in non-temporary storage.
- Must comply with article 27 of the USC 122 which means you cannot transport it from one state to another, territory or district by any means, State laws vary from state to state and counties within states.
- Brochure will be published in the very near future to assist individuals desiring to ship Alcoholic Beverages and will spell out all requirements for doing so.

# Open Issue DES/SO-10-652 Smoking Too Close to the Buildings on the Installation

**Scope:** As I understand, smoking is prohibited within 50 feet of most buildings on the installation. This rule is not observed at most locations. As I enter the PX, Library, CPF, and practically any other building on post, I and my asthmatic children have to inhale smoke which usually takes our breath away. This is not only offensive but is also a health hazard. I'm not a smoker and should not be exposed to smoke in such public places. Whose job is it to enforce this rule?

**Recommendations:** I recommend that the installation give notice to the community that the expectation is for this rule to be observed and those caught not observing this rule will be fined. I'm not even sure if there is something in place now to enforce it but if not, I recommend that something is put in place to do so. I hate to suggest it as I know most people are already overworked, but maybe the managers and supervisors of the areas can be tasked with helping to enforce that people are 50 ft away. If I had my way, the entire installation would be smoke-free.

**Agency Response:** <u>DES/S0</u>: This is a community wide responsibility and our military police can definitely help enforce it. We think the best impact would be to request the PAO run a add in the outlook reminding people of the rules for smoking. Also, I recommend managers, supervisors and senior occupants of buildings enforce the no smoking rules for their building because, more often than not, the perpetrators are the occupants of those buildings.
