





Wildland Fires by Agency






Number of Lightning Caused Fires



Number of Human Caused Fires






Large Fire Activity






Prescribed Fire Projects and Acres by Agency







National Preparedness Levels

The 41 days spent at national Preparedness Level 4 in 2005 was largely due to a heavy resource commitment to hurricane relief efforts. The National Interagency Coordination Center declared PL 4 on September 1st, and remained there until October 11th. In 2005, a total of 47 days were spent at PL 3 (from July 19th to August 31st), which is above both the five and ten year averages. Other significant milestones over the past ten years: February 14, 2003 was the earliest PL 2 was declared; May 12, 2000 was the earliest that PL 3 was declared; June 10, 2002 was the earliest that PL 4 was declared; June 21, 2002 was the earliest that PL 5 was declared.












Type 2 Incident Management Team Mobilization






Large Transportation Aircraft

This year there was one exclusive use contract for large transportation aircraft. The Forest Service maintains the contract and the Office of Aircraft Services administers the contract. 


