



Release 32.0.0 – Notes – Version 3.1

The *PostalOne!* 32.0.0 Release will be deployed October 14, 2012 to introduce software upgrades to the system. These Release Notes provide the contents of this release and its effect on the following areas based on changes identified during the test stage of the software development cycle. # 1. Mailers (External)

*PostalOne!* Release 32.0.0 will be deployed October 14, 2012 to introduce software upgrades to the system. The following items will be included in *PostalOne!* Release 32.0.0 and are of interest to external users of the *PostalOne!* system.

The contents of the release notes are subject to change.

## 1.1 Electronic Data Exchange

Users participating in electronic data exchange with the US Postal Service should reference the *Postal Service Mail.dat Technical Specification* and *Postal Service Mail.XML Technical Specification for Postage Payment and Reporting (eDoc)*.

## 1.2 Mail.dat

The changes in the following sections apply to customers participating in electronic data exchange using Mail.dat as a means of electronic submission.

### 1.2.1 Mail.dat Support

The *PostalOne!* system will support the following versions of Mail.dat.

- Mail.dat 12-1
- Mail.dat 12-2

### 1.2.2 Enhancements

The following Mail.dat enhancements are proposed for the *PostalOne!* system.

- The *PostalOne!* system will add functionality to allow mailers to search for jobs when pulling the discount assessment report for origin mail copal jobs that are submitted by consolidators with consolidator's Mailing Group ID.
- The *PostalOne!* system will allow individual mail owners the ability to pull (search for) only their own jobs.
- The *PostalOne!* system will update the Mail.dat job Status Receipt File to include the adjustments in postage made as a result of Incentives claimed.
- The *PostalOne!* system will allow Postage Statement Lock function for increased postage data integrity.
- The *PostalOne!* system will check if weight adjustments need to be made when Mail.dat PAR files are submitted.
- The Mail.dat MPU "Weight" field will be used to calculate surcharges when the Rate Category is barcoded or non-barcoded. The MPU weight field will be used in addition to the MPU "Class", MPU "Rate Category", MPU "Rate Type", MPU "Processing Category", and MPU "Barcode Discount or Surcharge Indicator".
- The *PostalOne!* system will update the Qualification Report to display incentive information if Incentive is claimed in Mail.dat 12-1 CCR "Characteristic" field. The *PostalOne!* system will update the Qualification Report to display incentive information if Incentive is claimed in Mail.dat 12-2

represented by the presence of the CCR “Characteristic Type” field value of “I” and corresponding CCR “Characteristic” field.

- The *PostalOne!* system will allow a Bundle-based Mail.dat copal consolidator job to be deleted from the *PostalOne!* dashboard. This deletion will be allowed if the postage statements generated for the job were cancelled, or if there were no postage statements that were generated. In addition, if the data for the job is sent to SASP, then that will prevent for the job to be deleted.
- The *PostalOne!* system proposes a validation for a processing category across Mail.dat jobs.
- The *PostalOne!* system proposes a validation to tie Parent and Child containers to the same SEG.
- The *PostalOne!* system will continue to support the Mobile Barcode Promotion.

### 1.2.3 Error Codes

The *PostalOne!* system will enhance and redefine the structure of eDoc error messages for Mail.dat and Mail.XML to include the following.

- Provide error descriptions were needed.
- Identify and provide detailed descriptions and explanations of enumerations..
- Add the statement “The value provided was” “.to every message.
- Create the same description for duplicate functional error codes and highlight them for review..
- Delete non existent values from the descriptions and identify them in a separate column.

### 1.2.4 Presort Internal Copal for Full Service

The *PostalOne!* system will allow mailers the ability to send Origin MLOCR jobs and Origin presort jobs in order to combine them in a consolidated Copal job for First Class and Standard letters in tray mailings. This will be done by using the presentation category of C in the consolidated job. Mailers will also be able to see the OCI report for nesting information from trays to pallets.

### 1.2.5 Mail.dat PAR file (Spoilage/Shortage) with Incentives

PostalOne! supports Mail.dat PAR file for the communication of spoilage and shortage. Mailers when submitting the Mail.dat PAR file are required to take into account the incentives claimed (if any) and the adjusted postage amount for pieces based on the incentive claimed. In this case the mailer is required to submit the correct postage Adjustment Amount which must include the discount received because of the incentive. For instance, if the mail had pieces with a 2% incentive, then the adjustment per piece with the incentive should be \$Price Listed in Notice 123 minus the 2%.

## 1.3 Mail.dat Client Application

As a reminder, with this release it is required that mailers download the new Mail.dat client application. The latest Mail.dat application is available for download from the Electronic Data Exchange page, accessed from the Business Customer Gateway.

## 1.4 Mail.dat Validations

### a. Mail.dat - New Error Messages - Client

4411	The .seg eDoc Submitter CRID and Verification Zip+4 populated for the Consolidator Job does not match the .seg eDoc Submitter CRID and Verification Zip+4 populated for origin job %%1.
4412	For .hdr File Processing, the Presentation Category field is populated with an invalid value; when the Included In Other Documentation value for all Origin jobs is populated with O – Original Container, the .hdr Presentation Category for the Consolidator job cannot be populated with C – Consolidated Internal Copal.
4413	For .hdr File Processing, the .hdr Presentation Category contains an invalid value; the .hdr Presentation Category must be populated with M – MLOCR or C – Consolidated Internal Copal when the Included In Other Documentation value for Origin Mailings is populated with I – Internal Copal and the .hdr Presentation Category of the Origin Mailings is populated with P – Conventional Presort or M – MLOCR.
4414	For .hdr File Processing, the .hdr Presentation Category contains an invalid value; the .hdr Presentation Category must be populated with C – Consolidated Internal Copal when the Included In Other Documentation value for Origin Mailings is populated with I – Internal Copal and the .hdr Presentation Categories of the Origin Mailings are populated with P – Conventional Presort and M – MLOCR.
4417	When at least one .mpa Payment Account Number is populated, the .mpa Permit ZIP+4 and .seg Verification Facility ZIP+4 must map to the same finance number for .mpa records which do not have the .mpa Account Number populated.
4418	The .mpa Payment Account Number is not valid for the .mpa Permit Number, .mpa Permit ZIP+4 and .seg eDoc Sender CRID provided; when populated, the .mpa Payment Account Number must reference an active Account Number that is associated to the .mpa Permit Number, .mpa Permit ZIP+4 and .seg eDoc Sender CRID.
4419	The maximum weight limit for Standard Mail pieces is 3.3 ounces (0.2063 lbs).
4422	The .csm eInduction Indicator field contains an invalid value; in a single job, all .csm records must have the eInduction Indicator field populated with either Y – Yes or blank – No.

### b. Mail.dat – New Warning Messages - Client

4415	The .hdr {1} File Status can not be populated with N when the .hdr {1} Record Count field is populated with a value greater than 0.
4416	The .hdr {1} File Status can not be populated with O when the .hdr {1} Record Count field is populated with 0.

**c. Mail.dat - Updated Error Messages - Client**

7139	The permit balance of the .mpa Permit Number <XXXXXX> and Permit ZIP+4 <XXXXXXXXXX> provided will be negative after postage statement processing. NOTE: This is for regulated Metered – MT Permits.
7140	The permit balance of the .mpa Permit Number <XXXXXX> and Permit ZIP+4 <XXXXXXXXXX> provided will be negative after postage statement processing. NOTE: This is for Government Metered Permits - OM

The changes in the following sections apply to customers participating in electronic data exchange using Mail.XML as a means of electronic submission.

### 1.6.1 Mail.XML Support

The *PostalOne!* system will support the following versions of Mail.XML.

- Mail.XML 12.0A
- Mail.XML 12.0B

### 1.6.2 Enhancements

The following Mail.XML enhancements are proposed for the *PostalOne!* system.

- The *PostalOne!* system will perform minimum required weight and piece count warning validations for commercial mail on postage statements.
- The *PostalOne!* system will make enhancements to *PostalOne!* Mail.XML ID/Identification systems. This enhancement will allow the MID and CRID responses to also include the related Permit Account information.
- The *PostalOne!* system will add a new value “C = Consolidated Internal Copal job with linked logical and presort mailings” to indicate that logical (MLOCR) and physical (conventional) presorts are in the same mailing.
- The *PostalOne!* system will return an updated warning message when FormType is PE and the ZoneIType enumerated value provided is invalid.
- The *PostalOne!* system will allow mailers to send the Mail.XML 12.X messages containing mixed class mailing for both Periodicals and Standard Mail. The mixed class mailings for Full Service are only supported in Mail.dat today.
- The *PostalOne!* system will continue to support the Mobile Barcode Promotion.

The *PostalOne!* system will enhance and redefine the structure of eDoc error messages for Mail.dat and Mail.XML to include the following.

- Provide error descriptions were needed.
- Identify and provide detailed descriptions and explanations of enumerations..
- Add the statement “The value provided was” “.to every message.
- Create the same description for duplicate functional error codes and highlight them for review..
- Delete non existent values from the descriptions and identify them in a separate column.

## 1.7 Mail.XML Validations

## 1.9 Postal Wizard

The Postal Wizard (PW) will provide new functionality that will allow mailers to use Postal Wizard to generate required postal eDocumentation for business mailings claiming entry discounts or mailer expedited plant load mailings. The Postal Wizard “Register Entry” page will be moved out of the postage statement entry process and provided as an option on the “Postage Statement Submitted” web page to allow mailers to create a postage register. Mailers will be able to use the new Postal Wizard functionality to:

- Create a postage register for either a drop ship mailing claiming entry discounts or a mailer expedited plant load mailing. Mailers will be able to specify only one USPS entry facility per register per postage statement.
- Print a PS-Form 8017/8125 with all the mailer’s sections completed
- Create, print, and apply IMcbs to containers for drop ship and/or mailer expedited plant load mailings.
- Claim Destination Delivery Unit (DDU) entry discounts and specify a USPS entry DDU facility in the register.
- Easily data enter and navigate through the Register Entry web page.
- Induct containers with an IMcb generated by PW through the eInduction process.

## 1.10 Mail Anywhere

Periodicals will be included as an eligible mail class for Mail Anywhere. However, it is only available for use for customers that are in the Mail Anywhere Pilot program.

## 1.11 Seamless Acceptance

Seamless Acceptance automates the entry and verification of mail through scanning, sampling, and trend reporting.

### 1.11.1 Seamless Paralell Functionality

#### **Seamless Acceptance Participation Criteria:**

- Mailing must be submitted in the form of electronic documentation
  - Mail.dat or Mail.XML
- Mailing must be eligible for Seamless Processing
  - First-Class, Periodicals, Standard Mail
  - Letters, Cards, Flats
- Piece information must be provided through the .pdr, .pbc or MailPiece block
- All containers, handling units, and pieces must contain a unique barcode
- Mailing must meet eInduction criteria

#### **Seamless Parallel Run:**

Seamless Parallel Run processing allows mailers to submit Seamless Acceptance mailings without an interruption to the current processing. Mailers will participate in Seamless Parallel Run processing prior to having their eDoc Submitter CRID set to Seamless Acceptance. This processing will serve as a trial period for the mailers that wish to participate in Seamless Acceptance.

Mailings which meet the Seamless Acceptance criteria will be processed in *PostalOne!*. A warning message will be triggered when fields are not populated correctly in the electronic documentation (Mail.dat, Mail.XML) based on Seamless requirements.

After a successful job submission, a postage statement will be generated and must be manually finalized by a BMEU clerk. After finalization, data from these mailings will be available in the Seamless Acceptance reports. Additional Seamless functionality such as Auto-finalization and sampling at induction will not be enabled.

#### **Seamless Acceptance:**

Mailings which meet the Seamless Acceptance criteria will be processed in *PostalOne!* An error message will be triggered when fields are not populated correctly in the electronic documentation based on Seamless requirements. Balance validations will be implemented to ensure that payment accounts have sufficient funds prior to Auto-Finalization. If the payment account balance is positive, the postage statement will be auto-finalized.

After Auto-Finalization, the mailing will be inducted into facilities and sampling will be performed by BMEU clerks. The data retrieved from these mailings during sampling will be available in the Seamless Acceptance reports.

## 1.11.2 Seamless Acceptance eDoc Validations

### Seamless/Seamless Parallel Run Validations

Validations will be triggered in the form of an error message for Seamless Acceptance mailings and in the form of a warning message for Seamless Parallel Run mailings when fields in the eDoc do not meet Seamless participation criteria. For Seamless Acceptance mailings, if an error is logged, the mailing will be rejected. For Seamless Parallel Run mailings, if a warning is logged, the mailing will continue with the existing process.

- Mailers must verify that their Mail.dat or Mail.XML jobs meet the following participation criteria to qualify for auto-finalization:
  - Mail Class is First-Class, Periodicals, or Standard
  - Processing Category is Letter, Cards, or Flats
  - eInduction Indicator is set to Y
  - Containers must include a unique 21 character barcode beginning with 99M
  - Handling Units must include a unique 24 character barcode
  - eDoc containers must include a 9 digit Entry Point Actual/Delivery Locale Key
  - Piece data must be submitted in either the .pdr or .pbc file or the MailPiece block for Mail.XML jobs
  - Logical Container must be referenced by a physical sibling with Sibling Container Indicator set to 'Y'
  - Logical Pallets must be referenced by a physical sibling with Sibling Container Indicator set to 'Y'
  - Balance of Account Number, Permit/Publication Number, Additional Postage Permit, or CAPS Credit Account balance must be positive or negative below the configurable threshold

## 1.11.3 Bypass Seamless Acceptance

Mailers will have the ability to flag mailings to Bypass Seamless Acceptance processing. Mailers must populate the .seg Bypass Seamless field with 'Y' for Mail.dat and the BypassSeamlessAcceptance field in the QualificationReportSummaryCreateRequest message for Mail.XML mailings.

The mailing will not be processed as Seamless Acceptance when the field is set to Y and the CRID is set to either Seamless or Seamless Parallel Run.

Postage statements will not be Auto-Finalized when the Bypass Seamless Acceptance field is set to 'Y'.

#### 1.11.4 Auto-Finalization

A postage statement will be auto-finalized after the electronic documentation for Seamless Acceptance mailings was validated and uploaded successfully.

The Postage Statement Mailing Date will be used to determine when a postage statement should be auto-finalized for both Mail.dat and Mail.XML job submissions.

Postage statements will be auto-finalized based off of a configurable number of days (zero) after the Postage Statement Mailing Date.

#### 1.11.5 Sampling

Sampling will be implemented to perform verifications on containers, handling units, and pieces to assess mail quality. Mailings that are USPS transported, drop shipped, or entered at a BMEU will be sampled using the 1-3-30 (1 container, 3 handling units, 30 pieces) method. The *PostalOne!* system will determine the container sampling frequency for each mailer, which determines the containers that will be flagged for sampling.

After a postage statement has been auto-finalized, BMEU clerks will use the Full-Service Intelligent Mail Device (FS-IMD) to sample containers that were flagged by the *PostalOne!* system. Handling units and pieces from the container that was flagged will be sampled.

- A clerk will select and scan 3 random handling units using the FS-IMD and populate the required fields with the correct values
- A clerk will select and scan 10 random pieces from each handling unit using the FS-IMD and populate the required fields with the correct values
- A clerk will re-cradle the FS-IMD after performing the required sampling for the mailing

The container will be released into mail operation and the FS-IMD sampling scan information will be sent to the SASP system for further processing. After the container is released, it will be removed from the sampling list.

The data retrieved from the sampling process will be displayed in the Seamless Acceptance reports.

#### 1.11.6 Seamless Acceptance Verifications

Verifications will be performed on containers, handling units, and pieces during the sampling process. The data that is retrieved from the FS-IMD scans will be compared to the data submitted in the electronic documentation. Verification errors will be logged if the scan data does not match the data submitted in the eDoc.

Additional verifications will be performed on Seamless mailings during the induction and sampling processes.

FS-IMD Verifications are performed during the sampling process.

- **Barcode Quality**
  - Identifies the barcodes that are non-visible, unreadable, contains invalid MIDs, STID, OEL, and barcodes that are not populated with the correct character length

- **Barcode Uniqueness**

- Identifies barcodes that are non-unique within 45 days
- **Entry Facility**
  - Identifies mail that was entered at the incorrect facility
- **Mail Characteristic**
  - Identifies mail that contains incorrect Mail Class, Processing Category, Content, or Bundle preparation
- **Mailer ID**
  - Identifies Mailer IDs that are captured from an Intelligent Mail Barcode that do not match valid Mailer IDs in the SASP system
- **Nesting/Sortation**
  - Identifies pieces/handling units that were not placed on the containers that were claimed in the eDoc, Identifies containers with incorrect presort levels
- **Postage**
  - Identifies mailpieces with insufficient postage or postage payment method
- **Service Type**
  - Identifies mailpieces with Service Type IDs that do not match Service Type IDs in the SASP system and Service Type IDs for a Mail Class that does not match the Mail Class submitted in the eDoc

  - Identifies piece weights that do not match the mailpiece weight submitted in the eDoc

Census Verifications are performed as mailpieces are run through the Mailpiece Processing Equipment.

- **Barcode Scan Rate**
  - Identifies IMcbs, IMtbs, or IMbs that are not readable on USPS equipment
- **Entry Discount**
  - Identifies containers that were processed at the incorrect facility
- **Move/Update**
  - Identifies mailpieces that were sent to an incorrect address
- **Nesting/Sortation**
  - Identifies pieces that were not placed inside the handling units that were claimed in the eDoc
- **Undocumented Mail**
  - Identifies containers, handling units, and pieces that received a scan, but could not be associated to an eDoc

MDQ Verifications are performed during eDoc upload.

- **Appointment**
  - Identifies invalid appointments
- **By/For**
  - Identifies mail preparers or mail owners that were not identified for the physical piece
- **Barcode Quality**
  - Identifies the barcodes that contains invalid MIDs, STID, OEL, and barcodes that are not populated with the correct character length
- **Barcode Uniqueness**
  - Identifies barcodes that are non-unique within 45 days
- **eDoc**
  - Identifies containers in the electronic documentations that were not prepared correctly according to Seamless Acceptance participation criteria
- **Entry Facility**
  - Identifies mail that was entered at the incorrect facility
- **Mailer ID**
  - Identifies Mailer IDs that are captured from an Intelligent Mail Barcode that do not match valid Mailer IDs in the SASP system
- **Service Performance**



- Identifies postage statements that were finalized two or more days after the Scheduled Ship Date, orphan handling units that do not have a BMEU induction method, and physical containers with multiple SV unload scans with different appointment IDs
- **Service Type**
  - Identifies mailpieces with Service Type IDs that do not match Service Type IDs in the SASP system and Service Type IDs for a Mail Class that does not match the Mail Class submitted in the eDoc

## 1.12 Flats Deflection

The *PostalOne!* system will include Flats Deflection verification as an in-depth verification. MicroStrategy Reports will also include Flats Deflection as an in-depth verification and there will be a Disqualification Mail Log.

## 1.13 Intelligent Mail Barcode (IMb)

The *PostalOne!* system will include an automated accounting system for mail with an Intelligent Mail barcode (IMb) to track and count pieces from Business Reply Mail and Alternate Postage mailers. The scan count will be captured in the system and allow invoice generation and CAPS account debiting.

## 1.14 Official Mail Accounting System (OMAS)

The *PostalOne!* system has improved the modification process for cost codes for federal agencies and members of Congress that are processed by OMAS.

## 1.15 eInduction

The following process improvements, system enhancements and modifications to the existing eInduction application in *PostalOne!* will be implemented.

**MID Management Enhancements Support for Continuous Mailer:** To enhance the Mailer ID (MID) application in BCG, allow a mailer to identify themselves as a continuous mailer and be able to tag (check off) each of the MIDs identified as continuous mailing MIDs for eInduction.

**Support for Container Manifest for *PostalOne!* MDX CreateRequest for Postage Validation:** A new validation rule will be added for container manifest message set to only have less than or equal to the number of pallets that are on the postage statement. The system will generate an error anytime more than the allotted pallets on a postage statement ID show up with any container manifest message.

**eInduction Mixed Mailing Support for Mail.XML:** The *PostalOne!* system will support eInduction mixed mailing in Mail.XML.

**eInduction Percentage Identification for Appointments:** The eInduction appointment report will be updated to show the percentage of the appointment that is eInduction.

## 1.16 Electronic Verification System (eVS)

### 1.16.1 Weekly Reconciliation Extracts

Mailers will have the option to request a weekly reconciliation extract for the current month to monitor pending adjustments as they accumulate throughout the month. eVS will generate the extract on Wednesdays for mailers who opt to receive the weekly update. The weekly extract will use the "Proposed Adjustment" format as defined in the Publication 205.

## 1.17 Data Distribution / Bundle Scan Data

The *PostalOne!* system will provide enhancements to the Business Customer Gateway interface to facilitate Bundle Data Distribution and Data Visibility for mailers. Mailers will be able to see the bundle scan counts on the *PostalOne!* Data Distribution Dashboard and manually download bundle scan data through the same filters available for tray scan data. They will also be able to set up push Mail.XML profiles through bundle data.

## 1.18 Scan Based Payment (SBP)

### 1.18.1 Parcel Return Service

The Scan Based Payment system will be modified to calculate Parcel Return Service charges based on scan events received from Intelligent Mail Devices, Point of Sale Terminals and Mail Processing Equipment.

### 1.18.2 Transaction Codes for Return Products

The *PostalOne!* system will provide Scan Based Payment customers the ability to reconcile shipment and cash withdrawals. The SBP customers will thereafter be able to identify the unique returns product types of shipments in the Web CAPS and transaction history reports.

## 1.19 MicroStrategy Report

The *PostalOne!* system will include a new MicroStrategy report to track postage statement submission frequency issues for Overnight Periodicals.

## 1.20 Testing Environment for Mailers (TEM)

The TEM and Full Service approval processes for the *PostalOne!* system will be updated to increase efficiency.
