

## Postage Due for a Pending Periodical – June 2012

During the pending application for a Periodicals permit, the mailer pays the postage due for Standard Mail or Bound Printed Matter (BPM). The difference between the postage that is paid and the Periodicals postage is placed in a reserve account that is maintained by the USPS. Upon approval of a pending Periodical application, the amount in the reserve account is refunded to the mailer. Upon denial of a pending Periodical during any portion of the pending period the postage paid while pending prevails and the reserve amount for that portion is not refunded.

The mappings from Periodicals Mail to Standard Mail or BPM are based on providing the closest possible Standard Mail or BPM price. For example, when destination entry is DADC in Periodicals Mail, the mapping is to destination entry DNDC in Standard Mail.

The mailer must provide an accurate Standard Mail or Bound Printed Matter postage statement for payment of postage during the pending period. The postage due for a Mail.dat file during the pending period is calculated by the *PostalOne!* system and may be understated or overstated resulting in an inaccurate reserve account amount. This is due to inaccurate mappings from the Periodicals postage to the Standard Mail or BPM postage that have been in the system since mailing date January 22, 2012 (file submission date January 8).

The following corrected mapping files for the June 2012 postage statements are presented so that the mailer community can produce accurate Standard Mail or (Package Services) Bound Printed Matter postage statements during the pending period. Mailers can then anticipate the postage corrections that may occur for a denied pending Periodical.
