3. Modification of the Rule regarding Use of the Hint Byte for New Addresses that do not DPV<sup>®</sup> Confirm.

**Problem:** Records will not DPV confirm because the Software Developer Guide (SDG) instructs the hint bytes to be placed at the end of the primary number if an entry is not found in the left-right table.

**Solution:** The SDG has been updated to place the hint byte in the secondary number field if an entry is not found in the left-right table.
