Subj: DISESTABLISHMENT OF NAVAL LEGAL SERVICE OFFICE BRANCH OFFICES NEWPORT, RI; WHIDBEY ISLAND, WA; EVERETT, WA; LEMOORE, CA; EARLE, NJ; MEMPHIS, TN; BRUNSWICK, ME; CORPUS CHRISTI, TX; NEW ORLEANS, LA; CHARLESTON, SC; KINGS BAY, GA; GUANTANAMO BAY, CUBA; AND SIGONELLA, ITALY

1. Purpose. To approve disestablishment of subject shore activity branch offices per reference (a).
2. Background. Naval Legal Service Offices (NLSOs) are being realigned to form new litigation-focused commands called Defense Service Offices, which will handle all military justice defense functions. Legal assistance functions of those offices and branch offices will transfer to Region Legal Service Offices (RLSOs). If a RLSO office or branch already exists, the NLSOs branches are being closed. Additional NLSO branch offices are being closed as a remnant of the Base Realignment and Closure process. Branch offices are the legal equivalent of a detachment.

on 1 October 2012, as appropriate, unless otherwise directed via
official correspondence. Correspondence concerning the PLA

Joint Expeditionary Base, Virginia Beach, VA 23459-5000 or by

calling (757) 322-1149/1150. NAVNETWARCOM will coordinate removal of the PLAs in the Navy Regional Enterprise Message System (NREMS) with applicable Navy Computer and Telecommunications Area Master Station.

c. Director, Navy Staff, Organization and Management Branch (DNS-33), will revise reference (b).

5. Cancellation Contingency. This notice will remain in effect for 1 year or until superseded, whichever occurs first. The organization action will remain effective until changed by Director, Navy Staff.
