### b. Revised Mission

To provide advice and representation at courts-martial and administrative proceedings to all eligible service members who are accused of offenses under the Uniform Code of Military Justice. (Defense Service Office North has the additional responsibility to represent service members in Formal Physical Evaluation Board proceedings.)

# 4. Action

- a. Commander, Naval Legal Service Command will take appropriate action to rename and modify mission of subject shore activities and take appropriate action, consistent with reference (a), to issue a revised Mission, Functions, and Tasks Directive for the shore commands within 90 days of the effective date of this action.
- b. Master Update Authority, Honolulu, HI will revise the PLAs in the Central Directory Component effective 1 October 2012, unless otherwise directed via official correspondence. Correspondence concerning the PLA should be forwarded to NAVNETWARCOM (Network Operations 321), Bldg. 1265, Joint Expeditionary Base Little Creek Ft Story, Virginia Beach, VA 23459-5000 or by calling (757) 322-1149/1150. NAVNETWARCOM will coordinate revision of the PLAs in the Navy Regional Enterprise Message System (NREMS) with applicable Navy Computer and Telecommunications Area Master Station.
- c. Director, Navy Staff, Organization and Management Branch (DNS-33), will revise reference (b).
- 5. <u>Cancellation Contingency</u>. This notice will remain in effect for 1 year or until superseded, whichever occurs first. The organization action will remain effective until changed by Director, Navy Staff.
