- 1. <u>Purpose</u>. To approve UIC modification for subject shore activity per reference (a).
- 2. <u>Background</u>. OPNAV N43 programmed a ship repair information and financial management system upgrade for the Southeast Regional Maintenance Center (SERMC). SERMC will execute a transition from the current Navy Enterprise Maintenance Automated Information System to the Advanced Industrial Management System during first half of FY12.
