Subj: DISESTABLISHMENT OF COMMANDER, SUBMARINE GROUP TRIDENT

1. <u>Purpose</u>. To approve the disestablishment of Commander, Submarine Group (COMSUBGRU) TRIDENT per reference (a).

2. <u>Background</u>. The disestablishment of COMSUBGRU TRIDENT is in concert with Program Objective Memorandum 12 guidance to reduce shore structure, resulting in deletion of manpower resources and end-strength.
