Subj: CONSOLIDATION OF FLEET AIR RECONNAISSANCE SQUADRON ONE (VQ-1) AND DISESTABLISHMENT OF FLEET AIR RECONNAISSANCE SQUADRON TWO (VQ-2)

Ref: (a) OPNAVINST 5400.44A of 13 Oct 2011 (b) OPNAVINST C3501.236 Series (c) OPNAVNOTE 5400 of 1 Oct 2011

1. Purpose. To approve consolidation of VQ-1 and VQ-2 per reference (a).

2. Background. To consolidate VQ-1 and VQ-2 into a single squadron to become VQ-1 at Naval Air Station (NAS) Whidbey Island, WA. This is part of the Navy's Program Objective Memorandum (POM) 12 Efficiency Initiatives and part of the Naval Aviation Master Air Plan (MAP) 11-2. Action will maintain the current number of operational aircrews / aircraft to support mission tasking and allow a reduction in Total Ownership Cost (TOC) thru the consolidation of personnel, administration, maintenance, and training.

3. Organizational Changes.

a. Effective 31 August 2012, the following changes apply to VQ-1 and VQ-2:

## 4. Action

a. Commander, U.S. Pacific Fleet / Commander, Naval Air Force U.S. Pacific Fleet will take appropriate action per reference (a) to direct and coordinate the consolidation of VQ-2 with VQ-1. Ensure VQ-1 is deployable, interoperable, fully trained, properly manned, capably equipped, well maintained, and combat-sustainable to meet the mission requirements listed in reference (b) (Required Operational Capabilities (ROC) and Projected Operational Environment (POE) for Fleet Air Reconnaissance Squadrons). Disestablish VQ-2 at NAS Whidbey Island, WA.

b. This is advance change 13-12 to reference (c).

c. Master Update Authority, Honolulu, HI will delete the PLA in the Central Directory Component effective 31 August 2012 unless otherwise directed via official correspondence.
