Subj: DISESTABLISHMENT OF PERSONNEL SUPPORT DETACHMENTS

NEW ORLEANS, LA AND KEY WEST, FL

- 1.  $\underline{\text{Purpose}}$ . To approve disestablishment of subject shore activity detachments per reference (a).
- 2. <u>Background</u>. The action to disestablish Personnel Support Detachments (PSDs) is part of the Navy Pay and Personnel Support Center (NPPSC) long range plan for footprint reduction and process standardization. The size of the customer base in New Orleans has been reduced through Base Realignment and Closure (BRAC) actions to the point where, per NPPSC policy, a Customer Service Desk (CSD) is the proper support rather than a PSD. The Key West PSD manpower was removed in 2007 and customer support transferred to PSD Jacksonville. With no prospect for restoring the local PSD support, the site is being formally disestablished.
- 3. <u>Organizational Changes</u>. Disestablish subject shore activity detachments effective immediately. The following applies:

## 4. Action

- a. Commander, Navy Installations Command will take appropriate action to disestablish subject shore detachments.
- b. Master Update Authority, Honolulu, HI will delete the PSD PLAs in the Central Directory Component effective immediately unless otherwise directed via official correspondence. Correspondence concerning the PLA should be forwarded to Commander, Naval Network Warfare Command (NAVNETWARCOM) (Network Operations 321), Bldg. 1265, Joint Expeditionary Base Little Creek Fort Story, Virginia Beach, VA 23459-5000 or by calling (757) 322-1149/1150. NAVNETWARCOM will coordinate removal of the PLA in the Defense Messaging Service system with applicable Navy Computer and Telecommunications Area Master Station.
- c. Director, Navy Staff, Organization and Management Branch (DNS-33), will revise reference (b).
- 5. <u>Cancellation Contingency</u>. This notice will remain in effect for 1 year or until superseded, whichever occurs first. The organization action will remain effective until changed by Director, Navy Staff.
