Subj: DISESTABLISHMENT OF COMMANDING OFFICER, MARITIME EXPEDITIONARY SECURITY SQUADRON FOURTEEN

1. <u>Purpose</u>. To approve the disestablishment of Commanding Officer, Maritime Expeditionary Security Squadron (MAREXSECRON) FOURTEEN per reference (a).
