CORIVGRU ONE and TWO will provide administrative support and control, operational planning, movement planning, intelligence dissemination, logistic, financial, high-risk training oversight, and certification for all subordinate units. The DETS will provide centralized planning, control and integration of CRF assets for force protection of strategic shipping and units operating in the inshore/coastal area, anchorages and harbors, waterborne mobility, security, command and control, and combat operations in support of military operations.


5. Action
