Subj: DISESTABLISHMENT OF COMMANDER, RIVERINE GROUP ONE AND CHANGE IN IMMEDIATE SUPERIOR IN COMMAND (ISIC) FOR COMMANDING OFFICER, RIVERINE SQUADRON (RIVRON) TWO

(b) OPNAVNOTE 5400 Ser DNS-33/12U102020 of 1 Mar 2012

- 1. <u>Purpose</u>. To approve the disestablishment of Commander, Riverine Group (COMRIVGRU) ONE and change in ISIC for RIVRON TWO per reference (a).
- 2. <u>Cancellation</u>. OPNAVNOTE 5400 Ser DNS-33/12U102051 of 22 March 2012.
- 3. <u>Background</u>. The disestablishment of COMRIVGRU ONE is due to Program Objective Memorandum (POM) reductions and reorganization of current structure. The ISIC change is a result of the disestablishment of COMRIVGRU ONE. This action supports the new established structure of Coastal Riverine Group TWO associated with the Coastal Riverine Force. All positions will be continued and will be absorbed in the merge with CORIVGRU TWO command.
- 4. Organizational Changes. Effective 1 October 2012, disestablish RIVGRU ONE and change the ISIC for RIVRON TWO. The following applies:
