1. Purpose. To approve PDS for Officer in Charge, USNS WALLY SCHIRRA (T-AKE 8) Military Department (MILDEPT) per reference (a).

2. Background. PDS is in accordance with the FY 12-13 Global Force Management Implementation Guidance.
