1. <u>Purpose</u>. To approve relocating subject shore activity detachment per reference (a).

## 4. Action

a. Chief of Naval Personnel and Commander, Navy Personnel Command will take appropriate action to relocate subject shore activity detachment.

c. Director, Navy Staff, Organization and Management Branch (DNS-33), will revise reference (b).

5. <u>Cancellation Contingency</u>. This notice will remain in effect for 1 year or until superseded, whichever occurs first. The organization action will remain effective until changed by Director, Navy Staff.
