## OPNAV NOTICE 5400

Subj: MODIFICATION OF OFFICER IN CHARGE, AIRBORNE COMMAND AND CONTROL LOGISTICS WING DETACHMENT WEAPONS AND TACTICS UNIT (COMACCLOGWING DET WTU) POINT MUGU CA AND NORFOLK VA

Ref: (a) OPNAVINST 5400.44A of 13 Oct 2011  
(b) OPNAVNOTE 5400 of 1 Mar 2012

1. Purpose. To approve modification of COMACCLOGWING DET WTU POINT MUGU and NORFOLK per reference (a).
2. Background. Commander, Naval Air Force, U.S. Pacific Fleet and Commander Airborne Command and Control Logistics Wing will be upgrading the VAW and VRC aviation training syllabus. Based on the Master Aviation Plan (11-02), the VAW community will be transitioning to the Advanced Hawkeye Aircraft with advanced radar, upgraded battle management C2, and modern network links starting in FY13. This is a major upgrade in warfare capability that will be integrated into the Fleet. In concert, the Type Wing will revise the name, mission, and curriculum of its Weapons and Tactics Unit to a Weapons School to support VAW Type-Model-Series transition from E-2C to E-2D and to support VRC community with a C-2A operational logistics syllabus. The primary schoolhouse will be under the command of a Commanding Officer and located in Norfolk where the Fleet Replacement Squadron resides. The Weapons School will complement the Fleet Replacement Squadron basic training and readiness syllabus with integrated and advanced warfare tactics techniques and procedures for operational squadrons. The schoolhouse in Point Mugu will act as an extension of the school house in Norfolk to support operational squadrons in the Pacific and it will be a detachment of the Type Wing.
3. Organizational Changes.

a. Effective 1 June 2012, change the name and modify the mission of COMACCLOGWING DET WTU POINT MUGU and NORFOLK to Airborne Command and Control Logistics Weapons School Pacific (ACCLOGWPNSCOLPAC) and Airborne Command and Control Logistics Weapons School Atlantic (ACCLOGWPNSCOLANT). Provide schoolhouse leadership and management for VAW / VRC squadron training and education; Conduct standardized Fleet Response Plan (FRP) syllabus training; Develop CONOPS in support of Warfare Commanders; Evaluate squadron ground and flight syllabus with respect to combat and weapon systems effectiveness; Coordinate the development and execution of tactics, techniques, and procedures in all ROC/POE mission areas to improve and maintain high levels of combat readiness in support of naval operations.

#### 4. Action

a. Commander, U.S. Pacific Fleet / Commander, Naval Air Force, U.S. Pacific Fleet / Commander Airborne Command and Control Logistics Wing will take appropriate action per reference (a) to direct and coordinate the modification of Airborne Command and Control Logistics Wing Detachment Weapons and Tactics Unit Point Mugu and Norfolk into Airborne Command and Control Logistics Weapons School Pacific and Airborne Command and Control Logistics Weapons School Atlantic. Ensure the Weapons School is properly manned, trained, and equipped as a supporting command to the VAW and VRC squadrons. Issue a revised Mission, Functions, and Tasks directive such that the Weapons School supports the applicable mission requirements listed in OPNAVINST C3501.270 / OPNAVINST C3501.249 series (Required Operational Capabilities (ROC) and Projected Operational Environment (POE) for VAW and VRC squadrons.

b. This is advance change 29-12 to reference (c).

c. Master Update Authority, Honolulu, HI will revise the Plain Language Address (PLA) in the Central Directory Component effective 1 June 2012 unless otherwise directed via official correspondence. Correspondence concerning the PLA should be forwarded to Commander, Naval Network Warfare Command (COMNAVNETWARCOM) (Network Operations 321), 2555 Amphibious DR, BLDG 1265, Joint Expeditionary Base, Virginia Beach, VA 23459-5000. Revised command should be activated on Navy Regional Enterprise Message System (NREMS). d. Director, Navy Staff Organization and Management Branch (DNS-33) will revise reference (c).
